1 [Affirming the Exemption Determination - 134-136 Ord Street]
2

3 **Motion affirming the determination by the Planning Department that the project located**
4 **at 134-136 Ord Street is exempt from environmental review.**
5

6 WHEREAS, On July 8, 2010, following a noticed public hearing, the Planning
7 Commission determined not to take discretionary review and approve the project as proposed
8 (Discretionary Review Case No. 2007.112400) for the construction of a new single-family
9 home at the front of the subject lot, which new building would be located in front of an existing
10 building on the lot (the "Project"). In so doing, the Commission affirmed the Department's
11 decision that the Project was exempt from environmental review under the California
12 Environmental Quality Act ("CEQA"), the CEQA Guidelines, and San Francisco Administrative
13 Code Chapter 31 under categorical exemption Class 1 (the "exemption determination"). By
14 letter to the Clerk of the Board, Stephen M. Williams, on behalf of the Corbett Heights
15 Neighbors, ("Appellant"), received by the Clerk's Office on or around December 9, 2010,
16 appealed the exemption determination; and

17 WHEREAS, On January 11, 2011, this Board held a duly noticed public hearing to
18 consider the appeal of the exemption determination filed by Appellant, and following the public
19 hearing affirmed the exemption determination; and

20 WHEREAS, In reviewing the appeal of the exemption determination, this Board
21 reviewed and considered the exemption determination, the appeal letters, the responses to
22 concerns document that the Planning Department prepared, the other written records before
23 the Board of Supervisors and all of the public testimony made in support of and opposed to
24 the exemption determination appeal. Following the conclusion of the public hearing, the
25 Board of Supervisors affirmed the exemption determination for the Project based on the

1 written record before the Board of Supervisors as well as all of the testimony at the public
2 hearing in support of and opposed to the appeal. The written record and oral testimony in
3 support of and opposed to the appeal and deliberation of the oral and written testimony at the
4 public hearing before the Board of Supervisors by all parties and the public in support of and
5 opposed to the appeal of the exemption determination is in the Clerk of the Board of
6 Supervisors File No. 101547 and is incorporated in this motion as though set forth in its
7 entirety; now therefore be it

8 MOVED, That the Board of Supervisors of the City and County of San Francisco
9 hereby adopts as its own and incorporates by reference in this motion, as though fully set
10 forth, the exemption determination; and be it

11 FURTHER MOVED, That the Board of Supervisors finds that based on the whole
12 record before it there are no substantial Project changes; no substantial changes in Project
13 circumstances, and no new information of substantial importance that would change the
14 conclusions set forth in the exemption determination by the Planning Department that the
15 proposed Project is exempt from environmental review; and be it

16 FURTHER MOVED, That after carefully considering the appeal of the exemption
17 determination, including the written information submitted to the Board of Supervisors and the
18 public testimony presented to the Board of Supervisors at the hearing on the exemption
19 determination, this Board concludes that the Project qualifies for a exemption determination
20 under CEQA Guidelines Sections 15301 (Class 1) and 15303 (Class 3).
