

1 [Explore the effect of highly active antiretroviral therapy on the incidence of cancer in persons
2 with AIDS.]

3 **Resolution authorizing the San Francisco Department of Public Health, AIDS Office**
4 **(SFPDH, AIDS) to accept and expend retroactively a grant in the amount of \$85,335**
5 **from the National Institute of Allergy and Infectious Diseases (NIAID), to explore the**
6 **effect of highly active antiretroviral therapy (HAART) on cancer incidence in persons**
7 **with AIDS and to enter into an agreement for the use of these funds; for the period of**
8 **May 1, 2003, to October 31, 2004.**

10 WHEREAS, SFPDH, AIDS has applied for and been awarded a grant from NIAID in the
11 amount of \$85,335 to explore the effect of highly active antiretroviral therapy on cancer
12 incidence in persons with AIDS; and,

13 WHEREAS, As a condition of receiving the grant funds, NIAID requires the City to
14 enter into an agreement (the "Agreement"), a copy of which is on file with the Clerk of the
15 Board of Supervisors in File No. _____, which is hereby declared to be a part of
16 this resolution as if set forth fully herein; and,

17 WHEREAS, The grant budget includes provision for indirect costs of \$10,334; and,

18 WHEREAS, This Resolution requires expedited review by the Board of Supervisors
19 because we did not receive the grant award notice until April 21, 2003; and,

20 WHEREAS, Resolutions authorizing the acceptance and expenditure of grant funds
21 may be placed automatically on the consent agendas in committee, as they are usually
22 considered to be routine items, and this resolution authorizes the acceptance and expenditure
23 of grant funding; now, therefore, be it

24 **RESOLVED, That SFPDH, AIDS is hereby authorized to accept and expend**
25 **retroactively a grant in the amount of \$85,335 from NIAID; and, be it**

1 FURTHER RESOLVED, That SFDPH, AIDS is hereby authorized to accept and
2 expend the grant funds in accordance with the requirements set forth in the Agreement
3 pursuant to San Francisco Administrative Code section 10-170-1; and, be it

4 FURTHER RESOLVED, That the Director of Health is authorized to enter into the
5 agreement on behalf of the City; and, be it

6 FURTHER RESOLVED, That the Controller is directed to designate the positions
7 funded under this agreement as "G" or grant-funded positions which would terminate when
8 the agreement expires.
