5 **Duong, Chris Oldag, terms ending July 1, 2009, to the Shelter Monitoring Committee,**
6 **residency requirement waived.**

8 **MOVED,** That the Board of Supervisors of the City and County of San Francisco does
9 hereby appoint the hereinafter designated persons to serve as members of the San Francisco
10 Fair Lending Working Group, pursuant to the provisions of Resolution No. 1-08, for the terms
11 specified:

12 Jan Lynn Owgn, new appointment, seat 1, must be a representative of a financial
13 institution/lending agency, for a term ending on July 1, 2009 (residency requirement waived).

14 Leon Huntting, new appointment, seat 2, must be a representative of the mortgage
15 broker industry, for a term ending on July 1, 2009 (residency requirement waived).

16 Heidi Mueller, new appointment, seat 3, must be a representative of the real estate
17 profession, for a term ending on July 1, 2009.

18 Maeve Elise Brown, new appointment, seat 4, must be a representative of a
19 community-based organization focusing on foreclosure counseling and legal assistance, for a
20 term ending on July 1, 2009 (residency requirement waived).

21 Kevin Stein, new appointment, seat 5, must be a representative of an advocacy
22 organization, for a term ending on July 1, 2009.

23 Ed Donaldson, new appointment, seat 6, must be a representative of any of the
24 following categories: a financial institution/lending agency, the mortgage broker industry, the
25

1 real estate profession, a community-based organization focusing on foreclosure
2 counseling and legal assistance, or other advocacy organization, for a term ending on July 1,
3 2009.

4 Amanda Feinstein, new appointment, seat 7, must be a representative of any of the
5 following categories: a financial institution/lending agency, the mortgage broker industry, the
6 real estate profession, a community-based organization focusing on foreclosure counseling
7 and legal assistance, or other advocacy organization, for a term ending on July 1, 2009
8 (residency requirement waived).

9 Jon Ballesteros, new appointment, seat 8, must be a representative of any of the
10 following categories: a financial institution/lending agency, the mortgage broker industry, the
11 real estate profession, a community-based organization focusing on foreclosure counseling
12 and legal assistance, or other advocacy organization, for a term ending on July 1, 2009.

13 Grace Mejia, new appointment, seat 9, must be a representative of any of the following
14 categories: a financial institution/lending agency, the mortgage broker industry, the real
15 estate profession, a community-based organization focusing on foreclosure counseling and
16 legal assistance, or other advocacy organization, for a term ending on July 1, 2009 (residency
17 requirement waived).

18 Jane Duong, new appointment, seat 10, must be a representative of any of the
19 following categories: a financial institution/lending agency, the mortgage broker industry, the
20 real estate profession, a community-based organization focusing on foreclosure counseling
21 and legal assistance, or other advocacy organization, for a term ending on July 1, 2009.

22 Chris Oldag, new appointment, seat 11, must be a representative of any of the
23 following categories: a financial institution/lending agency, the mortgage broker industry, the
24 real estate profession, a community-based organization focusing on foreclosure counseling
25

1 and legal assistance, or other advocacy organization, for a term ending on July 1, 2009
2 (residency requirement waived); and, be it

4 FURTHER MOVED, That the Board of Supervisors makes the following findings:

- 5 1. The membership of the San Francisco Fair Lending Group has a goal to be representative
6 of the diversity of the City and County of San Francisco.
- 7 2. Applicants Jan Lynn Owgn, Leon Huntting, Maeve Elise Brown, Amanda Feinstein, Grace
8 Mejia and Chris Oldag, new appointees, who are not residents of San Francisco, are
9 persons with experience that uniquely qualifies them to serve on the San Francisco Fair
10 Lending Group.
- 11 3. The San Francisco Fair Lending Group has attempted to fill these positions, for which
12 these applicants were nominated, with individuals who are City residents and who have
13 the specific experience, skills, and qualifications, but has been unable to do so at this time.
14 The Rules Committee has certified that the applicants are qualified to serve on the San
15 Francisco Fair Lending Group.
- 16 4. After exercising due diligence, the Board of Supervisors concludes that there are no other
17 possible representatives, who are residents of San Francisco and who have the specific
18 experience, skills, or qualifications possessed by these applicants, and who are willing to
19 serve on the San Francisco Fair Lending Group at this time; and, be it

20 FURTHER MOVED, That the Board of Supervisors waives the residency requirement
21 for Jan Lynn Owgn, Leon Huntting, Maeve Elise Brown, Amanda Feinstein, Grace Mejia and
22 Chris Oldag, as allowed in cases where no qualified City residents, willing to serve, can be
23 found, pursuant to Section 4.101 of the City Charter that requires person(s) appointed to
24 boards, commissions, and advisory bodies established by legislative act of the Board of
25 Supervisors to be resident(s) of the City and County of San Francisco.


