12 be a part of this motion as if set forth fully herein; now, therefore, be it

13 **MOVED, That the Board approves the Board of Supervisors revised Records Retention**
14 **Schedule and Records Retention and Destruction Policy retroactive to July 1, 2001 and**
15 **directs the Clerk of the Board of Supervisors to carry out the implementation of the schedule;**
16 **and, be it**

17 **FURTHER MOVED, That the Board authorizes the Clerk of the Board of Supervisors to**
18 **adjust this retention schedule on finding that it would provide better service to the Board and**
19 **the public if something were retained in a different location or for a longer period of time; and,**
20 **be it**

21 **FURTHER MOVED, That the Clerk of the Board of Supervisors shall obtain approval of**
22 **the Board prior to adding record titles to the retention schedule or reducing the retention**
23 **period for any listed record.**
