Mark Gonzalez (Seat 5)

San Francisco, CA 94123

Mark Gonzalez was born and raised in San Francisco and retired from the San Francisco Fire Department in 2019. Gonzalez also served as Deputy Chief of Operations (2nd in command) for over seven years. His responsibilities included working in the Emergency Medical Services (EMS) Division, fire prevention and investigation, the Airport Division, fire suppression and with fire stations and personnel. Gonzalez also worked on discipline investigations including Skelly Hearings as well as developed policy and represented the Department during Commissions hearings.

Gonzalez spent most of his career in the Fire Department at some of the City's most busy fire stations learning his craft; as a Firefighter, Lieutenant and Captain at Station 5 in the Fillmore District.
