8 Be it ordained by the People of the City and County of San Francisco:

9 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
10 authorizes the City Attorney to settle the action entitled Katy Sullivan v. City and County of
11 San Francisco, et al., San Francisco Superior Court, Case No. CGC-21-593827 by the
12 payment of \$207,500. The lawsuit involves an employment dispute.

13 Section 2. The above-named action was filed in San Francisco Superior Court on
