8 MOVED, That the Board of Supervisors of the City and County of San Francisco does  
9 hereby appoint the hereinafter designated person(s) to serve as member of the Committee on  
10 City Workforce Alignment, pursuant to the provisions of Administrative Code, Chapter 30,  
11 Article I, Section 30.5, for the term(s) specified:

12 Ruth Barajas (residency requirement waived) seat 15, inaugural appointment, shall be  
13 a member of the public who, at the time of their appointments are employed by Nonprofit  
14 Corporations that provide Workforce Development Services to low-income San Francisco  
15 residents and those with barriers to employment, for the unexpired portion of a three-year  
16 term ending November 6, 2025;

17 Tiffany Jackson (residency requirement waived), seat 16, inaugural appointment, shall  
18 be a member of the public who, at the time of their appointments are employed by Nonprofit  
19 Corporations that provide Workforce Development Services to low-income San Francisco  
20 residents and those with barriers to employment, for the unexpired portion of a three-year  
21 term ending November 6, 2025;

22 Bartolomy Pantoja, seat 17, inaugural appointment, shall be a member of the public  
23 who is affiliated with labor organization and has leadership experience and demonstrated  
24 expertise in workforce development systems, policies, and programs, including registered  
25

1 apprenticeship programs, for the unexpired portion of a three-year term ending November 6,  
2 2025; and, be it

3 FURTHER MOVED, That the Board of Supervisors makes the following findings:

- 4 1. The membership of the Committee on City Workforce Alignment has a goal to be  
5 representative of the diversity of the City and County of San Francisco.
- 6 2. Applicants Ruth Barajas and Tiffany Jackson, who are not residents of San Francisco,  
7 are persons with experience that uniquely qualifies them to serve on the Committee on  
8 City Workforce Alignment.
- 9 3. The Committee on City Workforce Alignment has attempted to fill the positions, for  
10 which Ruth Barajas and Tiffany Jackson were nominated, with individuals who are City  
11 residents and who have the specific experience, skills, and qualifications, but has been  
12 unable to do so at this time. The Rules Committee has certified that Ruth Barajas and  
13 Tiffany Jackson, are qualified to serve on the Committee on City Workforce Alignment.
- 14 4. After exercising due diligence, the Board of Supervisors concludes that there are no  
15 other possible representatives who are residents of San Francisco, who have the  
16 specific experience, skills, or qualifications possessed by these applicants, and who  
17 are willing to serve on the Committee on City Workforce Alignment at this time; and, be  
18 it

19 FURTHER MOVED, That the Board of Supervisors waives the residency requirement  
20 for Ruth Barajas and Tiffany Jackson, as is allowed in cases where no qualified City residents  
21 who are willing to serve can be found, pursuant to Charter, Section 4.101(a)(2), that otherwise  
22 requires person(s) appointed to boards, commissions, and advisory bodies established by  
23 legislative act of the Board of Supervisors to be resident(s) of the City and County of San  
24 Francisco.
