18 representative of public safety officers on Treasure Island; representative of Treasure Island
19 Homeless Development Initiative; representative of Job Corps; representative of Treasure
20 Island Elementary School; representative of film production industry; and representative of
21 residential tenants on Treasure Island, for a term indefinite.

22 Scott Vedro, seat 11, succeeding Elizabeth Strahlstrom, resigned, must meet any of

24 planning and alternative and mass transit; historic conservation and preservation; engineering
25 and construction; real estate development and financing; economic development and job

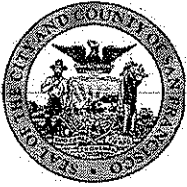
