2 Conservation Fund - Youth Stewardship Program - \$200,000]

3 **Resolution authorizing the Recreation and Park Department to accept and expend a**  
4 **grant of \$200,000 from the California Department of Parks and Recreation's Habitat**  
5 **Conservation Fund to support the Youth Stewardship Program.**

7 WHEREAS, The California Department of Parks and Recreation (CDPR) administers  
8 the Habitat Conservation Fund (HCF) Program, which provides funding for nature  
9 interpretation programs to bring urban residents into park and wildlife areas, protection of  
10 various plant and animal species, and acquisition and development of wildlife corridors and  
11 trails; and

12 WHEREAS, The Youth Stewardship Program (YSP) which engages students, K-12<sup>th</sup>  
13 grade, in environmental education and service learning projects throughout San Francisco's  
14 parks and open spaces; and

15 WHEREAS, CDPR has awarded RPD an HCF grant in the amount of \$200,000 to  
16 support the YSP from October 1, 2015, through June 30, 2019; and

17 WHEREAS, The terms and conditions of the Grant are detailed in an agreement on file  
18 at the Clerk of the Board of Supervisors in File No. 140932 ("Grant Agreement"), which is  
19 hereby declared to be part of this resolution as set forth fully herein; and

20 WHEREAS, The Grant does not require an Annual Salary Ordinance (ASO)  
21 Amendment; and


22 WHEREAS, The Grant prohibits the use of grant funds for indirect costs; now,  
23 therefore, be it

1 RESOLVED, That the Board of Supervisors authorizes the Recreation and Park  
2 Department General Manager to accept and expend the grant of \$200,000 from the California  
3 Department of Parks and Recreation's Habitat Conservation Fund to support the Youth  
4 Stewardship Program; and be it

5 FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of  
6 indirect costs in the grant budget; and be it


7 FURTHER RESOLVED, That the Board of Supervisors authorizes the General  
8 Manager, or his or her designee, to conduct all negotiations, execute and submit all  
9 documents, including, but not limited to applications, agreements, amendments, payment




