5 **amount of \$74,500 from the California Department of Toxic Substances Control to**  
6 **coordinate the Green Business tracking and measurement tool and amending**  
7 **Ordinance No. 183-09 to reflect the addition of one (1) grant funded position at the**  
8 **Department of the Environment.**

13 Be it ordained by the People of the City and County of San Francisco:

14 **Section 1. Findings**

15 The California Department of Toxic Substances Control has partnered with local  
16 governments, the California Green Business Network and the San Francisco Green Business  
17 Program to implement a Green Business tracking and measurement tool.

18 The tool allows local Green Business programs to manage environmental data, track  
19 the business applications and certifications, and measure the results.

20 This Green Business tracking and measurement tool documents and quantifies the  
21 environmental and fiscal benefits of individual Green Businesses, as well the cumulative  
22 environmental and fiscal benefits of Green Business programs.

23 Information generated by this Green Business tracking and measurement tool supports  
24 local Green Business programs to market their benefits and maximize local program funding  
25 resources.

1 The California Department of Toxic Substances Control has secured \$74,500 of  
2 funding for the San Francisco Green Business Program to continue development of this tool.

3 The California Department of Toxic Substances Control is providing these funds to the  
4 San Francisco Department of the Environment to lead the California Green Business Network  
5 in further development of the Green Business tracking and measurement tool.

6 The City and County of San Francisco has committed to an ongoing, coordinated effort  
7 to demonstrate the positive effects of Green Business programs on the community and  
8 calculate the benefits to participating businesses.

9 Continued development of a measurement tool supports the vitality and benefits of San  
10 Francisco Green Business Program and ensures that San Francisco is recognized a leader in  
11 creating programs and services with measurable environmental impacts.

12  
13 **Section 2. Authorization to Expend Funds.**

14 The Board of Supervisors hereby authorizes the Department of the Environment to  
15 expend \$74,500 in funds from the California Department of Toxic Substances Control for  
16 operation of the Green Business tracking and measurement tool.

17 The Department of the Environment is further authorized to furnish whatever additional  
18 information or assurances the funding agency may request in connection with this grant, and  
19 to execute any and all agreements necessary to carry out the purpose of the grant.

20 The grant budget includes provision for indirect cost of \$6,773.

21 The term of the California Department of Toxic Substances Control grant is from May  
22 01, 2010 to April 30, 2011.




