3 **Resolution Authorizing and Directing the Sale of Not to Exceed \$265,185,000 Aggregate**  
4 **Principal Amount of City and County of San Francisco General Obligation Bonds,**  
5 **Series 2012D; Prescribing the Form and Terms of Said Bonds; Authorizing the**  
6 **Execution, Authentication, and Registration of Said Bonds; Providing for the**  
7 **Appointment of Depositories and Other Agents for Said Bonds; Providing for the**  
8 **Establishment of Accounts Related to Said Bonds; Providing for the Manner of Sale of**  
9 **Said Bonds by Competitive Sale; Approving the Forms of Official Notice of Sale and**  
10 **Notice of Intention to Sell Bonds; Directing the Publication of the Notice of Intention to**  
11 **Sell Bonds; Approving the Form of the Preliminary Official Statement and the Form and**  
12 **Execution of the Official Statement Relating to the Sale of Said Bonds; Approving the**  
13 **Form of the Continuing Disclosure Certificate; Authorizing and Approving**  
14 **Modifications to Documents; Declaring the City's Intent to Reimburse Certain**  
15 **Expenditures; Ratifying Certain Actions Previously Taken; and Granting General**  
16 **Authority to City Officials to Take Necessary Actions in Connection with the**  
17 **Authorization, Issuance, Sale, and Delivery of Said Bonds.**

18  
19 WHEREAS, In accordance with the Bond Election (as defined below) and by  
20 Resolution No. 528-08 (the "Authorizing Resolution"), adopted by the Board of Supervisors  
21 (the "Board") of the City and County of San Francisco (the "City") on December 16, 2008, and  
22 signed by the Mayor of the City (the "Mayor") on December 19, 2008, the City authorized the  
23 issuance of its General Obligation Bonds (San Francisco General Hospital Improvement  
24 Bonds, 2008) (the "Bonds") in an aggregate principal amount not to exceed \$887,400,000;  
25 and,

1           WHEREAS, By Resolution No. 527-08, adopted by the Board on December 16, 2008,  
2 and signed by the Mayor on December 19, 2008, the City authorized the first series of Bonds  
3 in an aggregate principal amount not to exceed \$136,000,000; and,

4           WHEREAS, Pursuant to Resolution 527-08, on March 18, 2009, the City issued and  
5 delivered \$131,650,000 of its General Obligation Bonds (San Francisco General Hospital  
6 Improvement Bonds, 2008), Series 2009A; and,

7           WHEREAS, By Resolution 46-10, adopted by the Board on February 9, 2010, and  
8 signed by the Mayor on February 18, 2010, the City authorized the second series of Bonds in  
9 an aggregate principal amount not to exceed \$305,000,000; and,

10           WHEREAS, Pursuant to Resolution 46-10, on March 24, 2010, the City issued and  
11 delivered \$120,890,000 of its General Obligation Bonds (San Francisco General Hospital  
12 Improvement Bonds, 2008), Series 2010A, and \$173,805,000 of its General Obligation Bonds  
13 (San Francisco General Hospital Improvement Bonds, 2008), Series 2010C (Federally  
14 Taxable Build America Bonds); and,

15           WHEREAS, The City has issued and sold, to the date hereof, a total of \$426,345,000  
16 in aggregate principal amount of the Bonds; and there remains \$461,055,000 of authorized  
17 and unissued Bonds; and,

18           WHEREAS, It is necessary and desirable to issue an additional aggregate principal  
19 amount of the Bonds not to exceed of \$265,185,000 (the "Series 2012D Bonds"), to finance a  
20 portion of the costs of the Project (as defined in the Authorizing Resolution) and to pay costs  
21 of issuance therefor; and,

22           WHEREAS, The Series 2012D Bonds are being issued pursuant to the Authorizing  
23 Resolution and Title 5, Division 2, Part 1, Chapter 3, Article 4.5 of the California Government  
24 Code, the Charter of the City (the "Charter"), and a proposition approved by not less than a  
25 two-thirds vote of the qualified electors of the City voting at a special election held in the City

1 on November 4, 2008 (the "Bond Election") pursuant to Ordinance 128-08 adopted by the  
2 Board on July 22, 2008, and signed by the Mayor on July 24, 2008 (the "Bond Election  
3 Ordinance"); and,

4 WHEREAS, The City has paid and expects to pay certain expenditures in connection  
5 with the Project to be financed by the Series 2012D Bonds prior to the issuance and sale of  
6 the Series 2012D Bonds, and the City intends to reimburse itself for such prior expenditures  
7 from the proceeds of the Series 2012D Bonds; and,

8 WHEREAS, Section 1.150-2 of the Treasury Regulations promulgated under the  
9 Internal Revenue Code of 1986 (the "Reimbursement Regulations") requires the City to  
10 declare its reasonable official intent to reimburse prior expenditures with the proceeds of a  
11 subsequent borrowing; and,

12 WHEREAS, The Reimbursement Regulations require that any reimbursement  
13 allocation of proceeds of the Series 2012D Bonds to be made with respect to expenditures  
14 incurred prior to the issuance of the Series 2012D Bonds will occur not later than eighteen  
15 (18) months after the later of (i) the date on which the expenditure is paid or (ii) the date on  
16 which the facilities are placed in service, but in no event later than three (3) years after the  
17 expenditure is paid;

18 NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the City and  
19 County of San Francisco, as follows:

20 Section 1. Recitals. All of the recitals in this Resolution are true and correct.

21 Section 2. Conditions Precedent. All conditions, things and acts required by law to  
22 exist, to happen and to be performed precedent to and in connection with the issuance of the  
23 Series 2012D Bonds exist, have happened and have been performed in due time, form and  
24 manner in accordance with applicable law, and the City is now authorized pursuant to the  
25

1 Bond Election, the Charter and applicable law to incur indebtedness in the manner and form  
2 provided in this Resolution.

3 Section 3. Documents. The documents presented to the Board and on file with the  
4 Clerk of the Board of Supervisors or his or her designee (the "Clerk of the Board of  
5 Supervisors") are contained in File No. 120532.

6 Section 4. Issuance and Sale of Series 2012D Bonds; Determination of Certain Terms;  
7 Designation. The Board authorizes the issuance and sale of not to exceed \$265,185,000 in  
8 aggregate principal amount of Bonds to be designated as "City and County of San Francisco  
9 General Obligation Bonds, Series 2012D," for the purposes set forth in the Bond Election  
10 Ordinance and Proposition A approved by the voters at the Bond Election.

11 The Director of Public Finance of the City or his or her designee (the "Director of Public  
12 Finance") is authorized to determine, for the Series 2012D Bonds, the sale date, the interest  
13 rates, the definitive principal amount, the maturity dates and the redemption dates, if any, and  
14 the terms of any optional or mandatory redemption, subject to the other specific provisions of  
15 this Resolution, including the following terms and conditions: (i) the Series 2012D Bonds shall  
16 not have a true interest cost in excess of 12% (as such term is defined in the Official Notice of  
17 Sale (as defined in Section 17)); and (ii) the Series 2012D Bonds shall not have a final  
18 maturity date after June 15, 2040. The Director of Public Finance is further authorized to give  
19 the Series 2012D Bonds such additional or other series designation, or to modify such series  
20 designation, as may be necessary or appropriate to distinguish the Series 2012D Bonds from  
21 every other series of Bonds and from other bonds issued by the City.

22 Section 5. Execution, Authentication and Registration of the Series 2012D Bonds.  
23 Each of the Series 2012D Bonds shall be in fully registered form without coupons in  
24 denominations of \$5,000 or any integral multiple of that amount. The officers of the City are  
25 directed to cause the Series 2012D Bonds to be prepared in sufficient quantity for delivery to

1 or for the account of their purchaser and the Controller is directed to cause the blanks in the  
2 Series 2012D Bonds to be completed in accordance with the Authorizing Resolution and the  
3 Bond Award (as defined in Section 13), to procure their execution by the proper officers of the  
4 City (including by facsimile signature if necessary or convenient) and authentication as  
5 provided in this Section, and to deliver the Series 2012D Bonds when so executed and  
6 authenticated to said purchaser in exchange for their purchase price, all in accordance with  
7 the Authorizing Resolution.

8 The Series 2012D Bonds and the certificate of authentication and registration, to be  
9 manually executed by the Treasurer of the City or his or her designee (the "City Treasurer"),  
10 and the form of assignment to appear on the Series 2012D Bonds shall be substantially in the  
11 form attached as Exhibit A (a copy of which is on file with the Clerk of the Board of  
12 Supervisors and which is declared to be a part of this Resolution as if fully set forth in this  
13 Resolution), with necessary or appropriate variations, omissions and insertions as permitted  
14 or required by this Resolution.

15 Only Series 2012D Bonds bearing a certificate of authentication and registration  
16 executed by the City Treasurer shall be valid or obligatory for any purpose or entitled to the  
17 benefits of the Authorizing Resolution and this Resolution, and such certificate of the City  
18 Treasurer, executed as provided in this Resolution, shall be conclusive evidence that the  
19 Series 2012D Bonds so authenticated have been duly authenticated and delivered under, and  
20 are entitled to the benefits of, the Authorizing Resolution and this Resolution.

21 The Controller shall assign a distinctive letter, or number, or letter and number to each  
22 Series 2012D Bond authenticated and registered by the City Treasurer and shall maintain a  
23 record thereof which shall be available for inspection.

24 Section 6. Registration Books. The City Treasurer shall keep or cause to be kept, at  
25 the office of the City Treasurer or at the designated office of any registrar appointed by the

1 City Treasurer, separate and sufficient books for the registration and transfer of Series 2012D  
2 Bonds, which books shall at all times be open to inspection, and upon presentation for such  
3 purpose, the City Treasurer shall, under such reasonable regulations as he or she may  
4 prescribe, register or transfer or cause to be registered or transferred, on said books, Series  
5 2012D Bonds as provided in this Resolution. The City and the City Treasurer may treat the  
6 registered owner of each Series 2012D Bond as its absolute owner for all purposes, and the  
7 City and the City Treasurer shall not be affected by any notice to the contrary.

8 Section 7. Transfer or Exchange of Series 2012D Bonds. Any Series 2012D Bond  
9 may, in accordance with its terms, be transferred upon the books required to be kept pursuant  
10 to the provisions of Section 6, by the person in whose name it is registered, in person or by  
11 the duly authorized attorney of such person in writing, upon surrender of such Series 2012D  
12 Bond for cancellation, accompanied by delivery of a duly executed written instrument of  
13 transfer in a form approved by the City Treasurer.

14 Any Series 2012D Bond may be exchanged at the office of the City Treasurer for a like  
15 aggregate principal amount of other authorized denominations of the same interest rate and  
16 maturity.

17 Whenever any Series 2012D Bond shall be surrendered for transfer or exchange, the  
18 designated City officials shall execute (as provided in Section 5) and the City Treasurer shall  
19 authenticate and deliver a new Series 2012D Bond of the same interest rate and maturity in a  
20 like aggregate principal amount. The City Treasurer shall require the payment by any bond  
21 owner requesting any such transfer of any tax or other governmental charge required to be  
22 paid with respect to such transfer or exchange.

23 No transfer or exchange of Series of 2012A Bonds shall be required to be made by the  
24 City Treasurer during the period from the Record Date (as defined in Section 8(b)) next  
25

1 preceding each interest payment date to such interest payment date or after a notice of  
2 redemption shall have been mailed with respect to such Series 2012D Bonds.

3 Section 8. Terms of the Series 2012D Bonds; General Redemption Provisions.

4 (a) Date of the Series 2012D Bonds. The Series 2012D Bonds shall be dated the  
5 date of their delivery or such other date (the "Dated Date") as is specified in the Bond Award.

6 (b) Payment of the Series 2012D Bonds. The principal of the Series 2012D Bonds  
7 shall be payable in lawful money of the United States of America to their owners, upon  
8 surrender at maturity or earlier redemption at the office of the City Treasurer. The interest on  
9 the Series 2012D Bonds shall be payable in like lawful money to the person whose name  
10 appears on the bond registration books of the City Treasurer as the owner as of the close of  
11 business on the last day of the month immediately preceding an interest payment date (the  
12 "Record Date"), whether or not such day is a Business Day (as defined below).

13 Except as may be otherwise provided in connection with any book-entry only system  
14 applicable to the Series 2012D Bonds, payment of the interest on any Series 2012D Bond  
15 shall be made by check mailed on the interest payment date to such owner at such owner's  
16 address as it appears on the registration books as of the Record Date; provided, that if any  
17 interest payment date occurs on a day that banks in California or New York are closed for  
18 business or the New York Stock Exchange is closed for business, then such payment shall be  
19 made on the next succeeding day that banks in both California and New York are open for  
20 business and the New York Stock Exchange is open for business (each, a "Business Day");  
21 and provided, further, that the registered owner of an aggregate principal amount of at least  
22 \$1,000,000 of Series 2012D Bonds may submit a written request to the City Treasurer on or  
23 before a Record Date preceding an interest payment date for payment of interest on the next  
24 succeeding interest payment date and thereafter by wire transfer to a commercial bank  
25 located within the United States of America.



1 For so long as any Series 2012D Bonds are held in book-entry form by a securities  
2 depository selected by the City pursuant to Section 11, payment shall be made to the  
3 registered owner of the Series 2012D Bonds designated by such securities depository by wire  
4 transfer of immediately available funds.

5 (c) Interest on the Series 2012D Bonds. The Series 2012D Bonds shall bear  
6 interest at rates to be determined upon the sale of the Series 2012D Bonds, calculated on the  
7 basis of a 360-day year comprised of twelve 30-day months, payable on December 15, 2012  
8 (or such other date as may be designated in the Bond Award), and semiannually thereafter on  
9 June 15 and December 15 of each year. Each Series 2012D Bond shall bear interest from the  
10 interest payment date next preceding the date of its authentication unless it is authenticated  
11 as of a day during the period from the Record Date next preceding any interest payment date  
12 to the interest payment date, inclusive, in which event it shall bear interest from such interest  
13 payment date, or unless it is authenticated on or before the first Record Date, in which event it  
14 shall bear interest from the Dated Date; provided, that if, at the time of authentication of any  
15 Series 2012D Bond, interest is in default on the Series 2012D Bonds, such Series 2012D  
16 Bond shall bear interest from the interest payment date to which interest has previously been  
17 paid or made available for payment on the Series 2012D Bonds or from the Dated Date if the  
18 first interest payment is not made.

19 (d) Optional Redemption. The Series 2012D Bonds shall be subject to optional  
20 redemption prior to maturity as provided in the Official Notice of Sale or the Bond Award.

21 (e) Mandatory Redemption. The Series 2012D Bonds shall be subject to  
22 mandatory redemption at par, by lot, in any year in which the purchaser has designated that  
23 the principal amount payable with respect to that year shall constitute a mandatory sinking  
24 fund payment as permitted by the Official Notice of Sale. Any Series 2012D Bonds subject to  
25

1 mandatory redemption shall be designated as such in the Official Notice of Sale or the Bond  
2 Award.

3 The principal of and interest on the Series 2012D Bonds subject to mandatory  
4 redemption shall be paid from the Series 2012D Bond Account (as defined in Section 9),  
5 pursuant to Section 9. In lieu of any such mandatory redemption for Series 2012D Bonds, at  
6 any time prior to the selection of Series 2012D Bonds for mandatory redemption, the City may  
7 apply amounts on deposit in the Series 2012D Bond Account to make such payment to the  
8 purchase, at public or private sale, of Series 2012D Bonds subject to such mandatory  
9 redemption, and when and at such prices not in excess of the principal amount thereof  
10 (including sales commission and other charges but excluding accrued interest), as the City  
11 may determine.

12 (f) Selection of Series 2012D Bonds for Redemption. Whenever less than all of the  
13 outstanding Series 2012D Bonds are called for redemption on any date, the City Treasurer  
14 will select the maturities of the Series 2012D Bonds to be redeemed in the sole discretion of  
15 the City Treasurer. Whenever less than all of the outstanding Series 2012D Bonds maturing  
16 on any one date are called for redemption on any one date, the City Treasurer will select the  
17 Series 2012D Bonds or portions thereof, in denominations of \$5,000 or any integral multiple  
18 thereof, to be redeemed from the outstanding Series 2012D Bonds maturing on such date not  
19 previously selected for redemption, by lot, in any manner which the City Treasurer deems fair.

20 (g) Notice of Redemption. The date on which Series 2012D Bonds that are called  
21 for redemption are to be presented for redemption is called the "Redemption Date." The City  
22 Treasurer shall mail, or cause to be mailed, notice of any redemption of Series 2012D Bonds,  
23 postage prepaid, to the respective registered owners at the addresses appearing on the bond  
24 registration books not less than twenty (20) nor more than sixty (60) days prior to the  
25 Redemption Date. The notice of redemption shall (a) state the Redemption Date; (b) state the

1 redemption price; (c) state the maturity dates of the Series 2012D Bonds to be redeemed and,  
2 if less than all of any such maturity is called for redemption, the distinctive numbers of the  
3 Series 2012D Bonds of such maturity to be redeemed, and in the case of any Series 2012D  
4 Bonds to be redeemed in part only, the respective portions of the principal amount to be  
5 redeemed; (d) state the CUSIP number, if any, of each Series 2012D Bond to be redeemed;  
6 (e) require that such Series 2012D Bonds be surrendered by the owners at the office of the  
7 City Treasurer or his or her agent; and (f) give notice that interest on such Series 2012D  
8 Bonds or portions of Series 2012D Bonds to be redeemed will cease to accrue after the  
9 Redemption Date. Notice of optional redemption may be conditional upon receipt of funds or  
10 other event specified in the notice of redemption as provided in subsection (j) of this Section  
11 8.

12 The actual receipt by the owner of any Series 2012D Bond of notice of such  
13 redemption shall not be a condition precedent to redemption, and failure to receive such  
14 notice, or any defect in such notice so mailed, shall not affect the validity of the proceedings  
15 for the redemption of such Series 2012D Bonds or the cessation of accrual of interest on such  
16 Series 2012D Bonds on the Redemption Date.

17 Notice of redemption also shall be given, or caused to be given by the City Treasurer,  
18 by (i) registered or certified mail, postage prepaid, (ii) confirmed facsimile transmission, (iii)  
19 overnight delivery service, or (iv) to the extent acceptable to the intended recipient, email or  
20 similar electronic means, to (a) all organizations registered with the Securities and Exchange  
21 Commission as securities depositories and (b) such other services or organizations as may be  
22 required in accordance with the Continuing Disclosure Certificate described in Section 19.

23 The notice or notices required for redemption shall be given by the City Treasurer or  
24 any agent appointed by the City. A certificate of the City Treasurer or such other appointed  
25 agent of the City that notice of redemption has been given to the owner of any Series 2012D

1 Bond to be redeemed in accordance with this Resolution shall be conclusive against all  
2 parties.

3 (h) Series 2012D Redemption Account. At the time the City Treasurer or the  
4 Controller of the City or his or her designee (the "Controller") determines to optionally call and  
5 redeem any of the Series 2012D Bonds, the City Treasurer or his or her agent shall establish  
6 a redemption account to be described or known as the "General Obligation Bonds, Series  
7 2012D Redemption Account" (the "Series 2012D Redemption Account"), and prior to or on the  
8 Redemption Date there must be set aside in the Series 2012D Redemption Account moneys  
9 available for the purpose and sufficient to redeem, as provided in this Resolution, the Series  
10 2012D Bonds designated in said notice of redemption, subject to the provisions of subsection  
11 (j) of this Section. Said moneys must be set aside in the Series 2012D Redemption Account  
12 solely for the purpose of, and shall be applied on or after the Redemption Date to, payment of  
13 the redemption price of the Series 2012D Bonds to be redeemed upon presentation and  
14 surrender of such Series 2012D Bonds. Any interest due on or prior to the Redemption Date  
15 may be paid from the Series 2012D Bond Account as provided in Section 9 or from the Series  
16 2012D Redemption Account. Moneys held from time to time in the Series 2012D Redemption  
17 Account shall be invested by the City Treasurer pursuant to the City's policies and guidelines  
18 for investment of moneys in the General Fund of the City. If, after all of the Series 2012D  
19 Bonds have been redeemed and canceled or paid and canceled, there are moneys remaining  
20 in the Series 2012D Redemption Account, said moneys shall be transferred to the General  
21 Fund of the City or to such other fund or account as required by applicable law; provided, that  
22 if said moneys are part of the proceeds of refunding bonds, said moneys shall be transferred  
23 pursuant to the resolution authorizing such refunding bonds.

24 (i) Effect of Redemption. When notice of optional redemption has been given  
25 substantially as provided in this Resolution, and when the amount necessary for the

1 redemption of the Series 2012D Bonds called for redemption (principal, premium, if any, and  
2 accrued interest to such Redemption Date) is set aside for that purpose in the Series 2012D  
3 Redemption Account, the Series 2012D Bonds designated for redemption shall become due  
4 and payable on the Redemption Date, and upon presentation and surrender of said Series  
5 2012D Bonds at the place specified in the notice of redemption, such Series 2012D Bonds  
6 shall be redeemed and paid at said redemption price out of said Series 2012D Redemption  
7 Account. No interest will accrue on such Series 2012D Bonds called for redemption after the  
8 Redemption Date and the registered owners of such Series 2012D Bonds shall look for  
9 payment of such Series 2012D Bonds only to the Series 2012D Redemption Account. All  
10 Series 2012D Bonds redeemed shall be canceled immediately by the City Treasurer and shall  
11 not be reissued.

12 (j) Conditional Notice of Redemption; Rescission of Redemption. Any notice of  
13 optional redemption given as provided in Section 8(g) may provide that such redemption is  
14 conditioned upon: (i) deposit in the Series 2012D Redemption Account of sufficient moneys to  
15 redeem the Series 2012D Bonds called for optional redemption on the anticipated  
16 Redemption Date, or (ii) the occurrence of any other event specified in the notice of  
17 redemption. If conditional notice of redemption has been given substantially as provided in  
18 this subsection (j), and on the scheduled Redemption Date (i) sufficient moneys to redeem the  
19 Series 2012D Bonds called for optional redemption on the Redemption Date have not been  
20 deposited in the Series 2012D Redemption Account, or (ii) any other event specified in the  
21 notice of redemption as a condition to the redemption has not occurred, then (y) the Series  
22 2012D Bonds for which conditional notice of redemption was given shall not be redeemed on  
23 the anticipated Redemption Date and shall remain Outstanding for all purposes of this  
24 Resolution, and (z) the redemption not occurring shall not constitute a default under this  
25 Resolution or the Authorizing Resolution.

1           The City may rescind any optional redemption and notice of it for any reason on any  
2 date prior to any Redemption Date by causing written notice of the rescission to be given to  
3 the owners of all Series 2012D Bonds so called for redemption. Notice of any such rescission  
4 of redemption shall be given in the same manner notice of redemption was originally given.  
5 The actual receipt by the owner of any Series 2012D Bond of notice of such rescission shall  
6 not be a condition precedent to rescission, and failure to receive such notice or any defect in  
7 such notice so mailed shall not affect the validity of the rescission.

8           Section 9. Series 2012D Bond Account. There is established with the City Treasurer a  
9 special subaccount in the General Obligation Bonds (San Francisco General Hospital  
10 Improvement Bonds, 2008) Bond Account (the "Bond Account") created pursuant to the  
11 Authorizing Resolution to be designated the "General Obligation Bonds, Series 2012D Bond  
12 Subaccount" (the "Series 2012D Bond Account"), to be held separate and apart from all other  
13 accounts of the City. All interest earned on amounts on deposit in the Series 2012D Bond  
14 Account shall be retained in the Series 2012D Bond Account.

15           On or prior to the date on which any payment of principal of or interest on the Series  
16 2012D Bonds is due, including any Series 2012D Bonds subject to mandatory redemption on  
17 said date, the City Treasurer shall allocate to and deposit in the Series 2012D Bond Account,  
18 from amounts held in the Bond Account, an amount which, when added to any available  
19 moneys contained in the Series 2012D Bond Account, is sufficient to pay principal of and  
20 interest on the Series 2012D Bonds on such date

21           On or prior to the date on which any Series 2012D Bonds are to be redeemed at the  
22 option of the City pursuant to this Resolution, the City Treasurer may allocate to and deposit  
23 in the Series 2012D Redemption Account, from amounts held in the Bond Account pursuant  
24 to Section 8 of the Authorizing Resolution, an amount which, when added to any available  
25 moneys contained in the Series 2012D Redemption Account, is sufficient to pay principal,

1 interest and premium, if any, with respect to such Series 2012D Bonds on such date. The  
2 City Treasurer may make such other provision for the payment of principal of and interest and  
3 any redemption premium on the Series 2012D Bonds as is necessary or convenient to permit  
4 the optional redemption of the Series 2012D Bonds.

5 Amounts in the Series 2012D Bond Account may be invested in any investment of the  
6 City in which moneys in the General Fund of the City are invested. The City Treasurer may (i)  
7 commingle any of the moneys held in the Series 2012D Bond Account with other City moneys  
8 or (ii) deposit amounts credited to the Series 2012D Bond Account into a separate fund or  
9 funds for investment purposes only; provided, that all of the moneys held in the Series 2012D  
10 Bond Account shall be accounted for separately notwithstanding any such commingling or  
11 separate deposit by the City Treasurer.

12 Section 10. Series 2012D Project Account. There is established with the City  
13 Treasurer a special subaccount in the General Obligation Bonds (San Francisco General  
14 Hospital Improvement Bonds, 2008) Project Account (the "Project Account") created pursuant  
15 to the Authorizing Resolution to be designated the "General Obligation Bonds, Series 2012D  
16 Project Subaccount" (the "Series 2012D Project Account"), to be held separate and apart from  
17 all other accounts of the City. All interest earned on amounts on deposit in the Series 2012D  
18 Project Account shall be retained in the Series 2012D Project Account. Amounts in the Series  
19 2012D Project Account shall be expended in accordance with the provisions of the  
20 Authorizing Resolution for the acquisition, construction or reconstruction of the Project (as  
21 defined in the Authorizing Resolution).

22 Amounts in the Series 2012D Project Account may be invested in any investment of  
23 the City in which moneys in the General Fund of the City are invested. The City Treasurer  
24 may (i) commingle any of the moneys held in the Series 2012D Project Account with other  
25 City moneys or (ii) deposit amounts credited to the Series 2012D Project Account into a

1 separate fund or funds for investment purposes only; provided, that all of the moneys held in  
2 the Series 2012D Project Account (including interest earnings) shall be accounted for  
3 separately notwithstanding any such comingling or separate deposit by the City Treasurer.

4 The City Treasurer is authorized to pay or cause to be paid from the proceeds of the  
5 Series 2012D Bonds, on behalf of the City, the costs of issuance associated with the Series  
6 2012D Bonds. Costs of issuance of the Series 2012D Bonds shall include, without limitation,  
7 bond and financial printing expenses, mailing and publication expenses, rating agency fees,  
8 the fees and expenses of paying agents, registrars, financial consultants, disclosure counsel  
9 and co-bond counsel, and the reimbursement of departmental expenses in connection with  
10 the issuance of the Series 2012D Bonds.

11 Section 11. Appointment of Depositories and Other Agents. The City Treasurer is  
12 authorized and directed to appoint one or more depositories as he or she may deem desirable  
13 and the procedures set forth in Section 6, Section 7 and Section 8 relating to registration of  
14 ownership of the Series 2012D Bonds and payments and redemption notices to owners of the  
15 Series 2012D Bonds may be modified to comply with the policies and procedures of such  
16 depository. The City will not have any responsibility or obligation to any purchaser of a  
17 beneficial ownership interest in any Series 2012D Bonds or to any participants in such a  
18 depository with respect to (i) the accuracy of any records maintained by such securities  
19 depository or any participant therein; (ii) any notice that is permitted or required to be given to  
20 the owners of Series 2012D Bonds under this Resolution; (iii) the selection by such securities  
21 depository or any participant therein of any person to receive payment in the event of a partial  
22 redemption of Series 2012D Bonds; (iv) the payment by such securities depository or any  
23 participant therein of any amount with respect to the principal or redemption premium, if any,  
24 or interest due with respect to Series 2012D Bonds; (v) any consent given or other action



1 taken by such securities depository as the owner of Series 2012D Bonds; or (vi) any other  
2 matter.

3 The Depository Trust Company ("DTC") is appointed as depository for the Series  
4 2012D Bonds. The Series 2012D Bonds shall be initially issued in book-entry form. Upon  
5 initial issuance, the ownership of each Series 2012D Bond shall be registered in the bond  
6 register in the name of Cede & Co., as nominee of DTC. So long as each Series 2012D Bond  
7 is registered in book-entry form, each Series 2012D Bond shall be registered in the name of  
8 Cede & Co. or in the name of such successor nominee as may be designated from time to  
9 time by DTC or any successor as depository.

10 The City Treasurer is also authorized and directed to appoint one or more agents as he  
11 or she may deem necessary or desirable. To the extent permitted by applicable law and  
12 under the supervision of the City Treasurer, such agents may serve as paying agent, fiscal  
13 agent, rebate calculation agent, escrow agent or registrar for the Series 2012D Bonds or may  
14 assist the City Treasurer in performing any or all of such functions and such other duties as  
15 the City Treasurer shall determine. Such agents shall serve under such terms and conditions  
16 as the City Treasurer shall determine. The City Treasurer may remove or replace agents  
17 appointed pursuant to this paragraph at any time.

18 Section 12. Defeasance Provisions. Payment of all or any portion of the Series 2012D  
19 Bonds may be provided for prior to such Series 2012D Bonds' respective stated maturities by  
20 irrevocably depositing with the City Treasurer (or any commercial bank or trust company  
21 designated by the City Treasurer to act as escrow agent):

22 (a) An amount of cash equal to the principal amount of all of the Series 2012D  
23 Bonds or portion thereof to be defeased, and all unpaid interest thereon to maturity, except  
24 that in the case of any portion of the Series 2012D Bonds that is to be redeemed prior to such  
25 Series 2012D Bonds' respective stated maturities and in respect of which notice of such

1 redemption shall have been given as provided in Section 8 or an irrevocable election to give  
2 such notice shall have been made by the City, the amount to be deposited shall be the  
3 principal amount thereof, all unpaid interest thereon to the Redemption Date, and premium, if  
4 any, due on such Redemption Date; or

5 (b) Defeasance Securities (as defined below) not subject to call, except as provided  
6 below in the definition of that term, maturing and paying interest at such times and in such  
7 amounts, together with interest earnings and cash, if required, as will, without reinvestment,  
8 as certified by an independent certified public accountant, be fully sufficient to pay the  
9 principal and all unpaid interest to maturity, or to the Redemption Date, as the case may be,  
10 and premium, if any, due on the portion of the Series 2012D Bonds to be redeemed, as such  
11 principal and interest come due; provided, that, in the case of Series 2012D Bonds that are to  
12 be redeemed prior to maturity, notice of such redemption shall be given as provided in Section  
13 8 or an irrevocable election to give such notice shall have been made by the City; then, all  
14 obligations of the City with respect to said outstanding Series 2012D Bonds shall cease and  
15 terminate, except only the obligation of the City to pay or cause to be paid from the funds  
16 deposited pursuant to paragraphs (a) or (b) of this Section 12 to the owners of such Series  
17 2012D Bonds all sums due with respect thereto and the obligations of the City pursuant to  
18 Section 18; and provided further, that the City shall have received an opinion of nationally  
19 recognized bond counsel that provision for the payment of such Series 2012D Bonds has  
20 been made in accordance with this Section 12.

21 For purposes of this Section 12, "Defeasance Securities" shall mean any of the  
22 following that at the time are legal investments under the laws of the State of California for the  
23 moneys proposed to be invested:

24 (1) United States Obligations (as defined below); and  
25

1           (2) Pre-refunded fixed interest rate municipal obligations meeting the following  
2 conditions: (a) the municipal obligations are not subject to redemption prior to maturity, or the  
3 trustee or paying agent has been given irrevocable instructions concerning their calling and  
4 redemption and the issuer has covenanted not to redeem such obligations other than as set  
5 forth in such instructions; (b) the municipal obligations are secured by cash or United States  
6 Obligations; (c) the principal of and interest on the United States Obligations (plus any cash in  
7 the escrow fund or the Series 2012D Redemption Account) are sufficient to meet the liabilities  
8 of the municipal obligations; (d) the United States Obligations serving as security for the  
9 municipal obligations are held by an escrow agent or trustee; (e) the United States Obligations  
10 are not available to satisfy any other claims, including those against the trustee or escrow  
11 agent; and (f) the municipal obligations are rated, without regard to any numerical modifier,  
12 plus or minus sign or other modifier, at the time of original deposit to the escrow fund, by any  
13 two Rating Agencies (as defined below) not lower than the rating then maintained by such  
14 Rating Agencies on such United States Obligations.

15           For purposes of this Section 12, "United States Obligations" means (i) direct and  
16 general obligations of the United States of America, or obligations that are unconditionally  
17 guaranteed as to principal and interest by the United States of America, including without  
18 limitation, the interest component of Resolution Funding Corporation (REFCORP) bonds that  
19 have been stripped by request to the Federal Reserve Bank of New York in book-entry form  
20 or (ii) any security issued by an agency or instrumentality of the United States of America that  
21 is selected by the Director of Public Finance that results in the escrow fund being rated by any  
22 two Rating Agencies at the time of the initial deposit to the escrow fund and upon any  
23 substitution or subsequent deposit to the escrow fund, not lower than the rating then  
24 maintained by such Rating Agencies on United States Obligations described in clause (i)  
25 above.

1 For purposes of this Section 12, "Rating Agencies" means Moody's Investors Service,  
2 Inc., Fitch Ratings, and Standard and Poor's Rating Services, a division of The McGraw-Hill  
3 Companies, Inc., or any other nationally recognized bond rating agency that is the successor  
4 to any of the foregoing rating agencies or that is otherwise established after the date hereof.

5 Section 13. Official Notice of Sale; Receipt of Bids; Bond Award.

6 (a) Official Notice of Sale. The form of proposed Official Notice of Sale inviting bids  
7 for the Series 2012D Bonds (the "Official Notice of Sale") submitted to the Board is approved  
8 as the Official Notice of Sale inviting bids for the Series 2012D Bonds, with such changes,  
9 additions and modifications as may be made in accordance with Section 20. The Director of  
10 Public Finance is authorized and directed to cause to be mailed or otherwise circulated to  
11 prospective bidders for the Series 2012D Bonds copies of the Official Notice of Sale, subject  
12 to such corrections, revisions or additions as may be acceptable to the Director of Public  
13 Finance.

14 (b) Receipt of Bids. Bids shall be received on the date designated by the Director of  
15 Public Finance pursuant to Section 4.

16 (c) Bond Award. As provided in the Official Notice of Sale, the City may reject any  
17 and all bids received for any reason. The Controller is authorized to award the Series 2012D  
18 Bonds to the responsible bidder whose bid (a) is timely received and conforms to the Official  
19 Notice of Sale, except to the extent informalities and irregularities are waived by the City as  
20 permitted by the Official Notice of Sale, and (b) represents the lowest true interest cost to the  
21 City in accordance with the procedures described in the Official Notice of Sale. The award, if  
22 made, shall be set forth in a certificate signed by the Controller setting forth the terms of the  
23 Series 2012D Bonds and the original purchasers (the "Bond Award"). The Controller shall  
24 provide a copy of the Bond Award as soon as practicable to the Clerk of the Board of  
25

1 Supervisors and the Director of Public Finance; provided, that failure to provide such copy  
2 shall not affect the validity of the Bond Award.

3 Section 14. Publication of Notice of Intention to Sell Bonds. The form of proposed  
4 Notice of Intention to Sell the Series 2012D Bonds (the "Notice of Intention to Sell Bonds")  
5 submitted to the Board is approved as the Notice of Intention to Sell the Series 2012D Bonds,  
6 and the Director of Public Finance is authorized and directed to cause the Notice of Intention  
7 to Sell Bonds, subject to such corrections, revisions or additions as may be made in  
8 accordance with Section 20, to be published once in The Bond Buyer or another financial  
9 publication generally circulated throughout the State of California.

10 Section 15. Sale of Series 2012D Bonds; Solicitation of Competitive Bids. The Board  
11 authorizes the sale of the Series 2012D Bonds by solicitation of competitive bids for the  
12 purchase of the Series 2012D Bonds on the date and at the place determined in accordance  
13 with the Official Notice of Sale and Section 4.

14 Section 16. Disposition of Proceeds of Sale. The proceeds of sale of the Series  
15 2012D Bonds shall be applied by the City Treasurer as follows: (a) accrued interest, if any,  
16 shall be deposited into the Series 2012D Bond Account; (b) premium, if any, shall be  
17 deposited into the Series 2012D Bond Account; and (iii) remaining proceeds of sale shall be  
18 deposited into the Series 2012D Project Account.

19 Section 17. Official Statement. The form of proposed Preliminary Official Statement  
20 describing the Series 2012D Bonds (the "Preliminary Official Statement") submitted to the  
21 Board is hereby approved as the Preliminary Official Statement describing the Series 2012D  
22 Bonds, with such additions, corrections and revisions as may be determined to be necessary  
23 or desirable made in accordance with Section 20. The Controller is authorized to cause the  
24 distribution of a Preliminary Official Statement deemed final for purposes of Securities and  
25 Exchange Commission Rule 15c2-12 promulgated under the Securities Exchange Act of

1 1934, as amended (the "Rule"), and to sign a certificate to that effect. The Director of Public  
2 Finance is authorized and directed to cause to be printed and mailed or electronically  
3 distributed to prospective bidders for the Series 2012D Bonds the Preliminary Official  
4 Statement in substantially the form of the Preliminary Official Statement approved by this  
5 Resolution, as completed, supplemented, corrected or revised. The Controller is authorized  
6 and directed to approve, execute, and deliver the final Official Statement with respect to the  
7 Series 2012D Bonds, which final Official Statement shall be in the form of the Preliminary  
8 Official Statement, with such additions, corrections and revisions as may be determined to be  
9 necessary or desirable made in accordance with Section 20 and as are permitted under the  
10 Rule. The Director of Public Finance is authorized and directed to cause to be printed and  
11 mailed or electronically distributed the final Official Statement to all actual initial purchasers of  
12 the Series 2012D Bonds.

13 Section 18. Tax Covenants. (a) General. The City covenants with the holders of the  
14 Series 2012D Bonds that, notwithstanding any other provisions of this Resolution, it shall not  
15 take any action, or fail to take any action, if any such action or failure to take action would  
16 adversely affect the exclusion from gross income of interest on the Series 2012D Bonds under  
17 Section 103 of the Code, and the regulations issued thereunder, as the same may be  
18 amended from time to time, and any successor provisions of law. Reference to a particular  
19 section of the Code shall be deemed to be a reference to any successor to any such section.  
20 The City shall not, directly or indirectly, use or permit the use of proceeds of the Series 2012D  
21 Bonds or any of the property financed or refinanced with proceeds of the Series 2012D  
22 Bonds, or any portion thereof, by any person other than a governmental unit (as such term is  
23 used in Section 141 of the Code), in such manner or to such extent as would result in the loss  
24 of exclusion of interest on the Series 2012D Bonds from gross income for federal income tax  
25 purposes.

1 (b) Use of Proceeds. The City shall not take any action, or fail to take any action, if  
2 any such action or failure to take action would cause the Series 2012D Bonds to be "private  
3 activity bonds" within the meaning of Section 141 of the Code, and in furtherance thereof,  
4 shall not make any use of the proceeds of the Series 2012D Bonds or any of the property  
5 financed or refinanced with proceeds of the Series 2012D Bonds, or any portion thereof, or  
6 any other funds of the City, that would cause the Series 2012D Bonds to be "private activity  
7 bonds" within the meaning of Section 141 of the Code. To that end, so long as any Series  
8 2012D Bonds are outstanding, the City, with respect to such proceeds and property and such  
9 other funds, will comply with applicable requirements of the Code and all regulations of the  
10 United States Department of the Treasury issued thereunder, to the extent such requirements  
11 are, at the time, applicable and in effect. The City shall establish reasonable procedures  
12 necessary to ensure continued compliance with Section 141 of the Code and the continued  
13 qualification of the Series 2012D Bonds as "governmental bonds."

14 (c) Arbitrage. The City shall not, directly or indirectly, use or permit the use of any  
15 proceeds of the Series 2012D Bonds, or of any property financed or refinanced by the Series  
16 2012D Bonds, or other funds of the City, or take or omit to take any action, that would cause  
17 the Series 2012D Bonds to be "arbitrage bonds" within the meaning of Section 148 of the  
18 Code. To that end, the City shall comply with all requirements of Section 148 of the Code and  
19 all regulations of the United States Department of the Treasury issued thereunder to the  
20 extent such requirements are, at the time, in effect and applicable to the Series 2012D Bonds.

21 (d) Federal Guarantee. The City shall not make any use of the proceeds of the  
22 Series 2012D Bonds or any other funds of the City, or take or omit to take any other action,  
23 that would cause the Series 2012D Bonds to be "federally guaranteed" within the meaning of  
24 Section 149(b) of the Code.  
25

1 (e) Information Reporting. The City shall take or cause to be taken all necessary  
2 action to comply with the information reporting requirement of Section 149(e) of the Code with  
3 respect to the Series 2012D Bonds.

4 (f) Hedge Bonds. The City shall not make any use of the proceeds of the Series  
5 2012D Bonds or any other amounts or property, regardless of the source, or take any action  
6 or refrain from taking any action that would cause the Series 2012D Bonds to be considered  
7 "hedge bonds" within the meaning of Section 149(g) of the Code unless the City takes all  
8 necessary action to assure compliance with the requirements of Section 149(g) of the Code.

9 (g) Compliance with Tax Certificate. In furtherance of the foregoing tax covenants  
10 of this Section 18, the City covenants that it will comply with the provisions of the Tax  
11 Certificate to be executed by the City with respect to the Series 2012D Bonds, dated the date  
12 of issuance of the Series 2012D Bonds, as such Tax Certificate may be amended from time to  
13 time. This covenant shall survive payment in full or defeasance of the Series 2012D Bonds.

14 Section 19. Continuing Disclosure Certificate. The form of Continuing Disclosure  
15 Certificate (the "Continuing Disclosure Certificate"), to be executed by the City to permit the  
16 original purchasers of the Series 2012D Bonds to comply with the Rule, submitted to the  
17 Board is hereby approved as the Continuing Disclosure Certificate, with such additions,  
18 corrections and revisions as may be determined to be necessary or desirable made in  
19 accordance with Section 20. The Controller is authorized and directed to execute the  
20 Continuing Disclosure Certificate on behalf of the City and deliver the Continuing Disclosure  
21 Certificate to the original purchasers of the Series 2012D Bonds.

22 Section 20. Modification to Documents. Any City official authorized by this Resolution  
23 to execute any document is further authorized, in consultation with the City Attorney , to  
24 approve and make such changes, additions, amendments or modifications to the document or  
25 documents such official is authorized to execute as may be necessary or advisable (provided,



1 that such changes, additions, amendments or modifications shall not authorize an aggregate  
2 principal amount of Series 2012D Bonds in excess of \$265,185,000 or conflict with the  
3 provisions of Section 4 or in any way increase the risks or obligations of the City in a manner  
4 inconsistent with the terms herein contained). The approval of any change, addition,  
5 amendment or modification to any of the aforementioned documents shall be evidenced  
6 conclusively by the execution and delivery of the document in question.

7 Section 21. Ratification. All actions previously taken by officials, employees and  
8 agents of the City with respect to the sale and issuance of the Series 2012D Bonds are  
9 approved, confirmed and ratified.

10 Section 22. Relationship to Authorizing Resolution. In the event of any conflict  
11 between this Resolution and the Authorizing Resolution, the terms of this Resolution shall  
12 control. Without limiting the foregoing and notwithstanding the provisions of the Authorizing  
13 Resolution, the City is not obligated to transfer money from the General Fund of the City to the  
14 Bond Account to pay the principal of or interest on the Series 2012D Bonds.

15 Section 23. Reimbursement. The City declares its official intent to reimburse prior  
16 expenditures of the City incurred prior to the issuance and sale of the Series 2012D Bonds in  
17 connection with the Project or portions thereof to be financed by the Series 2012D Bonds.  
18 The Board declares the City's intent to reimburse the City with the proceeds of the Series  
19 2012D Bonds for the expenditures with respect to the Project (the "Expenditures" and each,  
20 an "Expenditure") made on and after that date that is no more than 60 days prior to adoption  
21 of this Resolution. The City reasonably expects on the date of adoption of this Resolution that  
22 it will reimburse the Expenditures with the proceeds of the Series 2012D Bonds.

23 Each Expenditure was and will be either (a) of a type properly chargeable to a capital  
24 account under general federal income tax principles (determined in each case as of the date  
25 of the Expenditure), (b) a cost of issuance with respect to the Series 2012D Bonds, (c) a

1 nonrecurring item that is not customarily payable from current revenues, or (d) a grant to a  
2 party that is not related to or an agent of the City so long as such grant does not impose any  
3 obligation or condition (directly or indirectly) to repay any amount to or for the benefit of the  
4 City. The maximum aggregate principal amount of the Series 2012D Bonds expected to be  
5 issued for the Project is \$265,185,000. The City shall make a reimbursement allocation,  
6 which is a written allocation by the City that evidences the City's use of proceeds of the Series  
7 2012D Bonds to reimburse an Expenditure, no later than 18 months after the later of the date  
8 on which the Expenditure is paid or the Project is placed in service or abandoned, but in no  
9 event more than three years after the date on which the Expenditure is paid. The City  
10 recognizes that exceptions are available for certain "preliminary expenditures," costs of  
11 issuance, certain de minimis amounts, expenditures by "small issuers" (based on the year of  
12 issuance and not the year of expenditure) and expenditures for construction projects of at  
13 least 5 years.

14 Section 24. Accountability Reports. The Series 2012D Bonds are subject to  
15 accountability requirements under the City's Administrative Code and the Bond Election  
16 Ordinance. Accountability report(s) with respect to the Series 2012D Bonds shall be  
17 submitted at the time(s) and in the manner required by the Administrative Code and the Bond  
18 Election Ordinance.

19 Section 25. Citizens' Oversight Committee. The Series 2012D Bonds are subject to,  
20 and incorporate by reference, the applicable provisions of the San Francisco Administrative  
21 Code Sections 5.30-5.36 (the "Citizens' General Obligation Bond Oversight Committee"), and,  
22 to the extent permitted by law, one tenth of one percent (0.1%) of the gross proceeds of the  
23 Series 2012D Bonds shall be deposited into a fund established by the Controller's Office and  
24 appropriated by the Board at the direction of the Citizens' General Obligation Bond Oversight  
25 Committee to cover the costs of such committee.

1           Section 26. CEQA Findings. The Board finds and declares that in accordance with the  
2 actions contemplated in this resolution, this Board, in approving Resolution No. 307-08 on  
3 July 16, 2008, including the Attachment A and Exhibit 1 to Attachment A, adopted findings  
4 with respect to the Final Environmental Impact Report ("FEIR") for the Project pursuant to the  
5 California Environmental Quality Act, ("CEQA"), CEQA Guidelines and San Francisco  
6 Administrative Code Chapter 31, including the adoption of a mitigation monitoring and  
7 reporting program and a statement of overriding considerations, ("CEQA Findings"). The  
8 CEQA Findings for the Project are on file with the Clerk of the Board in File No. 080663 and  
9 are incorporated into this resolution by this reference. The Board further finds that on the  
10 basis of substantial evidence and in light of the whole record, there are no changes in the  
11 Project, the circumstances under which the Project will be undertaken or new information that  
12 has become available since preparation of the FEIR that would alter the CEQA Findings  
13 previously adopted by the Board.

14           Section 27. General Plan and Other Findings. The Board finds and declares that the  
15 proposed Project is (i) in conformity with the priority policies of Section 101.1(b) of the City  
16 Planning Code, (ii) in accordance with Section 4.105 of the San Francisco Charter and  
17 Section 2A.53(f) of the City Administrative Code, and (iii) consistent with the City's General  
18 Plan, and adopts the findings of the City Planning Department, as set forth in the General  
19 Plan Referral Report, dated June 19, 2008, a copy of which is on file with the Clerk of the  
20 Board in File No. 080663 and incorporates said findings by reference.



## EXECUTIVE SUMMARY

### Legislative Objectives

- File 12-0532: Resolution authorizing and directing the third sale of up to \$265,185,000 in San Francisco General Hospital Improvement General Obligation Bonds.
- File 12-0526: Ordinance appropriating up to \$265,185,000 of 2012 Series D San Francisco General Hospital Improvement General Obligation Bond proceeds, including (a) \$249,384,679 to DPH for the reconstruction, expansion, and seismic strengthening of San Francisco General Hospital, (b) \$2,418,997 bond issuance costs, (c) \$751,324 for oversight and accountability costs, (d) \$12,630,000 Reserve to allow for fluctuations in market conditions, and (e) placing the entire \$265,185,000 on Controller's Reserve pending the sale of the bonds.

### Key Points

- In November, 2008, the San Francisco voters previously approved the sale of up to \$887,400,000 in General Obligation Bonds to fund the reconstruction, expansion, and seismic strengthening of San Francisco General Hospital. The City previously sold \$131,650,000 in such bonds in 2009 and \$294,695,000 in such bonds in 2010, totaling \$426,345,000. Therefore, of the \$887,400,000 in General Obligation Bonds, \$461,055,000 of such bonds have not yet been sold.
- File 12-0532 would approve the third sale of General Obligation Bonds up to \$265,185,000 to fund the reconstruction, expansion, and seismic strengthening of San Francisco General Hospital. File 12-0526 would appropriate the proceeds of such a bond sale. The remaining \$195,870,000 (\$461,055,000 less \$265,185,000) of San Francisco General Hospital (SFGH) Improvement General Obligation Bonds are anticipated to be sold in mid to late 2013.

### Fiscal Impacts

- The proposed sale of up to \$265,185,000 in SFGH Improvement GO Bonds will have a projected annual interest rate of 6.0% over approximately 20 years, with estimated total debt service payments of \$438,187,555, including \$185,632,555 in interest and \$252,555,000 in principal, with estimated average annual debt service payments of \$21,909,378. The difference between the proposed \$265,185,000 SFGH Improvement Bonds and the \$252,555,000 principal is \$12,630,000 for the reserve to allow for fluctuations in the market. Debt service would be paid from increased Property Taxes, such that an owner of a single family residence with an assessed value of \$500,000 would pay average annual additional Property Taxes to the City of \$68.03 per year.
- The City's Charter imposes a three percent limit on the amount of General Obligation Bonds that can be outstanding at any given time, relative to the total net assessed value of property in the City. As of May 1, 2012, there was \$1,654,741,441 of General Obligation Bonds outstanding, or approximately 1.04% of the \$158,649,887,998 total net assessed value of property in the City. If the City sells the proposed amount of \$252,555,000 of SFGH Improvement General Obligation Bonds, the total outstanding General Obligation Bonds would total \$1,907,296,441, or approximately 1.2% of the total net assessed value of property.

### Recommendation

- Approve the proposed resolution (File 12-0532) and the proposed ordinance (File 12-0526), subject to approval by the City's Capital Planning Committee.

## MANDATE STATEMENT / BACKGROUND

### Mandate Statement

Section 9.105 of the City's Charter authorizes the Board of Supervisors to approve the issuance and sale of General Obligation Bonds in accordance with State law or local procedures adopted by ordinance. Section 9.105 of the City's Charter also provides that (a) amendments to the appropriation ordinance, as finally adopted, are to be adopted in the same manner as other ordinances<sup>1</sup>, and (b) no amendment to the appropriation ordinance may be adopted unless the Controller certifies the availability of funds.

### Background

In November of 2008, the voters of San Francisco approved Proposition A, which authorized the sale of up to \$887,400,000 in General Obligation Bonds to fund the reconstruction, expansion, and seismic strengthening of San Francisco General Hospital. Table 1 below shows the total San Francisco General Hospital (SFGH) Improvement Bond Program budget of \$887,400,000.

In March of 2009, the City sold \$131,650,000 in such bonds (File 08-1521), and in March 2010, sold \$294,695,000 in such bonds (File 10-0024) for a total of \$426,345,000 in such bonds which have been sold. Therefore, of the \$887,400,000 in General Obligation Bonds, \$461,055,000 have not yet been sold.

The proposed sale of up to \$265,185,000 of bonds would be the third sale of San Francisco General Hospital Improvement General Obligation Bonds. According to Mr. Ronald Alameida, San Francisco General Hospital Rebuild Program Manager for the Department of Public Works, the remaining \$195,870,000 (\$461,055,000 less \$265,185,000) of San Francisco General Hospital (SFGH) Improvement General Obligation Bonds are anticipated to be sold in mid to late 2013.

<sup>1</sup> In accordance with Section 2.105 of the San Francisco Charter, the approval of an ordinance requires two readings at separate Board of Supervisors meetings, held at least five days apart.

## DETAILS OF PROPOSED LEGISLATION

The proposed resolution (File 12-0532) would authorize the sale of up to \$265,185,000 of SFGH Improvement General Obligation (GO) Bonds, which would be the third in the series of the total \$887,400,000 San Francisco General Hospital Improvement funds approved by the voters on November, 2008 under Proposition A. The proposed resolution:

- Authorizes the Director of Public Finance to determine the sale date, interest rates, principal amount of the bonds, maturity and redemption dates, with the provision that interest rates cannot exceed 12 percent and the maturity date cannot extend beyond June 15, 2040;
- Provides for the execution, authentication and registration of the 2012 San Francisco General Hospital Improvement, Series 2012D Bonds;
- Sets the terms for transferring or redeeming the bonds;
- Provides for defeasance of the bonds;
- Requires a special Series 2012D Bond subaccount for payment of principal and interest; and a special Series 2012D project subaccount for acquisition, renovation, and construction of bond-funded projects;
- Approves the appointment of the Depository Trust Company as the securities depository, and authorizes the Treasurer to appoint fiscal and other agents;
- Approves the (a) Official Notice of Sale, which announces the date, time and terms of the competitive bond sale; and the (b) Notice of Intention to Sell the Bonds;
- Approves the Official Statement, describing the sources and uses of funds, security for the bonds, risk factors, and tax and other legal matters, among other information; and authorizes the Controller or Director of Public Finance to revise the Official Statement to conform to the City's Comprehensive Annual Fiscal Report (CAFR);
- Restricts use of the bond proceeds to the public purpose for which the bonds were intended;
- Approves the Continuing Disclosure Certificate, which provides certain financial information and operating data relating to the City (the "Annual Report") not later than 270 days after the end of the fiscal year and to provide notices of the occurrence of certain enumerated events, if material;
- Authorizes City officials who have responsibility for executing documents related to the Series 2012D Bonds, including the Controller, Director of Public Finance, and Treasurer, to modify the documents as necessary, except that the Series 2012D Bond amount cannot exceed \$265,185,000; and
- Subjects the Series 2012D Bonds to the reporting requirements of the Citizens' General Obligation Bond Oversight Committee.

The proposed ordinance (File 12-0526) would appropriate the entire \$265,185,000 under this third SFGH Improvement General Obligation Bond sale, including (a) \$249,384,679 to DPH for the reconstruction, expansion, and seismic strengthening of San Francisco General Hospital (b)

\$2,418,997 bond issuance costs, (c) \$751,324 for oversight and audit costs, (d) \$12,630,000 Reserve to allow for fluctuations in market conditions, and (e) placing the entire \$265,185,000 on Controller's Reserve pending the sale of the bonds.

## FISCAL IMPACTS

### Project Appropriations and Expenditures To Date for the SFGH Improvement Project

Table 2 below shows (a) the SFGH Improvement Bond project budget totaling \$887,400,000, (b) the initial \$131,650,000 and second \$294,695,000 of SFGH Improvement General Obligation Bonds previously sold and appropriated, totaling \$426,345,000, (c) the proposed \$265,185,000 to be sold and appropriated, (d) the total of \$678,900,000 for the first two and proposed third bond sales and appropriations, and (e) the remaining amount of \$195,870,000 for future bond sales and appropriations.

To date, a total of \$426,345,000 (\$131,650,000 plus \$294,595,000) has been appropriated for the SFGH Improvement project. As reported by DPH in the April 10, 2012 Bond Accountability Report, as of March 31, 2012, DPH had expended \$262,615,669 or 61.6% of the appropriated \$426,345,000 and encumbered \$96,864,011 of the funds previously appropriated for the SFGH Improvement project. There remains a balance of \$66,865,320 (\$426,345,000 less \$262,615,669 less \$96,864,011) in unexpended and unencumbered funds.

### **Requested General Obligation Bond Debt Financing**

According to Ms. Nadia Sesay, Director of the Office of Public Finance, the proposed up to \$265,185,000 of SFGH Improvement General Obligation Bonds are expected to be sold in August, 2012, together with up to \$40,410,000 (File 12-0533 on the June 6, 2012 calendar of the Budget and Finance Committee) of Earthquake Safety and Emergency Response General Obligation Bonds, for a total not-to-exceed \$305,595,000 General Obligation Bond sale. However, as noted in the Attachment, a memorandum from Ms. Sesay, the office only intends to issue \$252,555,000<sup>2</sup> of SFGH Improvement General Obligation Bonds and \$38,485,000<sup>3</sup> in Earthquake Safety and Emergency Response General Obligation Bonds for a total of \$291,040,000.

Ms. Sesay advised that the not-to-exceed \$265,185,000 of San Francisco General Hospital Improvement GO Bonds will have a projected annual interest rate of 6.0% over approximately 20 years, with annual debt service payments extending from 2012 through 2032. Assuming a 20-year term, these bonds will result in estimated total debt service payments of \$438,187,555, including \$185,632,555 in interest and \$252,555,000 in principal, with estimated average annual debt service payments of \$21,909,378.

Repayment of such annual debt service will be recovered through increases to the annual Property Tax rate which, according to the Controller's Office, average \$0.0138 per \$100 of assessed valuation over the anticipated 20-year term of the Bonds. A single family residence with an assessed value of \$500,000, assuming a homeowners exemption of \$7,000, would pay average annual additional Property Taxes to the City of \$68.03 per year ( $\$500,000 - \$7,000 / \$100 \times \$0.0138$ ) if the proposed amount of \$252,555,000 in General Obligation Bonds are issued and appropriated.

The City's Charter imposes a three percent limit on the amount of General Obligation Bonds that can be outstanding at any given time, relative to the total net assessed value of property in the City. The FY 2011-12 total net assessed value of property in the City is \$158,649,887,998. According to Ms. Sesay, as of May 1, 2012, there was \$1,654,741,441 of General Obligation Bonds outstanding, or approximately 1.04% of the total net assessed value of property in the City. If the City sells the proposed amount of \$252,555,000 of General Obligation Bonds, the total outstanding General Obligation Bonds would total \$1,907,296,441, or approximately 1.2% of the total net assessed value of property.

<sup>2</sup> The difference between the proposed \$265,185,000 SFGH Improvement Bonds and the \$252,555,000 principal is \$12,630,000 for the reserve to allow for fluctuations in the market.

<sup>3</sup> The difference between the requested not to exceed \$40,410,000 ESER Bonds and the \$38,485,000 principal is \$1,925,000 for the reserve to allow for fluctuations in the market.

As noted above, the Office of Public Finance intends to issue only \$252,555,000 of the subject not to exceed \$265,185,000 SFGH Improvement General Obligation Bonds as well as \$38,485,000 of the not to exceed \$40,410,000 (File 12-0533 on the June 6, 2012 calendar of the Budget and Finance Committee) of Earthquake Safety and Emergency Response General Obligation Bonds in August 2012, or a total issuance of \$291,040,000. If the proposed not to exceed total of \$291,040,000 of General Obligation Bonds are issued, the City's total outstanding General Obligation Bonds would total \$1,945,781,441, or approximately 1.23 % of the total net assessed value of property.

## **POLICY CONSIDERATION**

The Budget and Legislative Analyst notes that, as of the writing of this report, the Capital Planning Committee has not yet reviewed and recommended DPH's proposed issuance and appropriation of \$265,185,000. According to Mr. Brian Strong, Director of the City's Capital Planning Program, the City's Capital Planning Committee will be reviewing DPH's requested issuance and appropriation of the subject \$265,185,000 of SFGH Improvement General Obligation (GO) Bonds on June 4, 2012, two days before the June 6, 2012 Budget and Finance Committee hearing. Therefore, the Budget and Legislative Analyst recommends approval of the proposed issuance and appropriation, subject to approval of the City's Capital Planning Committee.

## **RECOMMENDATIONS**

Approve the proposed resolution (File 12-0532) and the proposed ordinance (File 12-0526), subject to approval by the City's Capital Planning Committee.

I respectfully request that the Board of Supervisors consider for review and recommendation to the Board of Supervisors the issuance of general obligation bonds financing the San Francisco General Hospital & Trauma Center Seismic Retrofit and the Earthquake Safety and Emergency Response program. In connection with this request, legislation approving the sale and issuance of the bonds, supplemental appropriation ordinances to appropriate the bond proceeds, and related supporting documents were introduced at the Board of Supervisors meeting on Tuesday, May 15, 2012.

**Background:**

*San Francisco General Hospital & Trauma Center*

A two-thirds majority of voters of the City approved Proposition A in November 2008 ("Proposition A"), which authorized the issuance of not to exceed \$887,400,000 in general obligation bonds to build and/or rebuild and improve the earthquake safety of San Francisco General Hospital and Trauma Center (the "General Hospital Project"). The resolution authorizing the sale of City and County of San Francisco general obligation bonds (San Francisco General Hospital and Trauma Center, 2008) authorizes the issuance of not to exceed \$265,185,000 of City and County of San Francisco General Obligation Bonds Series 2012D (San Francisco General Hospital Improvement Bonds, 2008) to finance the purchase, construction, mobilization, project control and other program costs of the General Hospital Project.

Of the \$887,400,000 authorized to be issued by Proposition A, \$131,650,000 was issued in March 2009 and \$294,695,000 was issued in March 2010. The Bonds will be the third series of bonds to be issued under Proposition A for the General Hospital Project.

**Earthquake Safety & Emergency Response Bonds**

A two-thirds majority of voters of the City approved Proposition B in June 2010 (the "Proposition B"), which authorized the issuance of not to exceed \$412,300,000 in general obligation bonds to finance the construction, acquisition, improvement, retrofitting, rehabilitation and completion of earthquake safety and emergency responsiveness facilities and infrastructure (the "Earthquake Safety Projects"). The proposed resolution authorizes the issuance of not to exceed \$40,410,000 of City and County of San Francisco General Obligation Bonds, Series 2012E (Earthquake Safety and Emergency Response Bonds, 2010).

Of the \$412,300,000 authorized to be issued by the Proposition B, \$79,520,000 was issued in December 2010 and \$183,330,000 was issued in March 2012. The Series 2012E Bonds will be the third series of bonds to be issued under Proposition B financing the Earthquake Safety Projects. Proceeds from the 2012E Bonds will finance Auxiliary Water System Supply improvements.

The City anticipates issuing the Series 2012D and Series 2012E Bonds in August 2012. Detailed descriptions of the Projects financed with proceeds of the Bonds are included in the Bond Accountability Reports prepared by the respective departments. The remaining authorization under Proposition A and Proposition B will be issued subject to the consideration and adoption by the Board of Supervisors and approval by the Mayor of subsequent authorizing resolutions.

**Financing Parameters:**

The proposed resolutions authorize the issuance of not to exceed aggregate par amount of \$305,595,000. Based on current project cost estimates and schedules, the Office of Public Finance expects to issue \$291,040,000 under conservative assumptions of market conditions prevailing at the expected time of sale. The additional authorized amount above the expected issuance amount allows for fluctuations in market conditions from the date of authorization by the Board to the time of the sale of the Bonds. The Bonds are anticipated to contribute approximately \$249.38 million to the General Hospital Project and \$38.0 million to the Earthquake Safety Projects. Table 1 outlines anticipated sources and uses for the Bonds.

Based upon a conservative estimate of 6.0% interest rate, OPF estimates that average fiscal year debt service on the Bonds is approximately \$25.25 million. The anticipated total par value of \$291.04 million is estimated to result in approximately \$213.92 million in interest payments over the life of the Bonds. The total principal and interest payment over the approximate 20 year life of the Bonds is approximately \$504.96 million.

In addition, a portion of the Bonds will pay certain expenses incurred in connection with their issuance and delivery and the periodic oversight and review of the projects by the Citizens' General Obligation Bond Oversight Committee ("CGOBOC").

**Financing Timeline:**

The Bonds are expected to be issued and delivered in August 2012. Schedule milestones in connection with the financing may be summarized as follows:

**Debt Limit:**

The City Charter imposes a limit on the amount of general obligation bonds the City can have outstanding at any given time. That limit is 3.00% of the assessed value of property in the City. As of May 1, 2012, there were \$1.65 billion in general obligation bonds outstanding or approximately 1.04% of the net assessed value of property in the City. If all of the City's authorized and unissued bonds were issued, the total debt burden would be 1.72% of the net assessed value of property in the City. If the Board of Supervisors approves the issuance of the Bonds, the debt ratio would increase by approximately 0.18% to 1.23%— within the 3.00% legal debt limit.

**Capital Plan:**

The Capital Planning Committee approved a financial constraint regarding the City's planned use of general obligation bonds such that debt service on approved and issued general obligation bonds would not increase property owners' long-term property tax rates above fiscal year 2006 levels. The fiscal year 2006 property tax rate for the general obligation bond fund was \$0.1201 per \$100 of assessed value.

In fiscal year 2011-12, the property tax rate for the general obligation bond fund is \$0.1147 per \$100 of assessed value. If the Board of Supervisors approves the issuance of the Bonds, the overall property tax rate would be maintained within the Capital Planning Committee's approved financial constraint.

**Additional Information:**

The Resolutions were introduced at the Board of Supervisors meeting on Tuesday, May 15, 2012. The related financing documents—including the Notice of Intention to Sell, Official Notice of Sale, Official Statement, Appendix A and Continuing Disclosure Certificate and related documents—will also be submitted.

**Official Notice of Sale and Notice of Intention to Sell:** The Notice of Intention to Sell provides legal notice to prospective bidders of the City's intention to sell City and County of San Francisco General Obligation Bonds, consisting of (i) General Obligation Bonds, Series 2012D and (ii) General Obligation Bonds, Series 2012E. Such Notice of Intention to Sell will be published once in "The Bond Buyer" or another financial publication generally circulated throughout the State of California.

The Official Notice of Sale for the Bonds announces the date and time of the competitive bond sale, including the terms relating to the Bonds; the terms of sale, form of bids, and delivery of bids; and closing procedures and documents. Pending market conditions, the Bonds may be bid separately by series or bids may be received for all of the Bonds.

Exhibit A to the Official Notice of Sale is the form of the official bid for the purchase of the Bonds. Pursuant to the Resolutions, the Controller is authorized to award the Bonds to the bidder whose bid represents the lowest true interest cost to the City in accordance with the procedures described in the Official Notice of Sale.

*Official Statement and Appendix A:* The Official Statement provides information for prospective bidders and investors in connection with the public offering by the City of the Bonds. The Official Statement describes the Bonds, including sources and uses of funds; security for the Bonds; risk factors; and tax and other legal matters, among other information. The Official Statement also includes the City's Appendix A, the most recent Comprehensive Annual Financial Report of the City, the City's Investment Policy, and other forms of legal documents for the benefit of investors, holders and owners of the Bonds. A *Preliminary Official Statement* is distributed to prospective bidders prior to the sale of the Bonds and within seven days of the public offering of the Bonds, the *Final Official Statement* (adding certain sale results including the offering prices, interest rates, selling compensation, principal amounts, and aggregate principal amounts) is distributed to the initial purchasers of the Bonds.

The Board of Supervisors and the Mayor, in adopting and approving the Resolution, approve the form of the Official Statement, and authorize the use and distribution of the Official Statement by the co-financial advisors with respect to the Bonds. The Official Statement must include all facts that would be material to an investor in the Bonds. Material information is information that there is a substantial likelihood would have actual significance in the deliberations of the reasonable investor when deciding whether to buy or sell the Bonds. For purposes of the Securities and Exchange Act of 1934, the Controller will certify, on behalf of the City, that the Preliminary and Final Official Statements are final as of their dates.

The City prepares the Appendix A: "City and County of San Francisco—Organization and Finances" (the "Appendix A") for inclusion in the Official Statement. The Appendix A describes the City's government and organization, the budget, property taxation, other City tax revenues and other revenue sources, general fund programs and expenditures, employment costs and post-retirement obligations, investment of City funds, capital financing and bonds, major economic development projects, constitutional and statutory limitations on taxes and expenditures, and litigation and risk management.

The attached Preliminary Official Statement has been reviewed and approved for transmittal to the Board of Supervisors by staff and the financing team. Members of the Board of Supervisors may review the Preliminary Official Statement and/or question staff and members of the financing team to make sure they feel comfortable that it includes all material facts.

*Continuing Disclosure Certificate:* The City covenants to provide certain financial information and operating data relating to the City (the "Annual Report") not later than 270 days after the end of the fiscal year and to provide notices of the occurrence of certain enumerated events. The Continuing Disclosure Certificate describes the nature of the information to be contained in the Annual Report or the notices of enumerated events. These covenants have been made in order to assist initial purchasers of the Certificates in complying with the Securities and Exchange Commission Rule 15c2-12(b)(5).

If the winning bidder does not (a) confirm to the Co-Financial Advisors by telephone, within ten (10) minutes after notification to it of the City's determination, that the winning bidder will immediately wire the Good Faith Deposit or (b) provide, within ninety (90) minutes after notification to it of the City's determination, the Federal wire reference number for the wire of such Good Faith Deposit to the Co-Financial Advisors, the City may, in its sole discretion, reject the bid of the winning bidder and may award the Bonds to the responsible bidder that timely submitted a conforming bid that represents the next lowest TIC to the City, which will in turn become and will assume the responsibilities of the winning bidder as described in this paragraph.

For the purposes of this paragraph, sales of the Bonds to other securities brokers or dealers will not be considered sales to the general public.

Right of Rejection and Waiver of Irregularity. The City reserves the right, in its sole discretion, to reject any and all bids and to waive any irregularity or informality in any bid which does not materially affect such bid or change the ranking of the bids.

Right to Modify or Amend. In the further opinion of Co-Bond Counsel, under present California law, interest on the Bonds is exempt from State of California personal income taxes. See "TAX MATTERS" in the Preliminary Official Statement.

Copies of the Preliminary Official Statement with respect to the Bonds will be furnished or electronically transmitted to any potential bidder upon request to the Office of Public Finance or to either of the Co-Financial Advisors. In accordance with Rule 15c2-12 of the Securities and Exchange Commission ("**Rule 15c2-12**"), the City deems such Preliminary Official Statement final as of its date, except for the omission of certain information permitted by Rule 15c2-12. I respectfully request that the Board of Supervisors consider for review and recommendation to the Board of Supervisors the issuance of general obligation bonds financing the San Francisco General Hospital & Trauma Center Seismic Retrofit and the Earthquake Safety and Emergency Response program. In connection with this request, legislation approving the sale and issuance of the bonds, supplemental appropriation ordinances to appropriate the bond proceeds, and related supporting documents are expected to be introduced at the Board of Supervisors meeting on Tuesday, May 15, 2012.

**Background:**

*San Francisco General Hospital & Trauma Center*

A two-thirds majority of voters of the City approved Proposition A in November 2008 ("Proposition A"), which authorized the issuance of not to exceed \$887,400,000 in general obligation bonds to build and/or rebuild and improve the earthquake safety of San Francisco General Hospital and Trauma Center (the "General Hospital Project"). The resolution authorizing the sale of City and County of San Francisco general obligation bonds (San Francisco General Hospital and Trauma Center, 2008) authorizes the issuance of not to exceed \$265,185,000 of City and County of San Francisco General Obligation Bonds Series 2012D (San Francisco General Hospital Improvement Bonds, 2008) to finance the purchase, construction, mobilization, project control and other program costs of the General Hospital Project.

Of the \$887,400,000 authorized to be issued by Proposition A, \$131,650,000 was issued in March 2009 and \$294,695,000 was issued in March 2010. The Bonds will be the third series of bonds to be issued under Proposition A for the General Hospital Project.

*Earthquake Safety & Emergency Response Bonds*

A two-thirds majority of voters of the City approved Proposition B in June 2010 (the "Proposition B"), which authorized the issuance of not to exceed \$412,300,000 in general obligation bonds to finance the construction, acquisition, improvement, retrofitting, rehabilitation and completion of earthquake safety and emergency responsiveness facilities and infrastructure (the "Earthquake Safety Projects"). The proposed resolution authorizes the issuance of not to exceed \$40,410,000 of City and County of San Francisco General Obligation Bonds, Series 2012E (Earthquake Safety and Emergency Response Bonds, 2010).

Of the \$412,300,000 authorized to be issued by the Proposition B, \$79,520,000 was issued in December 2010 and \$183,330,000 was issued in March 2012. The Series 2012E Bonds will be the third series of bonds to be issued under Proposition B financing the Earthquake Safety Projects. Proceeds from the 2012E Bonds will finance Auxiliary Water System Supply improvements.

The City anticipates issuing the Series 2012D and Series 2012E Bonds in August 2012. Detailed descriptions of the Projects financed with proceeds of the Bonds are included in the Bond Accountability Reports prepared by the respective departments. The remaining authorization under Proposition A and Proposition B will be issued subject to the consideration and adoption by the Board of Supervisors and approval by the Mayor of subsequent authorizing resolutions.

**Financing Parameters:**

The proposed resolutions authorize the issuance of not to exceed aggregate par amount of \$305,595,000. Based on current project cost estimates and schedules, the Office of Public Finance expects to issue \$291,040,000 under conservative assumptions of market conditions prevailing at the expected time of sale. The additional authorized amount above the expected issuance amount allows for fluctuations in market conditions from the date of authorization by the Board to the time of the sale of the Bonds. The Bonds are anticipated to contribute approximately \$249.38 million to the General Hospital Project and \$38.0 million to the Earthquake Safety Projects. Table 1 outlines anticipated sources and uses for the Bonds.

Based upon a conservative estimate of 6.0% interest rate, OPF estimates that average fiscal year debt service on the Bonds is approximately \$19.73 million. The anticipated total par value of \$291.04 million is estimated to result in approximately \$103.53 million in interest payments over the life of the Bonds. The total principal and interest payment over the approximate 20 year life of the Bonds is approximately \$394.57 million.

In addition, a portion of the Bonds will pay certain expenses incurred in connection with their issuance and delivery and the periodic oversight and review of the projects by the Citizens' General Obligation Bond Oversight Committee ("CGOBOC").

**Financing Timeline:**

The Bonds are expected to be issued and delivered in August 2012. Schedule milestones in connection with the financing may be summarized as follows:

**Debt Limit:**

The City Charter imposes a limit on the amount of general obligation bonds the City can have outstanding at any given time. That limit is 3.00% of the assessed value of property in the City. As of May 1, 2012, there were \$1.65 billion in general obligation bonds outstanding or approximately 1.04% of the net assessed value of property in the City. If all of the City's authorized and unissued bonds were issued, the total debt burden would be 1.72% of the net assessed value of property in the City. If the Board of Supervisors approves the issuance of the Bonds, the debt ratio would increase by 0.19% to 1.24%—within the 3.00% legal debt limit.

**Capital Plan:**

The Capital Planning Committee approved a financial constraint regarding the City's planned use of general obligation bonds such that debt service on approved and issued general obligation bonds would not increase property owners' long-term property tax rates above fiscal year 2006 levels. The fiscal year 2006 property tax rate for the general obligation bond fund was \$0.1201 per \$100 of assessed value.

In fiscal year 2011-12, the property tax rate for the general obligation bond fund is \$0.1147 per \$100 of assessed value. If the Board of Supervisors approves the issuance of the Bonds, the overall property tax rate would be maintained within the Capital Planning Committee's approved financial constraint.

**Additional Information:**

The Resolutions are expected to be introduced at the Board of Supervisors meeting on Tuesday, May 15, 2012. The related financing documents—including the Notice of Intention to Sell, Official Notice of Sale, Official Statement, Appendix A and Continuing Disclosure Certificate and related documents—will also be submitted.

*Official Notice of Sale and Notice of Intention to Sell:* The Notice of Intention to Sell provides legal notice to prospective bidders of the City's intention to sell City and County of San Francisco General Obligation Bonds, consisting of (i) General Obligation Bonds, Series 2012D and (ii) General Obligation Bonds, Series 2012E. Such Notice of Intention to Sell will be published once in "The Bond Buyer" or another financial publication generally circulated throughout the State of California.

The Official Notice of Sale for the Bonds announces the date and time of the competitive bond sale, including the terms relating to the Bonds; the terms of sale, form of bids, and delivery of bids; and closing procedures and documents. Pending market conditions, the Bonds may be bid separately by series or bids may be received for all of the Bonds.

Exhibit A to the Official Notice of Sale is the form of the official bid for the purchase of the Bonds. Pursuant to the Resolutions, the Controller is authorized to award the Bonds to the bidder whose bid represents the lowest true interest cost to the City in accordance with the procedures described in the Official Notice of Sale.

*Official Statement and Appendix A:* The Official Statement provides information for prospective bidders and investors in connection with the public offering by the City of the Bonds. The Official Statement describes the Bonds, including sources and uses of funds; security for the Bonds; risk factors; and tax and other legal matters, among other information. The Official Statement also includes the City's Appendix A, the most recent Comprehensive Annual Financial Report of the City, the City's Investment Policy, and other forms of legal documents for the benefit of investors, holders and owners of the Bonds. A *Preliminary Official Statement* is distributed to prospective bidders prior to the sale of the Bonds and within seven days of the public offering of the Bonds, the *Final Official Statement* (adding certain sale results including the offering prices, interest rates, selling compensation, principal amounts, and aggregate principal amounts) is distributed to the initial purchasers of the Bonds.

The Board of Supervisors and the Mayor, in adopting and approving the Resolution, approve the form of the Official Statement, and authorize the use and distribution of the Official Statement by the co-financial advisors with respect to the Bonds. The Official Statement must include all facts that would be material to an investor in the Bonds. Material information is information that there is a substantial likelihood would have actual significance in the deliberations of the reasonable investor when deciding whether to buy or sell the Bonds. For purposes of the Securities and Exchange Act of 1934, the Controller will certify, on behalf of the City, that the Preliminary and Final Official Statements are final as of their dates.

The City prepares the Appendix A: "City and County of San Francisco—Organization and Finances" (the "Appendix A") for inclusion in the Official Statement. The Appendix A describes the City's government and organization, the budget, property taxation, other City tax revenues and other revenue sources, general fund programs and expenditures, employment costs and post-retirement obligations, investment of City funds, capital financing and bonds, major economic development projects, constitutional and statutory limitations on taxes and expenditures, and litigation and risk management.

The attached Preliminary Official Statement has been reviewed and approved for transmittal to the Board of Supervisors by staff and the financing team. Members of the Board of Supervisors may review the Preliminary Official Statement and/or question staff and members of the financing team to make sure they feel comfortable that it includes all material facts.

*Continuing Disclosure Certificate:* The City covenants to provide certain financial information and operating data relating to the City (the "Annual Report") not later than 270 days after the end of the fiscal year and to provide notices of the occurrence of certain enumerated events. The Continuing Disclosure Certificate describes the nature of the information to be contained in the Annual Report or the notices of enumerated events. These covenants have been made in order to assist initial purchasers of the Certificates in complying with the Securities and Exchange Commission Rule 15c2-12(b)(5).
