3 **Ordinance authorizing settlement of the lawsuit filed by Plaintiffs Vicki Rooker, et al.**

4 **against the City and County of San Francisco for \$114,054.77; the lawsuit was filed on**

5 **March 9, 1999 in United States District Court, Case No. C99-1095; entitled Rooker, et al.,**

6 **v. City and County of San Francisco, et al; other material terms of said settlement are:**

7 **(1) settlement pertains only to plaintiffs' claims that the city improperly computed**

8 **plaintiffs' wages during the time period plaintiffs worked as classification 2532**

9 **paramedics; and (2) settlement proceeds to be broken out as follows: (i) \$62,703.18 in**

10 **back overtime wages; (ii) \$31,351.59 in liquidated damages; and (iii) \$20,000 in**

11 **attorneys' fees.**

13 Be it ordained by the People of the City and County of San Francisco:

14 Section 1. The City Attorney is hereby authorized to partially settle the action entitled

15 "Rooker, et al., v. City and County of San Francisco, et al., United States District Court, Court

16 No. C99-1095" by the payment of \$114,054.77 broken out as follows: (1) \$62,703.18 in back

17 overtime wages; (2) \$31,351.59 in liquidated damages; and (3) \$20,000 in attorneys' fees..
