11 Planning (herein after referred to as OCJP); and

12 WHEREAS, The San Francisco Police Department's Juvenile Division Youth
13 Programs Section will implement a Suppression of Drug Abuse in the Schools Program
14 targeting elementary, middle and high school students who are at risk of exposure to
15 drugs, alcohol and violence; therefore be it

17 RESOLVED, that the Chief of Police of the City and County of San Francisco is
18 authorized on behalf of the City and County of San Francisco to accept and expend
19 continued funding for this project from OCJP, and waiving indirect costs due to funding
20 constraints; be it

22 FURTHER RESOLVED, that the Chief of Police is authorized to execute on
23 behalf of the City and County of San Francisco the necessary Grant Award Agreement
24 for this project including any extensions, funding augmentations from OCJP, or
25 amendments thereof; and be it


