3 **Resolution authorizing the Department of the District Attorney of the City and County**
4 **of San Francisco to retroactively accept and expend a grant in the amount of \$394,891**
5 **from the Department of Justice, Office of Justice Programs, for a program entitled**
6 **“Cold Case Program,” for the period October 1, 2005 to September 30, 2007.**

8 WHEREAS, The City and County of San Francisco desires to establish a certain
9 project designated the Cold Case Program to be funded in part from funds made available
10 from the Department of Justice, Office of Justice Programs (hereafter “DOJ”); now, therefore,
11 be it

12 RESOLVED, That the Board of Supervisors hereby authorizes the District Attorney of
13 the City and County of San Francisco to retroactively accept and expend funds from DOJ for
14 the purposes of its Cold Case Program; and

15 WHEREAS, the grant does not require an ASO amendment; and

16 WHEREAS, The terms of the grant prohibit inclusion of indirect costs in the grant
17 budget; now, therefore, be it

18 RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect costs in
19 the grant budget; and be it

20 FURTHER RESOLVED, That the District Attorney is authorized to execute on behalf of
21 the City and County of San Francisco the necessary Grant Award Agreements for Cold Case
22 Program purposes, including any extensions, augmentations or amendments thereof; and be


24 FURTHER RESOLVED, That the District Attorney is authorized and empowered to
25 execute, deliver and perform, in the name of the City and County of San Francisco, all

1 applications, contracts, agreements, amendments and payment requests necessary for the
2 purpose of securing DOJ grant funds and to implement and carry out the purposes specified
3 in the applicable grant application; and be it


4 FURTHER RESOLVED, That any liability arising out of the performance of the Grant
5 Award Agreement, including civil court actions for damages, shall be the responsibility of the
6 grant recipient and the authorizing agency; and that the grant recipient and the authorizing
7 agency will hold DOJ harmless from any claims that may arise from the use of grant funds;
8 be it

9 FURTHER RESOLVED, That grant funds received hereunder shall not be used to
10 supplant expenditures controlled by this body.
