APPROVE MODIFICATION NO. 6 TO CONTRACT NO. 9254 FOR AIRPORT SHUTTLE BUS SERVICES WITH SFO HOTEL SHUTTLE, INC., TO EXERCISE THE FINAL 2-YEAR OPTION TO EXTEND THE TERM THROUGH JUNE 30, 2022 AND INCREASE THE CONTRACT AMOUNT BY \$27,900,000 FOR A NEW TOTAL CONTRACT AMOUNT NOT TO EXCEED \$123,181,617

- WHEREAS, on October 9, 2012, by Resolution No. 12-0220, the Commission awarded the shuttle bus contract to SFO Shuttle Bus Company for a 3-year, seven-month period beginning December 1, 2012 through June 30, 2016 in an amount not to exceed \$39,000,000, with up to three 2-year options, exercisable at the sole discretion of this Commission; and
- WHEREAS, on November 20, 2012, the Board of Supervisors (BOS) approved Resolution No. 421-12, authorizing the agreement between SFO Shuttle Bus Company and the City and County of San Francisco acting by and through its Airport Commission in an amount not to exceed \$105,000,000 (if all options are exercised) for a term of December 1, 2012 through June 30, 2016, with up to three options for two years each; and
- WHEREAS, on May 15, 2015, the Airport Director approved the Assignment and Assumption through Administrative Modification No. 1, assigning service from SFO Shuttle Bus Company to SFO Hotel Shuttle, Inc.; and
- WHEREAS, on March 15, 2016, by Resolution No. 16-0077, the Commission approved Modification No. 2 to Contract No. 9254 with SFO Hotel Shuttle, Inc. to provide shuttle bus service at San Francisco International Airport, exercising the first of three 2-year options commencing July 1, 2016 through June 30, 2018, in an amount not to exceed \$23,871,617 for the option period, for a new total not-to-exceed contract amount of \$62,871,617; and
- WHEREAS, on March 21, 2017, by Resolution No. 17-0063, the Commission approved Modification No. 3 to Contract No. 9254 with SFO Hotel Shuttle, Inc. to adjust the scope to Contract No. 9254 by including Airfield bus service and increase funding in an amount of \$1,410,000 for a new total contract amount not to exceed \$64,281,617; and
- WHEREAS, on January 16, 2018, by Resolution No. 18-0002, the Commission approved Modification No. 4 to exercise the second of three 2-year options commencing July 1, 2018 through June 30, 2020, in an amount not to exceed \$28,300,000, for a new total not-to-exceed contract amount of \$92,581,617; and
- WHEREAS, on December 18, 2018, by Resolution No. 18-0400, the Commission approved Modification No. 5 to authorize wage rate increases and include new reimbursable costs in an amount of \$2,700,000 and a new total not-to-exceed contract amount of \$95,281,617; and
- WHEREAS, SFO Hotel Shuttle, Inc. has satisfactorily provided all aspects of Airport shuttle bus services, and the contract is set to expire on June 30, 2020; and
- WHEREAS, a modification to exercise the final 2-year option to extend the agreement is required to retain Airport shuttle bus services with SFO Hotel Shuttle, Inc.; now, therefore, be it
- RESOLVED, that this Commission hereby approves Modification No. 6 to Contract No. 9254 for Airport shuttle bus services with SFO Hotel Shuttle, Inc. and exercise the final 2-year option to extend the term through June 30, 2022 and to increase the Contract amount by \$27,900,000 for a new Contract amount not to exceed \$123,181,617; and, be it further
- RESOLVED, that the Airport Director is authorized to take the necessary steps to obtain BOS approval of Modification No. 6 to Contract No. 9254 pursuant to San Francisco Charter Section 9.118(b).

DIRECTOR'S RECOMMENDATION: APPROVE MODIFICATION NO. 6 TO CONTRACT NO. 9254, AIRPORT SHUTTLE BUS SERVICES WITH SFO HOTEL SHUTTLE, INC., TO EXERCISE THE FINAL 2-YEAR OPTION TO EXTEND THE TERM THROUGH JUNE 30, 2022 AND INCREASE THE CONTRACT AMOUNT BY \$27,900,000 FOR A NEW TOTAL CONTRACT AMOUNT NOT TO EXCEED \$123,181,617.

# **Executive Summary**

Through Contract No. 9254, SFO Hotel Shuttle, Inc. provides free shuttle bus service at San Francisco International Airport (Airport or SFO). This service includes busing to Long Term and Employee Parking Garages/Lots, busing to remote locations for Airfield operations, as-needed emergency busing services during AirTrain outages, and a new route to and from Oyster Point Ferry Terminal. The existing contract with SFO Hotel Shuttle, Inc. will expire on June 30, 2020. Staff seeks Commission approval to exercise the final 2-year option to extend the term through June 30, 2022.

### Background

On October 9, 2012, by Resolution No. 12-0220, the Commission awarded Contract No. 9254 to SFO Shuttle Bus Company (now known as SFO Hotel Shuttle) to provide shuttle bus services at SFO for a period of three-years and seven-months with three 2-year options to extend, for a total possible term of 9-years and 6-months. The total not-to-exceed Board of Supervisors (BOS) contract amount, including all extensions, was \$105,000,000. The contract has been modified five times, as detailed in Attachment A – Summary of Commission Actions to date for this contract.

The AirTrain extension to the long-term parking garage, initially scheduled for completion in March 2020, is now scheduled for completion in December 2020. Upon completion, Staff will evaluate busing services and recommend reduction in the scope of shuttle services to the new long-term parking garage. Assuming the AirTrain extension is complete by the end of December 2020, then we expect to see a reduction in spending on this contract by approximately \$500,000 each month.

In July 2019, the Airport added a route to Oyster Point, allowing badged personnel and customers from the East Bay to commute via ferry, and then get a free ride to the Airport. The Airport provides three scheduled rides in the morning and another three in the evening. While a small group of badged employees – and an even smaller number of customers – use this service, Staff is considering whether the service is sustainable, given the low numbers. Should Staff conclude that the Oyster Point service is underused, that service will be terminated, which will reduce the overall cost of this contract extension by \$150,000.

The initial not-to-exceed amount for this contract, including extensions, was \$105,000,000. In the intervening years, changes in scope to accommodate Airport construction projects resulted in accelerated expenditures. With this Modification No. 6, increasing the contract amount by \$27,900,000, the revised total not-to-exceed contract amount is \$123,181,617. The contract will expire on June 30, 2022. Consistent with San Francisco Charter Section 9.118(b), the Airport will also seek approval for this modification from the BOS.

## Recommendation

I recommend the Commission approve Modification No. 6 to Contract No. 9254, Airport shuttle bus services with SFO Hotel Shuttle, Inc., to exercise the final 2-year option to extend the term through June 30, 2022 and to increase the contract amount by \$27,900,000, for a new total contract amount not to exceed \$123,181,617.
