ORDINANCE NO. 2-08

[Banning alcohol in parks with playgrounds children's play areas.]

**Ordinance amending Section 4.10 of the Park Code to ban consumption of alcohol in any park that contains a children's playground or play structure areas.**

Be it ordained by the People of the City and County of San Francisco:

Section 1. The San Francisco Park Code is hereby amended by amending Section 4.10, to read as follows:

**SEC. 4.10 ALCOHOLIC BEVERAGES.**

(a) Except as provided in Subsection 4.10(b), No person shall consume alcoholic beverages of any kind in any building, children's playground areas, swimming pool, restroom, park that contains a children's playground or play structure, or any of the following parks or portions of parks: ~~as follows, except with the permission of the Recreation and Park Department.~~



5 (b) The General Manager of the Recreation and Park Department or the Recreation  
6 and Park Commission may grant permission to consume alcohol in the parks and portions of  
7 parks where such activity is prohibited by Subsection (a), above, if the General Manager or  
8 the Commission determines that the consumption of alcohol will not interfere with the public's  
9 use and enjoyment of the park. However, neither the General Manager nor the Commission  
10 may grant permission to consume alcohol in children's play areas.
