18 24013, and recommends that the Department of Alcoholic Beverage Control issue the
19 liquor license; now, therefore, be it

21 **Section 23958.4, the Board of Supervisors of the City and County of San Francisco**
22 **hereby determines that the issuance of a Type 42 on-sale beer and wine license to**

24 **Street, will serve the public convenience or necessity of the City and County of San**
