3 **Resolution enacting temporary "Street Closed to Vehicular Traffic" regulation on**
4 **Steiner Street between Lombard and Chestnut Streets from 10:00 a.m. to 5:15 p.m. on**
5 **every Tuesday between July 17, 2007 through October 30, 2007.**

8 WHEREAS, Farmers' markets provide the opportunity for residents to purchase fresh
9 produce and other items from local farmers; and

10 WHEREAS, Farmers' markets create opportunities for residents to gather together and
11 help enhance a sense of community within a neighborhood; and,

12 WHEREAS, Increasing walking traffic in neighborhood commercial districts tends to
13 enhance the overall economic vitality of the district; and,

14 WHEREAS, ON APRIL 26, 2007, ISCOTT referred this matter to the Board of
15 Supervisors for approval of temporary street closure; and,

16 WHEREAS, On May 24, 2007, a hearing on the best location for the Marina Farmers'
17 Market was held in the City Operations and Neighborhood Services committee, wherein
18 overwhelming support for a Farmers' Market on Tuesdays on Steiner Street was shown
19 through public comment: and now, therefore, be it

20 RESOLVED, That in accordance with the provisions of the California Vehicle Code and
21 the San Francisco Traffic Code, the following regulation governing the movement of vehicles
22 is hereby enacted as designated below

23 Temporary Street Closed to Vehicular Traffic, 10:00 a.m. to 5:15 p.m., every Tuesday
24 between July 17, 2007 through October 30, 2007, Establish Steiner Street between Lombard
25 and Chestnut Streets; and, be it

1 FURTHER RESOLVED, That the California Farmers' Market Association shall take all
2 actions necessary to address ingress and egress issues pertaining to residents and delivery
3 trucks during the Marina Farmers' Market; and, be it

4 FURTHER RESOLVED, That the California Farmers' Market Association shall set up
5 the market so that the street is free and open from 3333 Steiner Street to Lombard Street to
6 allow ingress and egress for the residents of 3333 Steiner Street.


