3 **Resolution determining that the person-to-person, premises-to-premises transfer**  
4 **of a Type-21 off-sale general beer, wine, and distilled spirits liquor license to**  
5 **Coolwater SF, LLC, doing business as Slake San Francisco Bottle and Sundry,**  
6 **located at 3239 Balboa Street (District 1), will serve the public convenience or**  
7 **necessity of the City and County of San Francisco, in accordance with California**  
8 **Business and Professions Code, Section 23958.4; and requesting that the**  
9 **California Department of Alcoholic Beverage Control impose conditions on the**  
10 **issuance of the license.**

12 WHEREAS, Coolwater SF, LLC, is seeking the person-to-person, premises-to-  
13 premises transfer of a Type-21 off-sale general beer, wine, and distilled spirits liquor  
14 license to do business as Slake San Francisco Bottle and Sundry, located at 3239  
15 Balboa Street (District 1); and

16 WHEREAS, The Planning Department has verified that the area is properly  
17 zoned and recommends approval; and

18 WHEREAS, The Police Department has filed zero protests and zero letters of  
19 support with the Department of Alcoholic Beverage Control under California Business  
20 and Professions Code, Section 24013, and recommends that the Department of  
21 Alcoholic Beverage Control issue the liquor license with no additional conditions; now,  
22 therefore, be it

23 RESOLVED, That in accordance with California Business and Professions Code,  
24 Section 23958.4, the Board of Supervisors of the City and County of San Francisco  
25 hereby determines that the person-to-person, premises-to-premises transfer of a Type-

1 21 off-sale general beer, wine, and distilled spirits liquor license to Coolwater SF, LLC,  
2 doing business as Slake San Francisco Bottle and Sundry, located at 3239 Balboa  
3 Street, will serve the public convenience or necessity of the City and County of San  
4 Francisco.
