Dear Ms. Cavillo:

This office represents Club OMG!, LLC dba Club OMG!. My clients have applied to the California Department of Alcoholic Beverage Control (ABC) to transfer an On-Sale General Public Premises licenses [Type 48] to their premises at 43-6th Street, San Francisco. This location formerly housed the bar, Anu, since approximately 2003. A partner in Anu died and the previous Type-48 ABC license on these premises is now tied up in litigation. We are informed that this address has housed a bar for at least 40 years.

My client wishes to open a new bar and lounge business in this location, catering to young technology professionals with a special emphasis on the South Asian communities in San Francisco. The surrounding Mid-Market area of San Francisco is attracting a number of larger technology companies due to attractive rents and tax credits.

Anu held a Place of Entertainment license at this location which allowed them to provide live and DJ music to their patrons until 2 am. Club OMG! intends to apply to the SF Entertainment Commission for a similar license. This location has been non-problematic and my client also intends to a business that is respectful to the neighborhood and to its customers.

As part of its commitment to ensure that its operation in this new business does not disturb its neighbors, Club OMG! will add additional sound mitigation measures to the building, on top of the extensive sound proofing work done by the previous owners. This location has been given a sound test in 2005 by the Entertainment Commission sound inspector, and easily passed. That sound test showed **no** sound bleed into any adjoining business or residence. Club OMG! will also use a sound limiter to further ensure that its music will not disturb the neighboring residences.

The managing partners, Rakesh Modi and Paresh Shah have been in the bar and restaurant business for over twenty years and are skilled operators. Presently Mr. Shah owns a bar and lounge in Danville, CA. The partners are committed to providing an excellent experience for their patrons and will strive to make the Sixth Street area safer and crime free. Foremost, they will be Good Neighbors.

This project marks another milestone in the revitalization of the 6th and Market Street neighborhood. Historically, this stretch of Market Street has been the center of the entertainment/theater district of San Francisco. Sixty years ago this neighborhood was the greatest theater district outside of New York City: The Loew's Warfield, The Paramount, The Empire, The Orpheum, The Golden Gate, The Jewel, Grauman's Imperial and dozens of other theaters lined this strip. A few blocks up Market Street, the five-thousand seat Fox Theater occupied the entire block at Hayes and Market. The Fox was considered by many to be the finest movie palace ever built.

Besides movie palaces, this neighborhood was the home of many speakeasies and jazz clubs. The Americrat Club—on Market near Sixth Street was a famous gay speakeasy and the Dawn Club in the basement of the Monadnock Building was home to jazz greats such as Lu Watters, Wally Rose and Turk Murphey.

Club OMG! will cater to the diverse residents of the Soma neighborhood, and will bring in both professionals and tourists to Sixth Street. It is also dedicated to providing an excellent nightlife experience and to participating in the improvement of its community. Along with providing employment to 10 hard-working and responsible individuals, Club OMG! will provide a platform for non-profit organizations to network and fundraise. We will provide our venue for meetings and gatherings of the SOMA Community Safety Group, Safe Haven Program for the Tenderloin, and South of Market Business Association. Supporting these groups—and many other non-profits—is part of the standard of excellence Club OMG! promotes and embodies.

The approval by the Board of Supervisors of this ABC license would not have any detrimental effect on the surrounding neighborhood or the City of San Francisco. The clientele of this operation fit well into the existing neighborhood and will pose no public safety problems. This new business venture will also provide additional job opportunities to the community.

PETITIONER(S), Have filed an application for the issuance of the above-referenced-to licenses for the above-mentioned premises; and,

WHEREAS, the San Francisco Police Department has provided the Department with substantial evidence of an identifiable problem which exists at the premises or in its immediate vicinity; and,

WHEREAS, transfer of the existing unrestricted license would be contrary to public welfare and morals; and,

WHEREAS, pursuant to Business and Professions Code Section 23800(e) the Department may grant a license transfer where the transfer with conditions will mitigate problems identified by the local governing body or its designee; and,

WHEREAS, petitioners stipulate that by reason of the existence of substantial evidence of identifiable problems at the premises or its immediate vicinity, grounds exist for denial of said license transfer;

NOW THEREFORE, the undersigned petitioner does hereby petition for a conditional license as follows, to-wit:

1. The sales, service and consumption of alcoholic beverages shall be permitted only between the hours of 12:00 noon and 2:00 a.m. each day of the week.
2. There shall be no coin-operated games or video machines maintained upon the premises at any time.
3. No noise shall be audible beyond the area under control of the licensee.
4. No person under the age of twenty-one (21) years of age shall sell, furnish or deliver alcoholic beverages.
5. The sales, service and consumption of alcoholic beverages shall remain within the confines of the area depicted on the ABC 257, dated 12/20/11.
6. The sale of alcoholic beverages for consumption off the premises is strictly prohibited.
7. Petitioner shall not permit its patrons or the general public to loiter or congregate on the sidewalks adjacent to the licensed premises. The orderly standing of patrons in line to enter the premises shall not be considered loitering or unlawfully congregating.
8. The petitioner shall be responsible for maintaining free of litter the area adjacent to the premises over which they have control.
9. Graffiti shall be removed from the premises and all parking lots within 72 hours of application. If the graffiti occurs on a Friday or weekend day, or on a holiday, the licensee shall remove the graffiti within 72 hours following the beginning of the next weekday.
10. Petitioner shall not make structural changes in the premises interior without prior written approval from the Department.
11. The interior lighting maintained therein shall be sufficient to make easily discernable the appearance and conduct of all persons and patrons in that portion of the premises where alcoholic beverages are sold, served, delivered or consumed.

13. At no time shall any person under the age of 21 years enter or remain in this public premises.
14. Petitioner shall install and maintain a state-of-the-art video surveillance system at the premises and shall make recordings from this system available to any law enforcement agency upon request. Petitioner shall maintain such recordings for a minimum of 14 days, and shall install cameras in front of the premises with coverage of the entire front of the premises.
15. Petitioner shall provide adequate security at the premises, taking into consideration the neighborhood where the premises are located . These security personnel shall be readily identifiable with the word "Security" printed on their jackets or uniforms.

This petition for conditional license is made pursuant to the provisions of Sections 23800 through 23805 of the Business and Professions Code and will be carried forward in any transfer at the applicant-premises.

Petitioner agrees to retain a copy of this petition on the premises at all times and will be prepared to produce it immediately upon the request of any peace officer.

The petitioner understands that any violation of the foregoing conditions shall be grounds for the suspension or revocation of the license.

Mark Rennie, on behalf of Club OMG! LLC, has filed an application with the California Department of Alcoholic Beverage Control seeking an Type 48 (On-Sale General) bar license for 43-6th Street (located between Stevenson Street and Jessie Street).

For the purposes of this hearing, the California Department of Alcoholic Beverage Control (ABC) seeks a determination from the Board of Supervisors as to the approval or denial of this license.

The completed investigation for this application was presented on April 23, 2012. The application for this license, 43-6th Street, is located in the highest reported crime area in the City and County of San Francisco. In addition, the number of active On-Sale licenses for this area is double the number authorized by the ABC.

ALU has recommended **Denial** of this ABC liquor license application.

At your request the Department has created a list of conditions in the event the committee decides to approve this application. If the committee approves this license, the Police Department respectfully requests the following conditions.

1. The sales, service and consumption of alcoholic beverages shall be permitted only between the hours of 12:00 pm (noon) and 2:00 am each day of the week.
2. The sale of alcoholic beverages for consumption off the premises is strictly prohibited.
3. No noise shall be audible beyond the area under the control of the licensee(s) as defined on the ABC-257.
4. Loitering (loitering is defined as "to stand idly about; linger aimlessly without lawful business") is prohibited on any sidewalks or property adjacent to the licensed premises under control of the licensee.
5. Between the hours of 9:00 p.m. and to until one half (1/2) hour past closing the petitioner(s) shall provide security personnel who shall maintain order therein and prevent any activity which would interfere with the quiet enjoyment of their property by nearby residents. Security personnel shall be readily identifiable as security.



Mark Rennie, on behalf of Club OMG! LLC, has filed an application with the California Department of Alcoholic Beverage Control seeking an Type 48 (On-Sale General) bar license for 43-6th Street (located between Stevenson Street and Jessie Street).

It should be noted that during the application process, notification date for the 500' mailer was on January 5, 2012. The Notice to the Public was posted on December 22, 2011. There are no record of letters of protest and no record of letters of support, received by the California Department of Alcoholic Beverage Control.

For the purposes of this hearing, the California Department of Alcoholic Beverage Control (ABC) seeks a determination from the Board of Supervisors as to the approval or denial of this license.

Police Calls for Service: From December 2010 to December 2011

3 calls, note this business has been closed since March 2011.

Police Reports: From December 2010 to December 2011

No Record

San Francisco Plot Information:

This premise is located in Plot 210

High Crime area is defined as 215 or more police reports in a plot.

This plot had 3,255 police reports recorded for 2010. This is approximately 15 times the High Crime area definition.

Applicant premise is located in a "high crime" area.

State Census Tract Information:

This premise is located in Census Tract 176.01

Population for this tract is: 5,756

On-sale license authorized for this census tract: 21

Active on-sale licenses in this census tract: 54

Off-sale licenses authorized for this census tract: 6

Applicant premise is located in an "undue concentration" area.

No Record with the California Department of Alcoholic Beverage Control, (ABC).

Since March 30, 2012, the San Francisco Police Department has documented approximately eleven (11) letters of support.

Departmental Recommendation:

This Police plot is the highest "High Crime" area in San Francisco, with over two dozen incidents directly related to alcohol and over 300 incidents related to narcotics in 2010. It is well known that licensed establishments have the ability to attract activity by drug buyers and sellers.

A 2011 Police Department operations order describes the 6th Street corridor as being, "plagued by high levels of narcotics activity. This activity attracts individuals who are responsible for a high percentage of the violent crimes which occurs in the Southern District, including assaults, robberies, stabbings and shootings."

As a result of this Department operations order, extra police resources including the Violent Crime Task Force and Tactical Units were detailed to the 6th Street Corridor during the months of July and August of 2011.

Single Resident Occupancy (SRO) hotels in this area are sponsored by the City through Public Health, who work with their clients to break their chemical dependencies and addictions. Adding a new licensed establishment contributes to the problem and appears to work against the City's efforts.

Specifically related to this premises is the 14 unit residential, Single Resident Occupancy hotel (SRO). This SRO, the Oak Tree Hotel, is located adjacent to and above the applicant premises at 45-6th Street. The entrance to this hotel is less than 1 foot from the entrance to the applicant premises, 43-6th Street. To illustrate high volume of police calls, there have been 34 calls for service to the Oak Tree Hotel in 2011.

The City and the community have worked tirelessly to add a Police Substation on 6th Street to bring a more permanent presence of officers. A new licensed premises will contribute to a greater number of intoxicated people which translates to a greater number of victims and suspects.

In conclusion, The San Francisco Police Department has gone to great lengths to combat violent crime on 6th Street. In recent years, thousands of personnel hours by Southern Station, the Violent Crime Task Force, Narcotics Detail, Gang Task Force, the Tactical Company and various other units have worked to keep this block safe for residents and merchants.

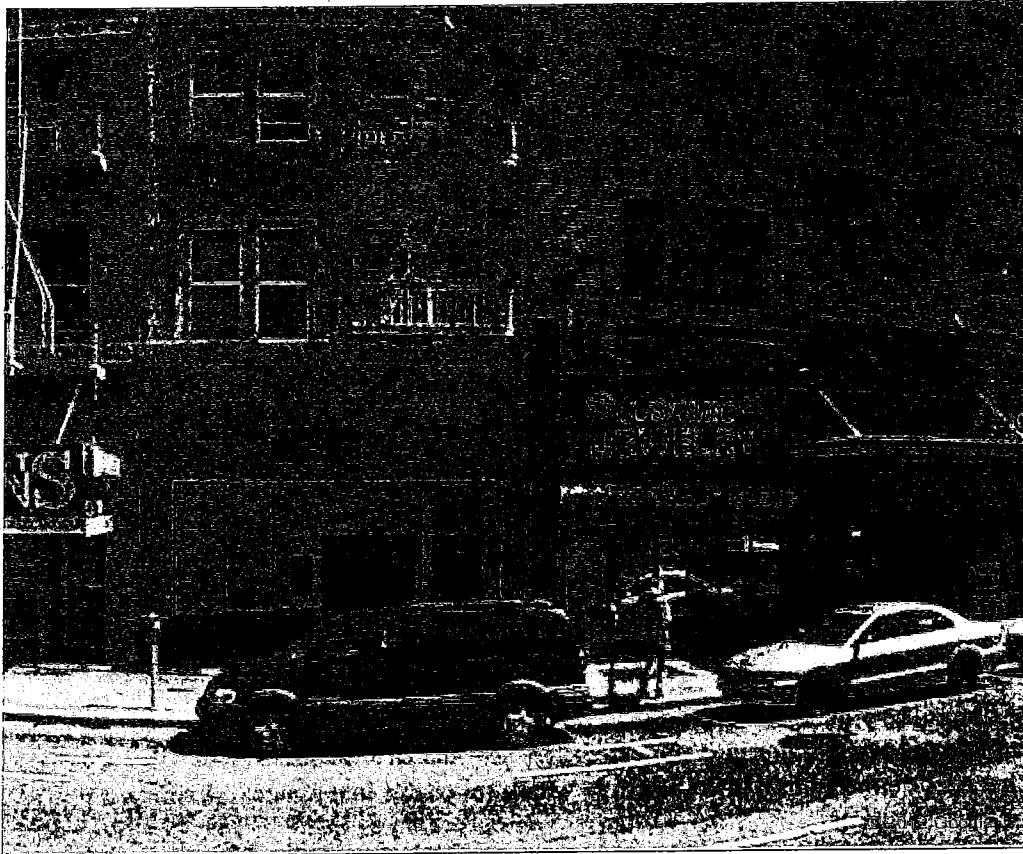
In the recent granting of ABC licenses in this area, which were strictly conditioned, still result in crime and high volumes of calls for service. Granting this license will not only contribute to the crime problem in this community, but it will go directly against the intent of laws, promoted by the ABC, in order to maintain safe communities for our residents, merchants and visitors to our City.

This application is **opposed** by **Southern Station**.

ALU recommends **Denial** of this ABC liquor license.

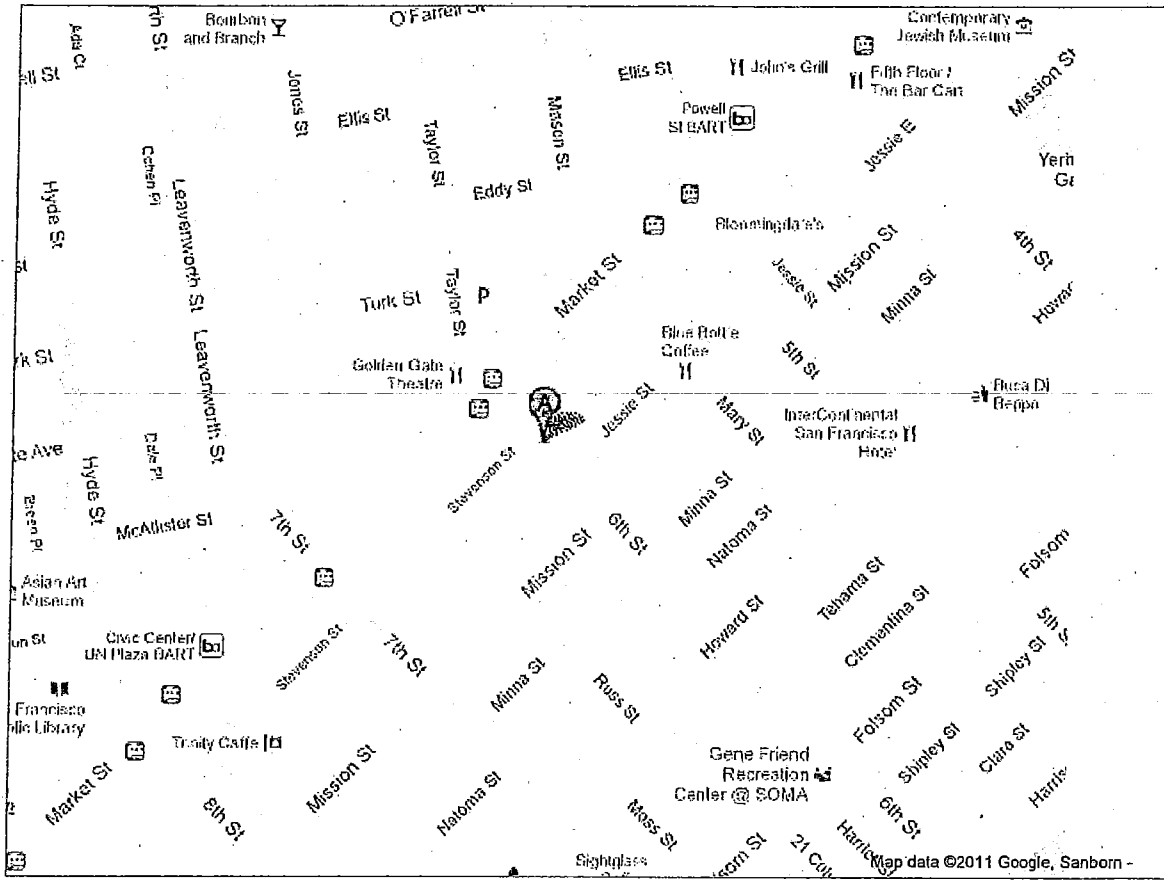

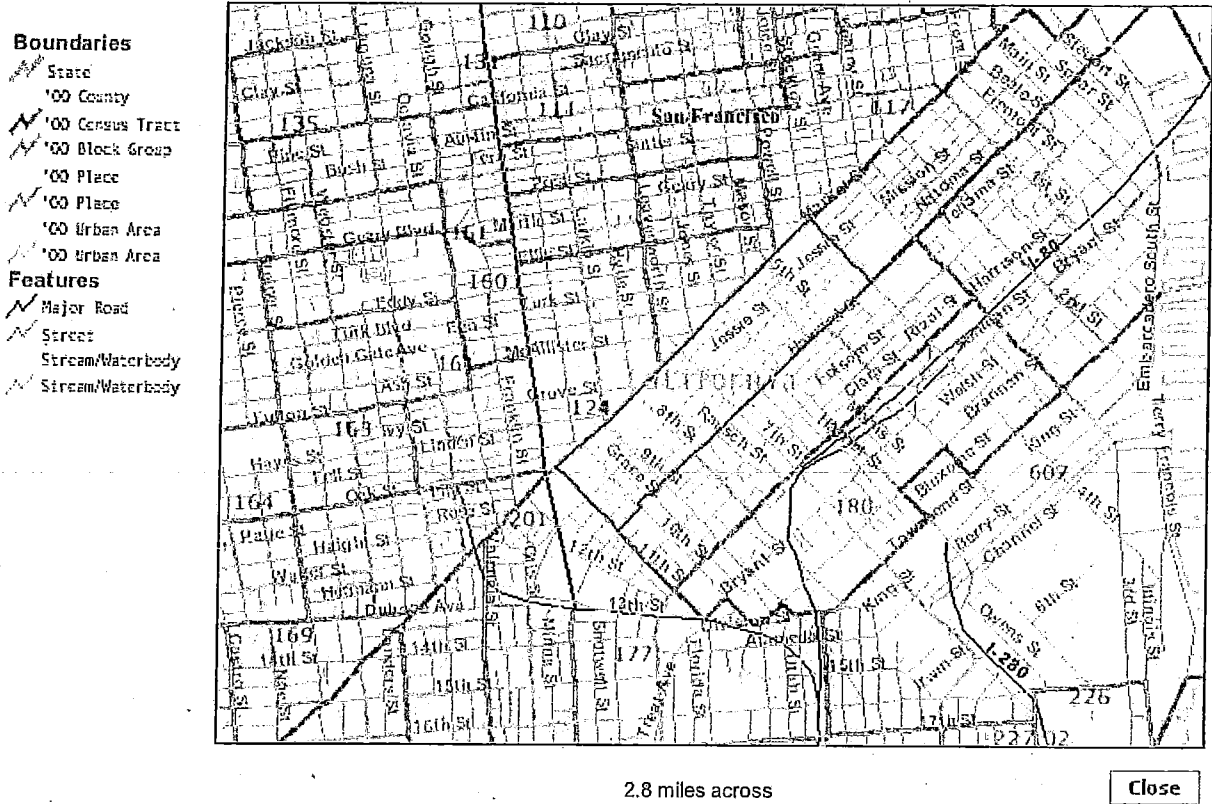


NORTHERN DISTRICT Plotting Plots & Major Streets

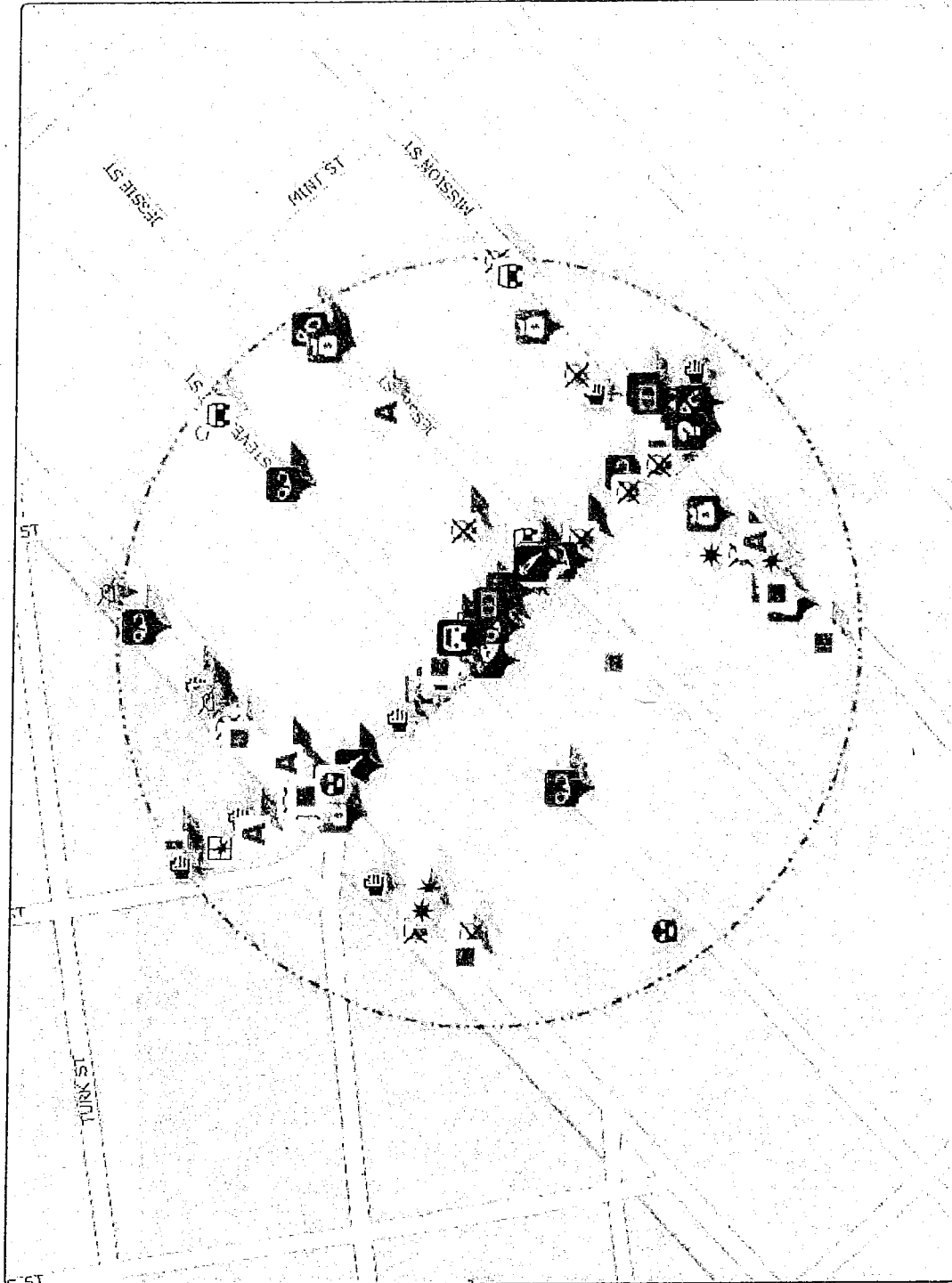

The bar would be close to BART and other public transit options, which many South Asians utilize for commute from their IT and financial sector jobs in downtown and SOMA. It has a great potential to become a successful "destination bar," to enjoy the South Asian bar scene. The success of such a bar could help improve the safety and livability of the surrounding area and generate jobs and revenue for the city.

Rakesh and Paresh are both highly respected individuals in the South Asian community in the bay area. Rakesh's contributions to our community was recently honored by the City with a Certificate of Honor from the Mayors Office.


There isn't a South Asian bar around us and I feel there should be one, so that we can celebrate that great culture and a good after work place to hangout and unwind.
