Project Management Support Services
for the Airfield Improvement Program, 2024-2029 Phase**

THIS **MODIFICATION NO. 3** ("Modification") is made as of _____, in San Francisco, California, by and between **AtkinsRéalis USA Inc.** ("Contractor") and the City and County of San Francisco, a municipal corporation ("City"), acting by and through its Airport Commission ("Department" or "Commission").

Recitals

A. City and Contractor have entered into the Agreement for Project Management Support Services for the Airfield Improvement Program, 2024-2029 Phase for the San Francisco International Airport ("Airport"); and

B. The Commission is authorized to enter into all contracts which relate to matters under its jurisdiction; and

C. On January 21, 2025, by Resolution No. 25-0004, the Commission awarded the Agreement to Contractor in the not-to-exceed amount of \$8,600,000 with a duration of four (4) years; and

D. On October 1, 2025, City and Contractor administratively modified the Agreement through Modification No. 1 to update the direct labor rate range for the Project Controls Manager classification and update standard contractual clauses; and

E. On May 1, 2026, City and Contractor administratively modified the Agreement through Modification No. 2 to update a subcontractor's home office overhead rate and update standard contractual clauses; and

F. City and Contractor desire to modify the Agreement on the terms and conditions set forth herein to increase the contract amount with no change to the contract duration; and

G. On June 2, 2026, by Resolution No. 26-0131, the Commission approved this Modification, increasing the contract not-to-exceed amount by \$8,400,000 with no change to the contract duration; and

H. On _____, by Resolution No. _____, the City's Board of Supervisors approved this Modification in the not-to-exceed amount of \$17,000,000 with a duration of four (4) years; and

I. The Commission will file Ethics Form 126f4 (Notification of Contract Approval) within five days of execution of this Modification because the Agreement has a value of \$100,000 or more in a fiscal year and will require the approval of the Board of Supervisors; and

J. Approval for the Agreement was obtained when the Civil Service Commission approved PSC No. DHRPSC0004625 on January 6, 2025.

NOW, THEREFORE, the parties agree as follows:

Article 1 Preface

The following definitions shall apply to this Modification:

1.1 **Agreement.** The term "Agreement" shall mean the Agreement dated January 21, 2025, between Contractor and City, as modified by:

Modification No. 1, dated October 1, 2025, and
Modification No. 2, dated May 1, 2026.

1.2 **Other Terms.** Terms used and not defined in this Modification shall have the meanings assigned to such terms in the Agreement.

Article 2 Modifications of Scope to the Agreement

The Agreement is hereby modified as follows:

2.1 **Section 3.3.1 Calculation of Charges and Contract Not-to-Exceed Amount** is amended to increase the total maximum compensation payable by **Eight Million Four Hundred Thousand Dollars (\$8,400,000)** for a new total not-to-exceed amount of **Seventeen Million Dollars (\$17,000,000)**.

Article 3 Updates of Standard Terms to the Agreement

There are no updates to the standard terms to the Agreement.

Article 4 Effective Date

Each of the modifications set forth in this Modification shall be effective on and after the date of this Modification.

Article 5 Legal Effect

Except as expressly modified by this Modification, all of the terms and conditions of the Agreement shall remain unchanged and in full force and effect.
