2 COMMENDING CARMEN CLARK, DEPARTING EXECUTIVE DIRECTOR OF THE SAN
3 FRANCISCO COUNTY TRANSPORTATION AUTHORITY

5 WHEREAS, In May, 1993, Carmen Clark became the first Director of Plans and
6 Programs for the San Francisco County Transportation Authority; and,

7 WHEREAS, Carmen Clark, as Director of Plans and Programs, assisted in planning
8 and programming of Proposition B funds; and,

9 WHEREAS, Carmen Clark helped develop policies for the Transportation Authority and
10 provided input for City, County and State legislation promoting Transportation Authority
11 projects; and

12 WHEREAS, Carmen Clark helped develop community relations in all aspects of
13 transportation improvements in San Francisco; and

14 WHEREAS, During the eight years that Carmen Clark served as the Director of Plans
15 and Programs, she oversaw the development of the various City Departments' five-year
16 plans; and

17 WHEREAS, In April 1997, Carmen Clark was appointed the Interim Executive Director
18 of the Transportation Authority, during which time she assumed the responsibilities of the
19 Executive Director for overall responsibilities for the day-to-day operation of the Agency; and

20 WHEREAS, In June, 1997, Carmen Clark was appointed the Executive Director of the
21 San Francisco Transportation Authority; and

22 WHEREAS, In December, 1998, the Mayor Willie Brown appointed Carmen Clark as
23 the Temporary Executive Manager of the PTD/MUNI, for a three-month period, while the
24 PTD/MUNI searched for a new Executive Manager, and

2 WHEREAS, In May, 2000, Carmen Clark resigned as Executive Director after three
3 successful years in steering the Transportation Authority into the last ten years of its life; and

4 WHEREAS, Carmen Clark will be sorely missed at the San Francisco County
5 Transportation Authority; now, therefore, be it

6 RESOLVED, That the Board of Supervisors of the City and County of San Francisco
7 commends and thanks Carmen Clark for her seven years of dedicated services to the
8 Transportation Authority and the people of San Francisco County.


