3 **Resolution authorizing the Department of Public Health, Population Health and**  
4 **Prevention, Community Substance Abuse Services, to accept retroactively and**  
5 **expend first year grant funds of \$800,000 from the Substance Abuse and**  
6 **Mental Health Services Administration (SAMHSA) and the Center for Substance**  
7 **Abuse Treatment (CSAT) to expand the number of residential beds available to**  
8 **pregnant and postpartum women and to enter into an agreement which**  
9 **includes a rights in data clause for the use of these funds; providing for**  
10 **ratification of action previously taken.**

12 WHEREAS, The Department of Public Health has applied for and been  
13 awarded a three year grant from SAMHSA/CSAT in the amount of \$800,000 for the  
14 first year of a mobile methadone program; and,

15  
16 WHEREAS, As a condition of receiving the grant funds, SAMHSA/CSAT  
17 requires the SFDPH to enter into an agreement (the "Agreement"), a copy of which is  
18 on file with the Clerk of the Board of Supervisors in File No. 002216, which is  
19 hereby declared to be a part of this resolution as if set forth fully herein; and,

21 WHEREAS, The Agreement contains a certain provision described below,  
22 which requires the approval of the Board of Supervisors; and,

23 WHEREAS, The grant budget includes provision for indirect costs of \$2,125;  
24 now, therefore, be it

3 Administrative Code section 10.170-1; and, be it


4 FURTHER RESOLVED, That the Director of Health is authorized to enter into

8 nonexclusive, and irrevocable license for the use of data developed under the  
9 contract; and, be it

10 FURTHER RESOLVED, That the Board of Supervisors authorizes the Director  
11 of Health to enter into similar agreements with SAMHSA/CSAT if the grant recurs or  
12 is renewed; and, be it


13 FURTHER RESOLVED, That the Controller <sup>is directed</sup> ~~should be urged~~ to designate the  
14 position created under the grant as a "G" or grant-funded position, which would  
15 terminate when the grant expires.




