7 MOVED, That the Board of Supervisors of the City and County of San Francisco does
8 hereby appoint the hereinafter designated persons to serve as members of the Medical
9 Cannabis Task Force, pursuant to the provisions of the San Francisco Administrative Code,
10 Sections 5.2-1 through 5.2-6, for the terms specified:

11 Hunter Holliman, seat 2, succeeding David Goldman, resigned, must be a
12 representative of a local patient advocacy organization with a background in working to
13 protect the interests of medical cannabis patients, for a term ending December 31, 2012.

14 Leonard Watkins, seat 4 (residency requirement waived), succeeding Mary Schroeder,
15 resigned, must be a representative of a hospice or a residential care facility with a background
16 as an employee or volunteer in direct services working with medical cannabis patients or as a
17 nurse or physician with a background in working with or treating of medical cannabis patients,
18 for a term ending December 31, 2012.

19 Martin Olive, seat 6, succeeding Martin Olive, term expired, must be a person with a
20 background in the management of a medical cannabis dispensary, for a term ending
21 December 31, 2012.

22 Sarah Shrader, seat 8, succeeding Sarah Shrader, term expired, must be a
23 representative of a drug policy organization working specifically on medical cannabis issues,
24 for a term ending December 31, 2012.

25

1 Brent Saupe, seat 10, succeeding Albert Blais, resigned, must be a person with a
2 background in providing medical cannabis to low-income patients, for a term ending
3 December 31, 2012.

4 Jean Talleyrand, seat 15, new appointment, must be a licensed or an accredited health
5 care practitioner practicing in San Francisco with a background in medical cannabis and
6 familiarity with the laws and regulations governing medical cannabis, for a term ending
7 December 31, 2012.

8 FURTHER MOVED, That the Board of Supervisors makes the following findings:

- 9 1. The membership of the Medical Cannabis Task Force has a goal to be
10 representative of the diversity of the City and County of San Francisco.
- 11 2. Applicant Leonard Watkins, a new appointee, who is not a resident of San
12 Francisco, is a person with experience that uniquely qualifies him to serve on the
13 Medical Cannabis Task Force.
- 14 3. The Medical Cannabis Task Force has attempted to fill the position, for which
15 Leonard Watkins was nominated, with an individual who is a City resident and who
16 has the specific experience, skills, and qualifications, but has been unable to do so
17 at this time. The Rules Committee has certified that Leonard Watkins is qualified to
18 serve on the Medical Cannabis Task Force.
- 19 4. After exercising due diligence, the Board of Supervisors concludes that there is no
20 other possible representative, who is a resident of San Francisco and who has the
21 specific experience, skills, or qualifications possessed by this applicant, and who is
22 willing to serve on the Medical Cannabis Task Force at this time; and, be it

24 for Leonard Watkins, as allowed in cases where no qualified City resident, willing to serve,

Brent O. Saupe

Brent is a coordinator for Collective Care Gardening Club, teaching others to grow their own medicine, introducing patients to gardeners, and helping to facilitate compliant, sustainable collective gardens as well as being part of a local collective garden operating in SOMA SF.

Born and raised in Southern California, Brent Saupe has been involved with marijuana throughout his life. Experiencing his first law enforcement encounter concerning indoor gardening at the age of twelve. Twelve years later he was busted again. Right here in San Francisco, and yes it was for cannabis. He has visited 18 countries and 48 states and boasts of sampling locally produced cannabis in each. A United States Marine Corps veteran, Brent is convinced cannabis can unify people and create peace around the world like nothing else, and advocates its appropriate use wherever he goes.

Finding no better place on earth than San Francisco, Brent has been living here since 1992.

After four years of Bible school and inner city church development work (mission district and the T.L.) and working in the residential drug rehabilitation arena, Brent created a cult survivor website and support network for people leaving abusive groups. During the next four years, in addition to facilitating the support group network, Brent was a board member of Glad Tidings Church in the Fillmore district of San Francisco and still calls G.T. his home church. Brents current mission is working with "Hell? No! Ministries" focusing on confronting misinformation concerning medical cannabis.

Being an advocate for patients rights, Brent became involved in Americans For Safe Access in 2002. He has traveled around the state giving ASA legal trainings, and has worked as a peer councilor in dispensaries around the Bay Area answering patients legal questions concerning medical cannabis.

A dedicated group of local volunteer activists created the local chapter of ASA SF and Brent became one of them. Facilitating meetings, coordinating volunteers, creating fund raising opportunities, emergency response planning, rallying patients for dispensary/court support, whatever ASA SF needs, Brent has worked with local patients to get it done.

Working tirelessly during the formulation of our initial San Francisco MCD ordinances, encouraging patients, providing public input, and offering innovative solutions, Brents focus has always been on creating reasonable garden guidelines that are easy for patients and law enforcement to understand.

Before becoming a patient, Brent supported his family as a general contractor. With this experience Brent found a niche in the San Francisco medical cannabis community helping patients set up safe and legally compliant gardens. In addition to giving advice to others, Brent has experienced six medical cannabis garden "inspections" personally over the last ten years. Brent has shown his continued commitment to intentional compliance by being "caught" following the rules each time.

Currently working on the cultivation subcommittee under the medical cannabis task force, Brent is applying for seat #10 on the medical cannabis task force that was recently vacated by Albert Blais. Brent is recommended for this seat by Albert as well as by unanimous vote of the cultivation subcommittee. Among others who support Brent for this seat are Shona Gochenhaur, president of Axis of Love, as well as David Goldman, current president of Americans for Safe Access San Francisco.

I am a resident of San Francisco for 16 years. In San Francisco, my medical experience began in 1995 as a medical resident and continued to attending physician at San Francisco General Hospital. Prior to 1995, I spent four years of medical study in Boston, MA working primarily in underserved areas based out of Boston City Hospital.

My professional focus is to provide medical service to underserved and minority populations. This focus began early in my career and spanned from Newark, NJ to Providence, RI to Boston and Dorchester, MA and finally to San Francisco, CA. My belief is that people have a right to health care and it is the responsibility of our community to provide basic medical services to all people.

My medical practice in San Francisco mostly encompassed work for the SF Department of Public Health as a physician for the Adult Urgent Care Center in San Francisco General Hospital and in outlying underserved communities such as Potrero Hill and Bayview/Hunter's Point neighborhoods of San Francisco. In 2000, I began a private practice in the Mission neighborhood of San Francisco in conjunction with practitioners of Traditional Chinese Medicine and Chiropractic services with the hopes of providing low cost alternative health options to patients in the community. This practice progressed to the evaluation of patients for medical cannabis.

In 2004, I founded MediCann, Inc. for the purpose of providing medical cannabis evaluations for desiring patients throughout California. Twenty MediCann clinics are now established throughout California and have provided alternative health services to nearly 300,000 patients.

The Task Force shall consist of 15 members, appointed by the Board of Supervisors as follows:

Seat 1: A community organizer representative with a background in organizing neighbors, businesses or organizations around social justice and quality of life issues. This representative should also have a background working on medical cannabis related issues.

Seat 2: A representative of a local patient advocacy organization with a background in working to protect the interests of medical cannabis patients.

Seat 3: A representative of a local patient advocacy organization with a background in working to protect the interests of medical cannabis patients.

Seat 4: A representative of a hospice or a residential care facility with a background as an employee or volunteer in direct services working with medical cannabis patients or as a nurse or physician with a background in working with or treating of medical cannabis patients.

Seat 5: A person with a background in the management of a medical cannabis dispensary.

Seat 6: A person with a background in the management of a medical cannabis dispensary.

Seat 7: A person with a background in the management of a medical cannabis dispensary whose primary mode of operation is delivery.

Seat 8: A representative of a drug policy organization working specifically on medical cannabis issues.

Seat 9: A licensed California attorney with a background working with San Francisco medical cannabis dispensaries and experience with the City's medical cannabis dispensary permitting and regulatory process.

Seat 10: A person with a background in providing medical cannabis to low-income patients.

Seat 11: A person with a background in providing medical cannabis to permitted medical cannabis dispensaries located in the City and County.

Seat 12: A person with at least fifteen years of experience working on medical cannabis issues in the City and County.

Seat 13: A person with at least fifteen years of experience working on medical cannabis issues. A representative of a recognized neighborhood organization that has a medical cannabis dispensary within its boundaries.

Seat 14: A person with a background in providing medical cannabis to permitted medical cannabis dispensaries located in City and County.

Seat 15: A licensed or accredited health care practitioner practicing in the City and County with a background in medical cannabis and familiarity with the laws and regulation governing medical cannabis.

The Task Force shall have the power and duty to:

- (1) Hold hearings and take testimony regarding medical cannabis issues and related matters.
- (2) Create subcommittees as necessary.
- (3) Review local medical cannabis related laws, and make recommendations for changes.
- (4) Develop and make recommendations for a mediation process to be used by operators of medical dispensaries, patients and neighbors of dispensaries to address community concerns and resolve conflicts and disputes.
- (5) Develop and make recommendations regarding medical cannabis cultivation, production and baking guidelines for medical cannabis dispensaries.
- (6) Develop and make recommendations regarding cultivation and distribution of medical cannabis by individual patients, caregivers or small collectives that may fall outside the definition of a medical cannabis dispensary under the City's Health Code.
- (7) Develop and make recommendations regarding the cultivation of medical cannabis, particularly in residential dwellings, that may violate the City's Planning Code or applicable San Francisco or California Building Code requirements.
- (8) Develop and make recommendations regarding the taxation of medical cannabis lawfully dispensed or cultivated in the City and County.
- (9) Develop and make recommendations regarding the local regulation of medical cannabis in the event that State Proposition 19 is approved by the voters in the election held on November 2, 2010.

Report: During each year of its operation the Task Force shall submit to the Board of Supervisors an annual report summarizing its recommendations.

Dear Chairwoman Kim and Members of the Rules Committee:

Per notification of the Rules Committee Agenda for Thursday, November 3, 2011, I write in reference to item #3, "Appointments, Medical Cannabis Task Force," to consider appointing three members to fill vacancies on the Task Force. As a former member of the Task Force, I strongly urge you to consider postponing these appointments and instead recommend the Task Force revisit legislative changes to the Task Force to better facilitate fulfillment of its charter.

At least seven appointed members of the San Francisco Medical Cannabis Task Force, nearly one-half the entire body, either resigned or stopped attending regular meetings upon expiration of their term in July. These resignations are a clear indication that something is not working and ought to prompt some investigation by the Board before new members are appointed so as to ensure future appointments will result in substantive discussion and recommendations. Specifically, the Board of Supervisors might consider amending legislation to specify a permanent chair, limit the number of committees and how many people can be on each committee, among other changes as noted in several resignation letters.

Unless or until changes are made to the structural design of the Task Force, I fear continued repugnance will divide the community and further deter participation from stakeholders that more accurately reflect the experiences of the medical cannabis community in San Francisco.

I am writing in regard to the Rules Committee meeting scheduled for November 3, 2011. Agenda item #3 is the hearing on the appointment of 3 members to the San Francisco Medical Cannabis Task Force. I am sorry I will not be able to attend since I will be at a conference in Los Angeles.

As you know I resigned from the Task Force because of the disruptive influence of a fellow member of the Task Force by the name of Shona Gochenaur and the Axis of Love. I requested the Board of Supervisors to sunset the Task Force.

First, I would like to express my support for Carol Blecker for seat #4. Carol is a wonderful social worker at the Richard Cohen residential care facility and she has worked with medical cannabis patients there for years. She is by far the best qualified candidate for the hospice/care facility seat formerly held by Mary Schroeder of Maitri.

Since you are filling vacated seats, I would like to call to your attention that at least 2 of the applicants are members of Axis of Love, Marquis Devon Ausby and Kenneth Lima. If appointed, there will be an unprecedented number of people from one group that will dominate the Task Force and will not be representative of the medical cannabis community. Members of the Task Force that are associated with Axis of Love are Shona Gochenaur, Maureen Burns and Stuart Rhoads. Adding two more of Axis members to the Task Force would skew the balance that the community worked hard on to make sure that everyone would be at the table. This is not acceptable.

Ms. Gochenaur has a history of disrupting meetings by intimidating members of committees until they resign in disgust. Then she has members of her group appointed to the open seats. She did this before to the original members of the Community Oversight Committee Regarding Enforcement Of Marijuana Offenses. She continued her intimidation until she had the majority of the membership that she could control. It has made that committee unmanageable and totally impotent. The Oversight

Committee had only 5 meetings this year, one of which was canceled. There are no minutes of the meetings posted for the whole year of 2011.

I am writing to you today to underscore my concern about the possible appointment of more members of the organization Axis of Love to the San Francisco Medical Cannabis Task Force. As you may know, I have recently resigned from the Task Force due to its inability to function with its current structure of rotating chairs, and the continual disruptive influence of Task Force member Shona Gochenaur and her followers in her organization Axis of Love. My letter of resignation is below.

Dear Members of the Board of Supervisors:

I hereby resign from the San Francisco Medical Cannabis Task Force effective October 3, 2011. I also resign from the Legal Committee and the Outreach Committee of the Task Force. It has been an honor to serve.

Inherent flaws in the Task Force's structure have made it increasingly difficult for work to get done. In particular, the requirement that there be rotating chairs for each meeting has led to having chairs with the inability to conduct meetings in an efficient and productive manner. Furthermore, one member of the Task Force, Ms. Shona Gochenaur has continued to play a disruptive role, using her followers to hijack public comment portions of the meeting. She has instructed her followers to make untrue personal attacks on members of the Task Force during public comment. She has frequently violated both the Brown and Sunshine Acts in emails she has sent to the Task Force. She has continued to push for investigating issues which are not under the purview of the Task Force. She has not recused herself on votes, in which she has a personal interest. She and her followers have created several vacuous organizations, so she can stack the committees of the Task Force, including the Veterans Committee, the Cultivation Committee, and the Patient Advocacy Committee. When her followers have come before the Task Force seeking appointment to the committees, and have been asked about their resumes, they have stated that they did not prepare them, and did not verify their accuracy before they were presented to the Task Force for consideration. What Ms. Gochenaur has done has been unethical. The entire process has become repugnant and embarrassing.

In good conscience, I cannot continue to serve on a body with Ms. Gochenaur. Until she is removed

from the Task Force, the ability of the Task Force to be a credible voice for San Francisco's medical cannabis community will be stymied.

I did not envision the Task Force ending up this way. I am certain you were of the same point of view. I strongly urge the Board to restructure the Task Force, or if this is not possible, to sunset it as soon as possible.

Thank you for giving me the opportunity to serve the City and County of San Francisco. I will continue to work on medical cannabis issues as part of the Core Leadership Group of the San Francisco chapter of ASA, Americans for Safe Access, the nation's oldest and largest medical cannabis advocacy organization. It is my sincere hope that there will be a time in the future where I may be able to serve the City and County of San Francisco in continuing to make San Francisco the model for sensible medical cannabis regulation for the United States.
