9 Be it ordained by the People of the City and County of San Francisco:

11 Section 1. To promote Small Business Week and permit sidewalk sales of  
12 merchandise, Public Works Code Section 724.1(b), setting a fee for temporary street space  
13 occupancy, is hereby waived on Saturday, May 19, 2018, between the hours of 7 a.m. and 9  
14 p.m., for the following areas:

15 3rd Street between Jerrold Avenue and Kirkwood Avenue;

16 3rd Street between Palou Avenue and Quesada Avenue;

17 9th Avenue between Lincoln Way and Kirkham Street;

18 14th Street between Church Street and Landers Street;

19 18th Street between Eureka Street and Douglas Street;

20 18th Street between Noe Street and Diamond Street;

21 24th Street between Diamond Street and Church Street;

22 Armstrong Avenue between 3rd Street and Keith Street;

23 Balboa Street between 33rd Avenue and 40th Avenue;

- 1 Bosworth Street between Diamond Street and Brompton Avenue;
- 2 Castro Street between Market Street and 19th Street;
- 3 Castro Street between 24th Street and Jersey Street;
- 4 Chenery Street between Brompton Avenue and Natick Street;
- 5 Chestnut Street between Divisadero Street and Fillmore Street;
- 6 Church Street between Elizabeth Street and 30th Street;
- 7 Church Street between Market Street and 15th Street;
- 8 Columbus Avenue between Vallejo Street and Green Street;
- 9 Diamond Street between 24th Street and Jersey Street;
- 10 Diamond Street between Monterey Boulevard and Surrey Street;
- 11 Fillmore Street between Eddy Street and Jackson Street;
- 12 Geneva Avenue between Gloria Court and Paris Street;
- 13 Grant Avenue between California Street and Clay Street;
- 14 Grant Avenue between Vallejo Street and Green Street;
- 15 Green Street between Columbus Avenue and Grant Street;
- 16 Haight Street between Central Avenue and Stanyan Street;
- 17 Irving Street between 5th Avenue and 18th Avenue;
- 18 Jerrold Avenue between 3rd Street and Phelps Street;
- 19 Lane Street between Underwood Avenue and Van Dyke Avenue;
- 20 Market Street between Castro Street and Church Street;
- 21 Mission Street between Italy Avenue and Mt. Vernon Avenue;
- 22 Noe Street between Market Street and Beaver Street;
- 23 Sacramento Street between Spruce Street and Baker Street;
- 24 Ulloa Street between Claremont Boulevard and Wawona Street;
- 25 Valencia Street between Market Street and Cesar Chavez Street;

1 Vallejo Street between Columbus Avenue and Grant Street;  
2 Vicente Street between Claremont Boulevard and Wawona Street;  
3 Vicksburg Street between 24th Street and Jersey Street;  
4 West Portal Avenue between Ulloa Street and 15th Avenue; and  
5 Wilder Street between Diamond Street and Carrie Street.

7 Section 2. All other provisions of Public Works Code Sections 724 et seq. shall remain  
8 in full effect.  
9

10 Section 3. Effective and Operative Dates; Retroactivity.

11 (a) This ordinance shall become effective 30 days after enactment. Enactment occurs  
12 when the Mayor signs the ordinance, the Mayor returns the ordinance unsigned or does not  
13 sign the ordinance within ten days of receiving it, or the Board of Supervisors overrides the  
14 Mayor's veto of the ordinance.

16 (b) If this ordinance becomes effective after May 19, 2018, this ordinance shall be  
17 retroactive to that date.


