Be it ordained by the People of the City and County of San Francisco:

Section 1. To promote Small Business Week and permit sidewalk sales of merchandise, Public Works Code Section 724.1(b), setting a fee for temporary street space occupancy, is hereby waived on Saturday, May 19, 2018, between the hours of 7 a.m. and 9 p.m., for the following areas:

Section 3. Effective and Operative Dates; Retroactivity.

- (a) This ordinance shall become effective 30 days after enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board of Supervisors overrides the Mayor's veto of the ordinance.
- (b) If this ordinance becomes effective after May 19, 2018, this ordinance shall be retroactive to that date.
