8 Be it ordained by the People of the City and County of San Francisco:

9 Section 1. Pursuant to Charter section 6.102(5), the Board of Supervisors hereby
10 authorizes the City Attorney to settle the action entitled Aaron Read v. City and County of San
11 Francisco, et al., San Francisco Superior Court, Case No. CGC-13-534077 by the payment of
12 \$112,000.

13 Section 2. The above-named action was filed in San Francisco Superior Court on
14 October 6, 2013, and the following parties were named in the lawsuit: Plaintiff: Aaron Read,
15 Defendants: City and County of San Francisco, San Francisco Housing Authority, North
16 Beach Housing Associates, John Stewart Company.




