2 COMMENDING THE BAY AREA SUSAN G. KOMEN BREAST CANCER FOUNDATION  
3 FOR AWARDING A \$31,000 GRANT TO THE BAYVIEW HUNTERS POINT HEALTHCARE  
4 TASK FORCE .

6 WHEREAS, The Bay Area Susan G. Komen Breast Cancer Foundation recently awarded a  
7 grant over \$31,000 to the Bayview Hunters Point Healthcare Task Force to fund information  
8 and training programs on breast cancer; and,

9 WHEREAS, This grant will provide workshops on breast cancer and train volunteers to  
10 demonstrate proper self exam techniques in the Bayview Hunters Point community, where  
11 volunteers also work door-to-door in an outreach effort to distribute awareness information; and,

13 WHEREAS, The work of the Komen Foundation has been recognized by Pacific Bell,  
14 which has earmarked some of its funds for finding a cure for breast cancer to go directly to the  
15 Komen Foundation and for increased mammograms for underserved women in San Francisco;

18 WHEREAS, The success of the Task Force has prompted the Margaret Cruz Latin Breast  
19 Cancer Foundation to implement a similar program for Latina women in the Mission, Excelsior,  
20 and Bernal Heights areas; and,

21 WHEREAS, The Komen Foundation has raised over \$215 million for breast cancer  
22 research, education, and screening programs, and is best known for the Komen Race for the  
23 Cure, which is held in 106 cities in the United States and will be held in San Francisco on  
24 October 15, 2000; and,

1           WHEREAS, The Bay Area Affiliate of the Komen Foundation has disseminated over \$3  
2 million in grants to the Bay Area Breast Cancer Community to help fund a free mobile  
3 mammography program for underserved women in the Bay Area; now, therefore be it

4           RESOLVED, That the Board of Supervisors of the City and County of San Francisco  
5 extends its highest commendation to the Bay Area Susan G. Komen Breast Cancer Foundation  
6 for awarding a \$31,000 grant to the Bayview Hunters Point Healthcare Task Force.




