3 **Resolution authorizing the City Administrator and the Director of the Department of the**  
4 **Environment to accept and expend \$900,000 from the Bay Area Air Quality**  
5 **Management District's Transportation Fund for Clean Air and authorizing the City**  
6 **Administrator and the Director of the Department of the Environment to execute**  
7 **agreements with the Bay Area Air Quality Management District, whereby, the City**  
8 **would indemnify the District from claims resulting from the City's performance of said**  
9 **agreements.**

11 WHEREAS, The Bay Area Air Quality Management District ("District") has approved  
12 \$900,000 from the Transportation Fund for Clean Air, for the City Administrator/Department of  
13 the Environment; and

14 WHEREAS, The purpose of this grant is to subsidize the incremental costs of  
15 converting the Norcal Waste Systems, Inc.'s refuse transfer truck operation from diesel to  
16 natural gas; and

17 WHEREAS, The use of natural gas will reduce emissions from these vehicles and  
18 result in cleaner air throughout the San Francisco Bay Area; and

19 WHEREAS, The District requires that the City enter into funding agreements in order  
20 to receive the funds to be used for these projects; and

21 WHEREAS, The District requires that the City shall indemnify and hold harmless the  
22 Air District, its officers, employees, agents, representatives, and successors-in-interest  
23 against any and all claims, suits, or actions resulting from the performance by the City of its  
24 duties under the agreements; and

25 WHEREAS, The Departments propose to maximize use of available grant funds on  
program expenditures by not including indirect costs in the grant budget; now, therefore, be it

7 its officers, employees, agents, representatives, and successors-in-interest against any and  
8 all claims, suits, or actions resulting from the performance by the City of its duties under the  
9 agreements.


