4	Resolution approving a grant agreement between Conard House, Inc. and the
5	Department of Homelessness and Supportive Housing ("HSH"), for support services,
6	property management and master lease stewardship at the Allen, Aranda, and
7	McAllister Hotels for permanent supportive housing for formerly homeless adults, for a
8	term of 24 months from July 1, 2025, through June 30, 2027, and a total not to exceed
9	amount of \$15,173,623; and authorizing HSH to enter into any amendments or other
10	modifications to the agreement that do not materially increase the obligations or
11	liabilities, or materially decrease the benefits to the City and are necessary or advisable
12	to effectuate the purposes of the agreement.
13	
14	WHEREAS, The mission of the Department of Homelessness and Supportive Housing
15	("HSH" or "Department") is to prevent homelessness when possible and make homelessness
16	rare, brief, and one-time in the City and County of San Francisco ("the City") through the
17	provision of coordinated, compassionate, and high-quality services; and
18	WHEREAS, Permanent supportive housing ("PSH") is the most effective evidence-
19	based solution to chronic homelessness; and
20	WHEREAS, As of the 2024 Point-in-Time Count, there were approximately 8,323
21	people experiencing homelessness in San Francisco on any given night, 52% of whom were
22	unsheltered; and
23	WHEREAS, Conard House, Inc. ("Conard") has operated the Allen and Aranda Hotels
24	as PSH since 2012, and the McAllister Hotel as PSH since 2004; and
25	

1	WHEREAS, In Fiscal Year 2023-2024 Conard served 296 total adult tenants across the
2	Allen, Aranda and McAllister PSH sites; and
3	WHEREAS, HSH awarded the agreement to Conard through the Department's
4	streamlined contracting authority for homeless services under Administrative Code, Chapter
5	21.B; and
6	WHEREAS, HSH intends to enter into an Agreement with Conard for support services,
7	property management and master lease stewardship at the Allen, Aranda, and McAllister
8	Hotels, for a term of 24 months, from July 1, 2025, through June 30, 2027, and a total not to
9	exceed amount of \$15,173,623 (the "Agreement"); and
10	WHEREAS, The Agreement continues services at the three PSH sites and
11	consolidates previously separate agreements to support with grant agreement management
12	and oversight by HSH; and
13	WHEREAS, The Amendment requires Board of Supervisors approval under Section
14	9.118 of the Charter; now, therefore, be it
15	RESOLVED, The proposed Agreement contained in File No. 250229, is substantially in
16	final form, with all materials terms and conditions included, and only remains to be executed
17	by the parties upon approval of this Resolution; and, be it
18	FURTHER RESOLVED, That the Board of Supervisors authorizes HSH to make any
19	modifications to the Agreement, prior to its final execution by all parties, that HSH determines,
20	in consultation with the City Attorney, are consistent with this Resolution, in the best interest of
21	the City, do not materially increase the obligations or liabilities of the City, are necessary or
22	advisable to effectuate the purposes of the Agreement, and are in compliance with all
23	applicable laws, including City's Charter; and, be it

FURTHER RESOLVED, That within 30 days of the Agreement being fully executed by

all parties, HSH shall submit to the Clerk a completely executed copy for inclusion in File
