
Recently, there have been a variety of serious food and worker safety incidents, as well as a range of sexual, racial and gender harassment complaints, against Taylor Farms Pacific. In addition, Region 32 of the National Labor Relations Board has found credible evidence of nearly sixty serious violations of law involving threats, intimidation and terminations of Taylor Farms workers for exercising their right to seek union representation.

Given the disturbing business practices of Taylor Farms Pacific, I am calling a hearing to inquire whether the City and County of San Francisco currently sources any products produced by Taylor Farms or its subsidiaries. If the City and County of San Francisco does source products from this company, I want to know what alternative sources we may have for these products. Please include any items that might be purchased indirectly through other suppliers. If necessary, prior to the hearing, please inquire from other vendors that may be sourcing products through Taylor Farms.

I am requesting that his hearing be assigned to the Public Safety & Neighborhood Services Committee and kindly ask the Clerk of the Board to send this hearing request to the Director of the Office of Contracts Administration.
