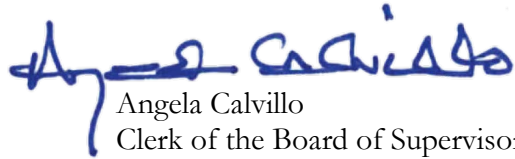
Subject: **File No. 260565.** Hearing of the Board of Supervisors sitting as a Committee of the Whole on June 16, 2026, at 3:00 p.m., to consider the Department of Public Health's budget reducing medical and health care services provided by the City and County of San Francisco for Fiscal Years (FYs) 2026-2027 and 2027-2028, pursuant to California Health and Safety Code, Section 1442.5(a) (The Beilenson Act).

At this Hearing, the Board of Supervisors of the City and County of San Francisco will consider the impacts of the proposed reduction of medical services provided by City and County of San Francisco facilities. Public testimony, both oral and written, will be accepted at this hearing.

The San Francisco Department of Public Health has prepared the attached list of proposed budget reductions that are subject to the Beilenson Hearing. The list includes the reduction of medical services at City and County of San Francisco facilities. Although Section 1442.5(a) of the Health and Safety Code requires notice only for reductions of medical services at county facilities and does not require notice for reduction of other health services, the Department of Public Health has included proposed changes of both types in the attached list. 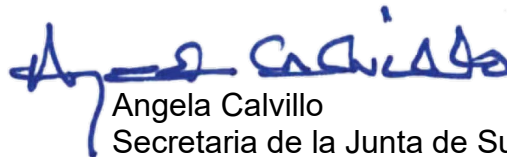

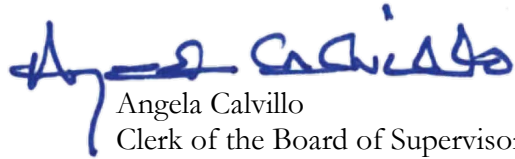
