13 Be it ordained by the People of the City and County of San Francisco:

14 Section 1. The Board of Supervisors hereby adopts and implements the Collective  
15 Bargaining Agreement ("CBA") between the City and County of San Francisco and San  
16 Francisco Sheriffs' Managers and Supervisors Association, to be effective July 1, 2022  
17 through June 30, 2024.

18 The CBA so implemented is on file with the Clerk of the Board of Supervisors in Board  
19 File No. 220580.

20 Section 2. The Board of Supervisors hereby authorizes the Department of Human  
21 Resources to make non-substantive ministerial or administrative corrections to the CBA.

22 Section 3. Effective Date. This ordinance shall become effective upon enactment.  
23 Enactment occurs when the Mayor signs the ordinance, the Mayor returns the ordinance


