3 **Motion adopting findings supporting the Board's decision to disapprove the decision**
4 **of the Planning Commission by its Motion No. 18648, approving Conditional Use**
5 **Authorization identified as Planning Case No. 2011.1372C on property located at 3901 –**
6 **24th Street.**

8 WHEREAS, The appellant Leslie Crawford filed a timely appeal on February 12, 2012,
9 protesting the approval by the Planning Commission by its Motion No. 18648, dated June 14,
10 2012, approving a Conditional Use Authorization identified as Planning Case No. 2011.1372C,
11 under Planning Code Sections 728.49 and 790.110 to convert a vacant ground floor commercial
12 space into a financial service (d.b.a. First Republic Bank) within the 24th Street – Noe Valley
13 Neighborhood Commercial District and a 40-X Height and Bulk District on property located at
14 3901 – 24th Street, Assessor's-Block No. 6508, Lot No. 001; said appeal was subscribed by
15 Supervisors Wiener, Olague, Avalos, Mar, and Chiu; and

16 WHEREAS, On July 30, 2012, the Board of Supervisors received a letter from Joe
17 Petitti, Executive Vice President of First Republic Bank, which provided that First Republic
18 Bank "hereby is withdrawing its application for a Conditional Use Authorization for 3901 – 24th
19 Street, (Planning Case N. 2011.1372c)"; and

20 WHEREAS, On July 31, 2012, the Board of Supervisors conducted a duly noticed
21 public hearing on the appeal from the Planning Commission's approval of the conditional use
22 authorization referred to in the first paragraph of this motion; and

23 WHEREAS, Following the conclusion of the public hearing on July 31, 2012, no
24 members of the public having commented, and no objection having been made to the
25 withdrawal by First Republic of the application for Conditional Use Authorization, the Board
