




14 the Planning Department, by its letter dated January 15, 2002, that the project intended by  
15 the map is consistent with the General Plan and the Priority Policies of Planning Code  
16 Section 101.1.

17           FURTHER MOVED, That approval of this map is also contingent upon compliance by  
18 the subdivider with all applicable provisions of the San Francisco Subdivision Code and  
19 amendments thereto.
