5 **where marijuana is grown, purchased or distributed with a medical recommendation.**

7 WHEREAS, On March 29, 2005, the Board of Supervisors adopted Ordinance No. 64-
8 05, an urgency Ordinance that imposed a 45-day moratorium on clubs or dispensaries where
9 marijuana is grown, purchased or distributed with a medical recommendation. A copy of said
10 Ordinance is on file with the Clerk of the Board of Supervisors in File No. 050512, and is
11 incorporated herein by reference; and,

13 WHEREAS, On April 1, 2005, the Mayor signed Ordinance No. 64-05 into law; and

14 WHEREAS, Said Ordinance was adopted in accordance with California Government
15 Code section 65858, which governs the adoption and extension of interim zoning moratoria;

18 WHEREAS, Government Code section 65858(d) requires the local legislative body to
19 issue a written report describing the measures taken to alleviate the condition that led to the
20 adoption of the moratorium; and,

22 WHEREAS, On April 25~~2~~, 2005, the Planning Department issued a report entitled
23 "Report on Status and Regulatory Actions Regarding Medical Cannabis Dispensaries" ~~Interim~~
24 ~~Ordinance on Clubs or Dispensaries Where Marijuana Is Grown, Purchased or Distributed~~
25 ~~With a Medical Recommendation~~" for the Board's consideration. A copy of said report is on
file with the Clerk of the Board of Supervisors in File No. 050512 and is incorporated herein by
reference; and

1 WHEREAS, On April 25, 2005 during a hearing of the Government Oversight and Audit
2 Committee of the Board of Supervisors, the Committee considered the Planning Department's
3 report; now, therefore, be it
