3 **Motion amending Rules 3.7 and 3.8 of the Rules of Order of the Board of Supervisors to**  
4 **provide that Board Committees have until 9:00 a.m. on Thursdays to report legislation**  
5 **to the Board for the following Tuesday's Board meeting, except that legislation**  
6 **reported by the Rules Committee at a Wednesday meeting must be submitted to the**  
7 **Clerk by 12:00 noon that day to be considered at the following Tuesday's meeting.**

10 Board amendment additions are double underlined.  
11 Board amendment deletions are ~~strikethrough-normal~~.

12 MOVED, That the Board of Supervisors of the City and County of San Francisco  
13 hereby amends Rules 3.7 and 3.8, to read as follows:

14 **3.7 New Business.** This item includes legislation reported to the full Board by Board  
15 committees prior to ~~12:00 noon~~ 9:00 a.m. on the ~~Wednesday~~ ~~Thursday~~ preceding the Tuesday  
16 Board meeting. An exception to Rule 3.7 is that legislation reported to the full Board by the Rules  
17 Committee at a Wednesday committee meeting must be submitted to the Clerk of the Board by 12:00  
18 noon that day to be considered by the Board at the immediately following Tuesday (or Wednesday, if  
19 that Tuesday is a holiday) Board meeting.

20 **3.8 Committee Reports on Urgent Legislation.** As an exception to the New  
21 Business rule, legislation deemed by a committee to be of an urgent nature, which is heard  
22 after the ~~12:00 noon Wednesday~~ 9:00 a.m. Thursday deadline (or after the Wednesday 12:00 noon  
23 deadline for the Rules Committee, as provided in Rule 3.7), may be considered by the Board as a  
24 committee report if the chair has anticipated such finding and requested the Clerk of the  
25 Board to include the item on the printed agenda under Committee Reports at the end of New  
Business.


