10 WHEREAS, Robin Reichert is seeking issuance of a Type 48 on-sale general
11 public premises liquor license for dba “Transmission Theater,” located at 314-11th
12 Street; and,

13 WHEREAS, The City Planning Department has verified that the area is properly
14 zoned; and recommends approval;

15 WHEREAS, The Police Department recommends that the liquor license
16 application be approved with conditions; now, therefore, be it

17 RESOLVED, That in accordance with Section 23958.4 of the California Business
18 and Professions Code, the Board of Supervisors of the City and County of San
19 Francisco hereby determines for the foregoing reasons that the issuance of a Type 48
20 on-sale general public premises liquor license, to Robin Reichert for dba “Transmission
21 Theater”, located at 314-11th Street will serve the public convenience and necessity of
22 the people of the City and County of San Francisco.

23 Conditions: 1) Sales and service of alcoholic beverages shall be permitted only
24 between the hours of 12:00 noon and 2:00 a.m. each day of the week; 2) Entertainment
25 provided shall not be audible beyond the area under the control of the licensee; 3) the

1 petitioner(s) shall be responsible for maintaining free of litter the area in front of and
2 adjacent to the premises over which they have control.




