3 **Resolution determining that the issuance of a Type 48 on-sale general public**  
4 **premises license in exchange for a Type 47 on-sale general eating place license**  
5 **to Wen Wen Lin dba Kabuki Night Club at 22 Peace Plaza, Space 525, will serve**  
6 **the public convenience and necessity of the people of the City and County of San**  
7 **Francisco, in accordance with Section 23958.4 of the California Business and**  
8 **Professions Code, with conditions.**

10 WHEREAS, Wen Wen Lin is seeking an exchange of a Type 47 on-sale general  
11 eating place license for a Type 48 on-sale general public premises license for the  
12 Kabuki Night Club at 22 Peace Plaza, Space 525; and,

13 WHEREAS, The Planning Department has verified that the area is properly  
14 zoned; and,

15 WHEREAS, The Police Department recommends that the alcoholic beverage  
16 license application be approved with conditions; now, therefore, be it

17 **RESOLVED, That in accordance with Section 23958.4 of the California Business**  
18 **and Professions Code, the Board of Supervisors of the City and County of San**  
19 **Francisco hereby determines for the foregoing reasons that the exchange of a Type 47**  
20 **on-sale general eating place license for a Type 48 on-sale general public premises**  
21 **license at 22 Peace Plaza, Space 525, for Wen Wen Lin dba Kabuki Night Club, will**  
22 **serve the public convenience and necessity of the people of the City and County of San**  
23 **Francisco.**

24 Conditions: (1) Sales, service, and consumption of alcoholic beverages shall be  
25 permitted only between the hours of 5:00 p.m. and 1:30 a.m. each day of the week. (2)

1 The petitioner(s) shall make no changes in the premises interior without prior written  
2 approval from the Department. (3) No noise shall be audible beyond the area under  
3 control of the licensee. (4) No employee or agent shall solicit or accept any alcoholic or  
4 non-alcoholic beverage from any customer while in the premises. (5) No employee or  
5 agent shall be permitted to accept money or anything of value from a customer for the  
6 purpose of sitting or otherwise spending time with customers while in the premises, or  
7 shall the licensee provide or permit, or make available either gratuitous or for  
8 compensation, male or female persons who act as escorts, companions, or guests of  
9 and for customers. (6) The petitioner(s) shall be responsible for maintaining free of  
10 litter the area adjacent to the premises over which they have control. (7) The  
11 petitioner(s) shall not permit their patrons or the general public to loiter or congregate on  
12 the area adjacent to the licensed premises. (8) The sale of alcoholic beverages for off-  
13 sale consumption is strictly prohibited.


