Conditions: (1) Sales, service, and consumption of alcoholic beverages shall be permitted only between the hours of 5:00 p.m. and 1:30 a.m. each day of the week. (2)

The petitioner(s) shall make no changes in the premises interior without prior written approval from the Department. (3) No noise shall be audible beyond the area under control of the licensee. (4) No employee or agent shall solicit or accept any alcoholic or non-alcoholic beverage from any customer while in the premises. (5) No employee or agent shall be permitted to accept money or anything of value from a customer for the purpose of sitting or otherwise spending time with customers while in the premises, or shall the licensee provide or permit, or make available either gratuitous or for compensation, male or female persons who act as escorts, companions, or guests of and for customers. (6) The petitioner(s) shall be responsible for maintaining free of litter the area adjacent to the premises over which they have control. (7) The petitioner(s) shall not permit their patrons or the general public to loiter or congregate on the area adjacent to the licensed premises. (8) The sale of alcoholic beverages for off-sale consumption is strictly prohibited
