3 **Resolution authorizing the San Francisco Board of Supervisors to enter into an**
4 **agreement between the City and County of San Francisco and the County of Santa**

7 WHEREAS, the County of Santa Clara acting for and on behalf of itself and the City of
8 Berkeley, the County of Alameda , the County of Marin, the County of San Benito, the County
9 of San Mateo, the County of Solano, the County of Sonoma, and such other public agencies
10 that may be added subsequently have joined in a joint powers agreement; and,

11 WHEREAS, these public agencies are possessed of common powers and authority to
12 collect, analyze, use and share immunization related information in their respective
13 immunization information systems; and

14 WHEREAS, the joint powers agreement is referred to as the Bay Area Regional
15 Immunization Registry; and

16 WHEREAS, the City and County of San Francisco desires to execute an agreement
17 and become a party to the joint powers agreement and become a member of the Bay Area
18 Regional Immunization Registry; and


19 WHEREAS, The San Francisco Health Commission on October 7, 2003, agreed that it
20 would be beneficial for San Francisco to be a member of the joint powers agreement; and

21 WHEREAS, The San Francisco Health Commission urges the Board of Supervisors to

23 therefore, be it

24 RESOLVED, That the Board of Supervisors, acting on behalf of the City and County of
25 San Francisco will authorize the President of the Board to execute the Joint Powers
