9 WHEREAS, Semere Mesfun is seeking issuance of a Type 40 (On-Sale Beer)  
10 alcoholic beverage license for The Unity Cafe, located at 1661 Fillmore Street; and,

11 WHEREAS, The Planning Department has verified that the area is properly  
12 zoned; and recommends approval with conditions and,

13 WHEREAS, The Police Department recommends that the alcoholic beverage  
14 license application be approved with conditions; now, therefore, be it

15 RESOLVED, That in accordance with Section 23958.4 of the California Business  
16 and Professions Code, the Board of Supervisors of the City and County of San  
17 Francisco hereby determines for the foregoing reasons that the issuance of a Type 40  
18 (On-Sale Beer) alcoholic beverage license, to Semere Mesfun for The Unity Cafe,  
19 located at 1661 Fillmore Street will serve the public convenience and necessity of the  
20 people of the City and County of San Francisco.

21 Conditions: 1) Sales and service of alcoholic beverages shall be permitted only  
22 between the hours of 9:00 a.m. to midnight each day of the week. 2) Petitioners shall  
23 not permit their patrons or the general public to loiter or congregate on the sidewalks  
24 adjacent to the licensed premises. 3) The petitioner(s) shall be responsible for  
25 maintaining free of litter the area adjacent to the premises over which they have control.

- 1 4) There shall be no coin operated games or video machines maintained upon the
- 2 premises at any time. 5) The subject alcoholic beverage license shall not be
- 3 exchanged for a public premises type license nor operated as a public premises. 6)
- 4 The sale of alcoholic beverages for consumption off the premises is strictly prohibited.
- 5 7) No noise shall be audible beyond the area under control of the licensee.




