

Be it ordained by the People of the City and County of San Francisco:

Section 1. Article III of the San Francisco Traffic Code is hereby amended by
amending Section 32.4.1, to read as follows:

SEC. 32.4.1. PENALTY FOR VIOLATION. Any person violating the provisions of
Section 32.4 shall be deemed guilty of an infraction and upon conviction thereof shall be
punished by a fine of not less than \$25 nor more than \$50. In addition, any officer of

~~t((T))he Police Department~~ is hereby authorized to remove or cause to have removed any
vehicle in violation of the provisions of Section 32.4 hereof, as provided for in Section 22654
of the California Vehicle Code and in accordance with the provisions of Article 9 of the San
Francisco Traffic Code.




