## **Hearing - Public Health Response to COVID-19 - Latinx Community Public comment**

Dear Public Safety and Land Use Committee of SF Board of Supervisors members:

This **Michael Nulty**, I am speaking as a **former San Francisco Health Department Employee**, I appreciate the presentation from the San Francisco Public Health Department. But it seem to only bring up more questions that actually answer what is going on to address the needs of the Latinx Communities in relationship to COVID.

The presenters from the Public Health Department failed to have any decision marking person that is responsible for how funds are being allocated to address this crisis. With the acknowledgment from the Public Health Department that the San Francisco's Latinx Communities make up 15% of the population but have 50% of San Francisco cases.

What amazed me was that **San Francisco Health Department** does not seem to be accountable to the distribute the much needs funds to the already established community based organization that are sensitive the the needs of the Latinx communities. Instead I am heard that San Francisco Public Health Department wanted to control and expend the funds through their agency and hold up funding request and RFP's that are long over due.

This is insane as a San Francisco native this seems to be another accountability issue that needs to be address. Another group I am affiliated with the **Alliance for a Better District 6 (ABD6)** I serve as their Executive Director and Co-Founder with the founding purpose to hold city hall and decision-makers accountable to the needs of the community. Throughout the 21 years of service ABD6 has collaborated with the needs of of the Mission Community and we co-produced the film called **Mi Casa No Es Su Casa**.
