RESOLVED, That this Board of Supervisors affirms this determination; and, be it FURTHER RESOLVED, That this Board of Supervisors approves the award of the 2023 Starlux Lease to STARLUX Airlines, Co., LTD dba STARLUX Airlines North America, Co. – Lease No. 23-0275; and, be it

FURTHER RESOLVED, That, in order to facilitate the administration of the 2023 Starlux Lease, this Board of Supervisors authorizes the Airport Director to enter into non-material modifications to the 2023 Starlux Lease throughout its term that do not: (a) materially increase the financial obligations or liabilities of City; (b) increase the term, or (c) change the general use of the demised premises from the permitted uses of the 2023 Starlux Lease; and, be it
