Re: Support for Sharon Lai's reappointment to SFMTA Board of Directors

Dear Supervisors Chan, Mandelman and Peskin,

I am writing to register Walk San Francisco's support for Sharon Lai's reappointment to the San Francisco Municipal Transportation Agency (SFMTA) Board of Directors.

Since Vision Zero was adopted in 2014, 200 people have lost their lives to traffic-related crashes, and 3,500 people live with serious injuries. We know where and how crashes happen and who suffers the most - children, older adults, people with disabilities, immigrants, and low-income residents. As the city's lead agency on Vision Zero, it is imperative SFMTA Board Members prioritize this policy in every decision.

In her six-months on the SFMTA Board, Board Member Lai has had the most vulnerable and non-English-speaking communities at the forefront of her decision-making and meeting discussions. She's been thoughtful about her questions on the agency's Vision Zero safety projects, and has participated in important discussions around the expansion of Slow Streets program to reach every neighborhood.

Both Vision Zero and Slow Streets will be front and center in the next 12-18 months as our city moves out of crisis and into recovery. We need Board Members to look at our streets as an extension of our transportation system, and prioritize giving communities across our city safe mobility choices like walking, biking and scooting to get to schools, jobs, recreation, and essential services while Muni recovers.

We believe Sharon Lai will continue to ask the hard questions, have our most vulnerable front and center to help guide the agency to make the necessary choices that will lead to a more equitable, safe, accessible, and sustainable transportation system.

Walk SF supports Sharon Lai's nomination for a full-term on the SFMTA Board.
