3 **Resolution restating the automatic public toilet and public service kiosk agreement**
4 **between the City and County of San Francisco and JC Decaux San Francisco, Inc.**
5 **which allows for the expansion of the automatic toilet program beyond the trial phase**
6 **and forwarding several other recommendations in order to ensure maximum quality**
7 **and public safety of said contract agreement and forwarded recommendations.**

9 WHEREAS, On August 2, 1994, the City and Contractor entered into an original
10 agreement entitled Automatic Public Toilet and Public Service Kiosk Agreement; and

11 WHEREAS, The Contractor, JC DeCaux San Francisco, Inc. agreed to provide
12 Automatic Public Toilets in exchange for the right to place Public Service Kiosks on public
13 property and to sell advertising on said Public Service Kiosks subject to the terms and
14 conditions set forth in the Original Agreement; and,

15 WHEREAS, On August 24th, 2001, the Audit, Labor and Government Efficiency
16 Committee held a hearing on said contract where several members of the public gave
17 comment on public health and safety issues surrounding these toilets; and,

18 WHEREAS, The following recommendations were introduced, discussed and
19 considered, including a request for the Department of Public Works (DPW) and the City
20 Attorney to review the terms of the current Contract Agreement and conduct an assesment in
21 order to determine if JC Decaux San Francisco, Inc. is in compliance with the contract
22 provisions set forth, including but not limited to:

- 23 • The requirement to maintain the Automatic Public Toilets in a clean, graffiti-free,
24 safe and first-class condition,
25 • Maintenance and inspection schedule, including hours of operations,

- 1 • Contributions to public art kiosks,
- 2 • Interactive media kiosks and additional public service kiosks,
- 3 • Payments, including percentage revenues,
- 4 • Other public services; and be it

21 the current twenty-five pursuant to contract restrictions.




