3 **Resolution approving the settlement of the unlitigated claim filed by the City and**
4 **County of San Francisco against SF Works for \$110,000.**

6 WHEREAS, the Wal-Mart Foundation Green Jobs Training Initiative Grant Award in the
7 amount of \$550,000 was awarded by the US Conference of Mayors in June 2009 to SF
8 Works, a private non-profit agency; and

9 WHEREAS, the Office of Economic and Workforce Development (OEWD) was a
10 subrecipient of this grant in the amount of \$350,000 to train economically disadvantaged
11 residents in asbestos abatement and solar installation through the Citybuild workforce training
12 academy; and,

13 WHEREAS, SF Works closed operations in November 2011; and,

14 WHEREAS, SF Works owes OEWD \$178,381 in grant funds, but has offered to pay
15 \$110,000; and,

16 WHEREAS, OEWD believes that pursuing litigation against SF Works for the full
17 amount owed will not be cost effective; and,


18 WHEREAS, OEWD thinks it is in the best interest of the City to accept this amount in
19 order to resolve the matter; now, therefore, be it

20 RESOLVED, That pursuant to Section 10.24(b) of the San Francisco Administrative
21 Code, settlement and compromise of said claim by acceptance of \$110,000 is hereby
22 approved.
