

1 [Police and Health Codes - Regulation of Cannabis Businesses]

3 Ordinance amending the Police Code by making a number of changes in the regulation
4 of commercial cannabis activity, including, among other things: 1) defining ownership
5 interest and revising Equity Criteria, for purposes of the Equity Program in a Cannabis
6 Business; 2) modifying the Cannabis Equity Incubator Program requirements; 3)
7 extending by one year the possible duration of a Temporary Cannabis Business
8 Permit; 4) authorizing the Director of the Office of Cannabis to issue Cannabis
9 Business Permits to Medical Cannabis Dispensaries forced to discontinue operations
10 due to a no-fault lease termination before December 31, 2018; 5) modifying the order in
11 which the Director may review and process Cannabis Business Permit applications; 6)
12 revising requirements associated with a Cannabis Business' change in ownership and
13 structure requiring Cannabis Business permit amendments when a change in
14 ownership results in a decrease in an Equity Applicant's Ownership Interest or role in
15 the Cannabis Business; 7) revising Cannabis Business Permit application
16 requirements; 8) requiring Cannabis Businesses to comply with all permit conditions
17 whether or not they are currently engaging in the permitted activity; 9) modifying the
18 amount of Cannabis that may be delivered or sold to a customer; and 10) authorizing
19 Cannabis Microbusinesses to conduct either storefront or delivery sales, but not both,
20 and reducing from four to three the categories of Commercial activity required to
21 operate as a Cannabis Microbusiness; and amending the Health Code by revising
22 eligibility requirements for medical cannabis dispensaries seeking authorization to Sell
23 Adult Use Cannabis, and extending by one year to December 31, 2019 the date on
24 which Article 33 (Medical Cannabis Act) expires.

7 Section 1. Article 16 of the Police Code is hereby amended by revising Sections 1602,
8 1604, 1605, 1606, 1608, 1609, 1613, 1615, 1618, 1622, 1627, 1628, ~~and 1629~~, and 1634, to
9 read as follows:

10 **SEC. 1602. DEFINITIONS.**

11 As used in this Article 16, the following words or phrases shall mean:

12 * * * *

13 “Owner” means any of the following:

14 (a) A Person with an aggregate ownership interest of 20% or more in the
15 Person applying for a Cannabis Business Permit or a Permittee, unless the interest is solely a
16 security, lien, or encumbrance;

17 (b) The chief executive officer of a nonprofit or other entity;

18 (c) A member of the board of directors of a nonprofit; or

19 (d) ~~An individual~~ Person who will be participating in the direction, control, or
20 management of the Person applying for a permit.

21 ~~“Ownership Interest” means an interest in a Person that would give the holder a share~~
22 ~~of the proceeds if the Person’s assets were sold at fair market value and then the proceeds~~
23 ~~were distributed in a complete liquidation of the Person.~~

2 **SEC. 1604. EQUITY PROGRAM.**

3 * * * *

4
5 (b) **Equity Applicants.** The Equity Program shall offer priority permit processing, as
6 provided in Section 1606, to an individual who meets the following Equity Criteria (“Equity
7 Applicant”):

8 * * * *

9 (3) Submits an application for a Cannabis Business Permit in any of the
10 following capacities:

11 (A) As the sole owner/operator of the Applicant;

12 (B) As an individual with an ownership interest of at least 40% in the
13 corporate Applicant, and who is also the Chief Executive Officer of the corporate Applicant;

14 (C) As an individual with an ownership interest of at least 51% in the
15 corporate Applicant;

16 (D) As the Executive Director or member of the board of directors of a
17 not-for-profit Applicant where a majority of the members of the board of directors satisfy the
18 requirements of subsections (b)(2) and (4) of this Section 1604; or

19 (E) As an individual with a membership interest in an Applicant formed
20 as a cooperative; and

21 ~~(4) — At the time of application, is a member of a household that earns no more~~
22 ~~than 120% of the San Francisco Area Median Income, adjusted for household size; and~~

23 ~~(454)~~ Meets three or more of the following additional criteria:

24 (A) At the time of application, is a member of a household that earns no
25 more than 80% of the San Francisco Area Median Income, adjusted for household size;

1 (A) ~~At the time of application, is a member of a household that earns no~~
2 ~~more than 80% of the San Francisco Area Median Income, adjusted for household size;~~

3 (BAB) During the period 1971-2016, was arrested for, convicted of, or
4 adjudged to be a ward of the juvenile court for any crime under the laws of California or any
5 other jurisdiction relating to the sale, possession, use, manufacture, or cultivation of Cannabis;

6 (CBC) ~~After~~ Since After 1995, ~~either lost housing~~ experienced housing

19 (DGD) Has a parent, sibling, or child who, during the period 1971-2016,
20 was arrested for, convicted of, or adjudged to be a ward of the juvenile court for any crime
21 under the laws of California or any other jurisdiction relating to the sale, possession, use,
22 manufacture, or cultivation of Cannabis;

23 (EDE) Attended a school under the jurisdiction of the San Francisco
24 Unified School District for five years, either consecutively or in total, during the period 1971-
25 2016; or

1 (FEF) During the period 1971-2016, lived for at least five years, either
2 consecutively or in total, in San Francisco census tracts where at least 17% of the households
3 had incomes at or below the federal poverty level, as determined by the Director.

4 For purposes of Section 1604(b)(3), an "ownership interest" in the corporate Applicant
5 shall include a right, proportionate to the interest held, to share in the business's profits,
6 including dividends, distributions, or other payments; a right, proportionate to the interest held,
7 to the proceeds of a sale of the business's assets, liquidation of the business, merger of the
8 business into another business, or another transaction that would signify the end of the
9 original business; and a right, proportionate to the interest held, to vote on fundamental
10 decisions relating to the business.

11 (c) **Equity Incubators.** The Equity Program shall offer priority permit processing, as
12 provided in Section 1606, to Equity Incubators. For purposes of this Article 16, an Equity
13 Incubator is an Applicant that does not qualify as an Equity Applicant, but that submits with its
14 Cannabis Business Permit application a Cannabis Equity Incubator Agreement in which it
15 *identifies no less than one Equity Operator; agrees to provide any identified Equity Operator*
16 *commercial space and security resources or, in either or both cases, the fair market value of same; and*
17 commits to comply with the following additional operating requirements during its first three
18 years in operation as a Cannabis Business:

19 (1) Ensure that at least 30% of all Business Work Hours are performed by Local
20 Residents. Business Work Hours performed by residents of states other than California shall
21 not be considered in calculation of the number of Business Work Hours to which this
22 requirement applies;

23 (2) Ensure that at least 50% of the Equity Incubator's employees satisfy the
24 requirements of subsection (b)(4) of this Section 1604;

1 (3) Provide a community investment plan demonstrating engagement with
2 businesses and residents located within 500 feet of the site of the proposed Cannabis
3 Business; and

4 (4) Provide the Equity Operator, directly or indirectly, with community outreach
5 services, security services for the Equity Operator's Premises, and any support necessary for
6 the Equity Operator to comply with the Good Neighbor Policy required in Section 1609(b)(19):
7 and

8 ~~(4)~~(5) Comply with one of the following additional operating requirements:

9 (A) Submit to the Director *for review and approval* a written, actionable
10 "Equity Incubator Plan" describing how the Equity Incubator will encourage and support the
11 establishment and growth of Equity Applicants who have been awarded Cannabis Business
12 Permits ("Equity Operators"), *including but not limited to any Equity Operator identified in the*
13 *Equity Incubator Plan*, by, among other things, providing business plan guidance, operations
14 consulting, *personnel, or* technical assistance. *The services listed in the Equity Incubator Plan must*
15 *be enumerated, and include an estimated dollar value of those services. The aggregate dollar value of*
16 *the services must equal or exceed the sum of (i) 10% of the rent for, or, if the Equity Incubator owns the*
17 *Equity Incubator's Premises, 10% of the rental market value of, the Equity Incubator's Premises, and*
18 *(ii) the annual total costs of security services at the Equity Incubator's premises. On or before March*
19 1 of each year, the Equity Incubator shall submit to the Director an annual report covering the
20 prior calendar year, signed by both the Equity Incubator and the Equity Operator, describing
21 the services provided under this subsection (c)(5)(A); or

22 (B) Provide an Equity Operator with rent-free commercial space owned
23 or leased by the Equity Incubator, *either adjacent to the Equity Incubator's Premises or off-site*, in
24 which the Equity Operator conducts its Cannabis Business. If such rent-free commercial
25 space is provided off-site, the Equity Incubator must provide the greater of 800 square feet or

1 the equivalent of at least 10% of the square footage of the Equity Incubator's Premises. If
2 such rent-free commercial space is provided adjacent to the Equity Incubator's Premises, the
3 Equity Incubator must provide either 800 square feet or the equivalent of at least 10% of the
4 square footage of the Equity Incubator's Premises. The rent-free commercial space must
5 equal or exceed 800 square feet or the equivalent of at least 10% of the square footage of the
6 Equity Incubator's Premises, whichever is greater, and must include the Equity Incubator's
7 provision of community outreach and security services for the space. Equity Incubators must
8 also provide to the Equity Operator the support necessary for the Equity Operator to comply
9 with the Good Neighbor Policy required in Section 1609(b)(19).

10
11 **SEC. 1605. TRANSITION PROVISION.**

12 * * * *

13 (h) **Duration.** A Temporary Cannabis Business Permit issued under this Section 1605
14 shall be valid for a period of 120 days and may be extended for additional ~~120~~90-day periods
15 at the discretion of the Director. Notwithstanding the prior sentence, the Director shall not
16 issue a new temporary permit after January 1, 2019, and shall not extend the term of a
17 Temporary Cannabis Business Permit *issued to an applicant for a Cannabis Business Permit under*
18 *this Article 16 past January 1/December 31, 2019.*

21 **SEC. 1606. APPLICATIONS FOR CANNABIS BUSINESS PERMITS.**

22 (a) Except as provided in subsection (b) of this Section 1606, the Director shall issue
23 Cannabis Business Permits only to Applicants that meet one or more of the following criteria:

24 (1) Qualify as an Equity Applicant or an Equity Incubator, ~~and have not~~
25 ~~previously received a Cannabis Business Permit for the same type of Cannabis Business (as~~

1 set forth in Section 1607) as the Cannabis Business for which a Cannabis Business Permit is
2 sought;

3 (2) Possess a valid permit to operate a Medical Cannabis Dispensary issued
4 pursuant to Article 33 of the Health Code prior to the effective date of the ordinance, in Board
5 File Number 171042, establishing this Article 16;

6 (3) Were issued a Temporary Cannabis Business Permit under Section 1605 of
7 this Article 16;

8 (4) Have demonstrated to the Director's satisfaction that the Applicant operated
9 in compliance with the Compassionate Use Act of 1996, and was forced to discontinue
10 operations as a result of federal prosecution or threat of federal prosecution;

11 (5) Applied for a Medical Cannabis Dispensary Permit that required referral to
12 and approval by the Planning Commission, and received approval from the Planning
13 Commission prior to the effective date of the ordinance, in Board File Number 171042,
14 establishing this Article 16; ~~or~~

15 (6) Registered with the Office of Cannabis as a Pre-Existing Non-Conforming
16 Operator, as set forth in subsection (k) of Section 1605 of this Article 16; or

17 (7) Possessed a valid permit to operate a Medical Cannabis Dispensary, issued under
18 Article 33 of the Health Code prior to January 6, 2018, or a valid Temporary Cannabis Business
19 Permit, issued under Section 1605(d), but were forced to discontinue operations due to the termination
20 of a lease, provided that:

21 (A) The lease terminated before December 31, 2018;

22 (B) The lease termination was not due to the lessee's breach of the lease;

23 (C) The Owner of the proposed Cannabis Business is identical to the Owner of
24 the former Medical Cannabis Dispensary; and

1 (D) The Permittee seeks an application for a Cannabis Business Permit no later
2 than July 1, 2019.

3 (b) The Director may award a Cannabis Business Permit to an Applicant that does not
4 meet the criteria set forth in subsection (a) of this Section 1606 if the total number of Cannabis
5 Business Permits awarded to Equity Applicants in the permit category sought by the Applicant
6 has reached 50% of the total number of Cannabis Business Permits awarded in that permit
7 category.

8 (c) The Office of Cannabis shall review and process applications for Cannabis
9 Business Permits in an order that reflects the Applicant's priority category:

10 (1) First priority: applications from Equity Applicants;

11 (2) Second priority: applications from Equity Incubators;

12 (3) Third priority: applications from Applicants that meet the requirements of Section
13 1606(a)(4) or 1606(a)(6).

14 (34) ThirdFourth priority: applications from Applicants, including Pre-Existing Non-
15 Conforming Operators, that were operating in compliance with the Compassionate Use Act of
16 1996 before September 1, 2016;

17 (45) Fourth Fifth priority: applications that demonstrate a commitment on the
18 part of the Applicant to provide benefits to the community in which the Cannabis Business is
19 located, including but not limited to workforce opportunities and community benefits
20 contributions; and

21 (56) FifthSixth priority: all other applications.

22 (d) Each Owner Treated as Applicant. Unless this Article 16 specifically provides
23 otherwise, each Owner of a Cannabis Business or proposed Cannabis Business shall be
24 subject to the same obligations that this Article 16 imposes on an Applicant. Such obligations
25

1 include, but are not limited to, the obligation to provide to the Director the information that this
2 Article 16, and any regulations promulgated thereunder, require from an Applicant.

4 **SEC. 1608. TRANSFER OF PERMIT; PORTABILITY OF PERMIT; SALE OF**
5 **CANNABIS BUSINESS; CHANGE IN OWNERSHIP; INTERIM CANNABIS BUSINESS**
6 **PERMITS.**

8 ~~(c) **Sale of Cannabis Business.** If a Permittee sells the Cannabis Business, the~~
9 ~~Permittee shall promptly surrender the permit to the Director. This obligation is not dependent~~
10 ~~on the Director's requesting the surrender, but arises by operation of law on the sale of the~~
11 ~~Cannabis Business. If the Permittee fails to surrender the permit to the Director, the Director~~
12 ~~may, after giving the Permittee notice by mail and electronically of the proposed action and an~~
13 ~~opportunity to respond, revoke the permit.~~

14 ~~(d) **Change in Ownership.** A Permittee may change partners, shareholders, or other~~
15 ~~Owners of a Cannabis Business provided that: the sale or other transfer of ownership~~
16 ~~regardless of the form of ownership results in a new Person owning: no more than 20% of the~~
17 ~~Cannabis Business, and the Permittee obtains an amendment to the Permit as provided in~~
18 ~~subsection (d)(2) of this Section 1608. If the sale or other transfer of ownership does not result~~
19 ~~in any Person (who did not already have such a percentage interest) having an ownership~~
20 ~~interest of 20% or more, the Permittee is not required to obtain a permit amendment.~~

21 ~~—— (1) A Permittee seeking to amend a permit as required under this subsection (d)~~
22 ~~shall pay the required filing fee for a permit amendment and that portion of the information~~
23 ~~required for Applicants under Section 1609, as determined by the Director.~~

24 ~~—— (2) The Director shall determine within 30 days of the filing of a complete~~
25 ~~application for a permit amendment under this subsection (d) whether to approve it. The~~

1 Director shall approve the application unless the Director determines that denial is warranted
2 under any of the grounds set forth in Section 1615. The Director shall notify the Permittee of
3 the Director's decision electronically and either by mail or personal delivery.

4 ~~———— (3) Notwithstanding this subsection (d), a Permittee must obtain a permit~~
5 ~~amendment if a change in ownership results in a decrease in an Equity Applicant's Ownership~~
6 ~~Interest in the Cannabis Business, a change in the Equity Applicant's role as Chief Executive~~
7 ~~Officer or member of the Board of Directors, or a material change in the degree of the Equity~~
8 ~~Applicant's participation in the direction, control, or management of the Cannabis Business.~~
9 ~~Applications for a permit amendment in accordance with this Subsection 1608(d)(3) must~~
10 ~~include the terms of the change in ownership.~~

11 **(c) Ownership; Changes in Ownership; Changes in Form or Structure.**

12 (1) Any change affecting any ownership interest of a Cannabis Business,
13 including, but not limited to, any change in ownership that affects an ownership interest of less
14 than 20% of the Cannabis Business, must be promptly disclosed, in writing, to the Director.

15 (2) Any change affecting any ownership interest of a Cannabis Business that
16 results in a Person holding an aggregate ownership interest of 20% or more of a Cannabis
17 Business, when that Person did not previously hold an aggregate ownership interest of 20%
18 or more in the Cannabis Business, shall require the Permittee to promptly obtain a permit
19 amendment. Such permit amendment shall be reviewed by the Director in a manner
20 consistent with subsection (c)(5), and shall not be granted unless the Director determines that,
21 if the relevant Person (i.e., the Person who newly holds an aggregate ownership interest of
22 20% or more in the Cannabis Business) had been an Owner at the time the Permittee applied
23 for a permit awarded under this Article 16, that permit would have been granted.

24 (3) Any change in the direction, control, or management of a Cannabis
25 Business must be promptly disclosed, in writing, to the Director, and such change shall

1 require the Permittee to promptly apply for and obtain a permit amendment. An application for
2 such a permit amendment shall be reviewed by the Director consistent with subsection (c)(4),
3 and shall not be granted unless the Director determines that, if the relevant Person (i.e., the
4 Person newly exercising direction, control, or management with respect to the Cannabis
5 Business) had been an Owner at the time the Permittee applied for a permit awarded under
6 this Article 16, that permit would have been granted.

7 (4) A Permittee seeking a permit amendment as required under this subsection
8 (c) shall pay the required filing fee for a permit amendment and provide such information, from
9 the categories of information described in Section 1609, as may be required by the Director.
10 The decision to grant or deny a permit amendment shall be entrusted to the Director's
11 discretion in the same manner, and subject to the same criteria, as the decision to grant or
12 deny a permit as set forth in Section 1615.

13 (5) Notwithstanding any other provision of this subsection (c), prior to the award
14 of a permanent Cannabis Business Permit and for a ten-year period thereafter, an aggregate
15 ownership interest of 50% or more in a Permittee may not be transferred to any Person or
16 combination of Persons who were not Owners of the Permittee at the time that a Cannabis
17 Business Permit was awarded under this Article 16. This restriction shall be cumulative, as to
18 each Permittee, across any permits (whether temporary or permanent) issued under this
19 Article 16. In the event that, prior to the award of a permanent Cannabis Business Permit or
20 within ten years thereafter, an aggregate ownership interest of 50% or more in a Permittee is
21 transferred to any Person or combination of Persons who were not Owners of the Permittee at
22 the time that a Cannabis Business Permit was awarded, the Permittee shall promptly
23 surrender the permit to the Director. This obligation is not dependent on the Director's
24 requesting the surrender, but arises by operation of law on the sale of the Cannabis Business.
25 If the Permittee fails to surrender the permit to the Director, the Director may, after giving the

1 Permittee notice by mail and electronically of the proposed action and an opportunity to
2 respond, revoke the permit.

3 (6) A change in the form or structure of a Permittee shall not be considered a
4 change affecting an ownership interest in a Cannabis Business for purposes of this
5 subsection (c). Notwithstanding any other provision of this subsection (c), a Permittee may
6 undertake any change in its form or structure, as long as the change in form or structure does
7 not cause any change affecting an ownership interest. The Permittee must promptly disclose
8 its change in form or structure, in writing, to the Director, and such change shall require the
9 Permittee to promptly apply for and obtain a permit amendment as set forth in subsection
10 (c)(4).

11 (7) Whenever, under this Article 16, an Owner is anything other than an
12 individual, every individual who exercises direction, control, or management of that Owner
13 shall also be treated as an Owner for purposes of this Article 16.

14 (8) Notwithstanding any other provision of this subsection (c), it shall not be
15 considered a change affecting an ownership interest in a Cannabis Business if an individual
16 transfers an ownership interest in a Cannabis Business to a Person that is entirely owned and
17 controlled by that same individual, but any subsequent transfer of an ownership interest in that
18 Person shall be considered a change affecting an ownership interest in the Cannabis
19 Business. All transfers described in this subsection (c)(8) must be promptly disclosed, in
20 writing, to the Director.

21 (9) Notwithstanding any other provision of this subsection (c), a Permittee
22 must obtain a permit amendment if a change in ownership results in a decrease in an Equity
23 Applicant's Ownership Interest in the Cannabis Business, a change in the Equity Applicant's
24 role as Chief Executive Officer or member of the Board of Directors, or a material change in
25 the degree of the Equity Applicant's participation in the direction, control, or management of

1 the Cannabis Business. Applications for a permit amendment in accordance with this
2 Subsection 1608(c)(9) must include the terms of the change in ownership.

3 (de) **Interim Cannabis Business Permits.** Once the Director receives a surrendered
4 Cannabis Business Permit to Operate, as set forth in subsection (b) of this Section 1608, the
5 new Owner of the business may apply to the Director for an Interim Cannabis Business
6 Permit, subject to any required Planning Department approvals, for a period not to exceed 90
7 days from the date of surrender (an “Interim Permit”). An Interim Permit may not be renewed.
8 The Director may grant an Interim Permit provided that:

11 **SEC. 1609. PERMIT APPLICATIONS.**

12 * * * *

13 (b) **Information Required of All Applicants for Cannabis Business Permits.** The
14 application form for all Cannabis Business Permit Applicants shall require the Applicant to
15 provide the following information and documentation:

16 (1) The name, street address, and parcel number of the business for which the
17 permit is sought;

18 (2) The name, contact information, and address of the Applicant as follows:

19 (A) If the Applicant is a corporation, the name of the corporation as
20 shown in its articles of incorporation; the date and place of incorporation; and the name and
21 address of each officer or director;

22 (B) If the Applicant is a Person other than a publicly traded company, the
23 name and address of every Person that directly or indirectly owns or controls 20% or more of
24 the assets, ownership interests, or voting interests in that Person;

1 (3) The name of and contact information for the manager(s) who will, directly or
2 through designees, be on the Premises during hours of operation;

3 (4) The name and address of each Person who appears on the business
4 registration certificate for the Business for which a permit is sought;

5 (5) The name and address of each Person who has or will have authority or
6 control over the Business and a brief statement of the nature and extent of such authority and
7 control, if the Applicant has not otherwise provided this information in the application;

8 (6) The name, contact information, and address of the Person authorized to
9 accept service of process;

10 (7) For all ~~Owners~~*Applicants*, a complete set of fingerprints in the manner
11 required by the Director for the purpose of conducting a criminal background check, and such
12 additional information concerning the criminal histories of Owners, as may be required by the
13 Director;

14 (8) Written verification that the owner of the real property where the Cannabis
15 Business will be located has the authority to consent, and consents, to its use as a Cannabis
16 Business. Such written verification must be signed by the property owner or the owner's
17 agent, and must include the owner and agent's contact information;

18 (9) Where the Applicant leases the Real Property, a copy of the lease;

19 (10) A determination from the Planning Department that the proposed use as a
20 Cannabis Business is in compliance with the Planning Code;

21 (11) An Operations Plan that includes such information as may be required by
22 the Director, including but not limited to:

23 (A) An odor mitigation plan;

24 (B) A Hazardous materials inventory;

25 (C) A power plan;

- (D) A Security Plan;
- (E) A track and trace compliance plan;

5 California driver's license or Identification card).

6 (4) Deliveries must be made during the Cannabis Business' hours of operation.

9 verification that the Customer, or a patient for whom he or she is a Primary Caregiver,
10 qualifies under California Health and Safety Code Section 11362.7 et seq. to use Medicinal
11 Cannabis.

12 (6) Upon Delivery, the employee performing the Delivery must:

13 (A) Personally review the Bona Fide Proof of Age and Identity of the
14 Customer to confirm that he or she is the same individual who submitted the Bona Fide Order,
15 and is not underage, as set forth in Section 1619 of this Article 16;

16 (B) Where the product being sold is Medicinal Cannabis or a Medicinal
17 Cannabis Product, personally review documentation verifying that the Customer possesses a
18 valid Physician's Recommendation;

19 (C) Require the Customer to sign a document indicating the type and
20 quantity of Cannabis and/or Cannabis Products that were Delivered; and

21 (D) Distribute to each Customer at the time of sale a fact sheet relating to
22 safe Consumption of Cannabis and Cannabis Products, the content of which shall be
23 produced by the Department of Public Health.

24 (7) A Cannabis Business may not Deliver more than the quantities of Cannabis or

7 (9) All Cannabis and Cannabis Products shall be kept in a lock-box securely

9 (10) A manifest must be created for each Delivery or series of Deliveries prior to
10 ~~departure completion of that Delivery or series of Deliveries~~departure, and the Delivery
11 employee may not make any unnecessary stops between Deliveries ~~or deviate substantially~~
12 ~~from the manifest route, unless a stop is necessary for personal safety~~ or deviate substantially
13 from the manifest route, unless a stop is necessary for personal safety.

14 (11) A Cannabis Business authorized to engage in the Delivery of Cannabis
15 and/or Cannabis Products shall comply with all track and trace requirements imposed by state
16 law, and shall document the following information regarding Deliveries pursuant to track and

6 established by the Director. Delivery of Cannabis and Cannabis Products by motorcycles,
7 scooters, drones, human powered vehicles, and unmanned vehicles is prohibited.

9 not be construed to limit the Director's authority to adopt any additional Delivery Standards

4 comply with the following additional operating standards:

5 (1) A Cannabis Microbusiness shall conduct *at no less than three of the following*
6 four categories of Commercial activity *(Cultivation, Manufacture, Distribution, and Sale)* on the

21 (5) A Delivery-Only Cannabis Retailer must provide to all Delivery personnel a
22 remote electronic age verification device to determine the age of any individual attempting to
23 purchase Cannabis or Cannabis Products, which device shall be used upon the Delivery of
24 the Cannabis or Cannabis Products to the Customer. The device shall be maintained in
25 operational condition and all employees shall be instructed in its use. Cannabis and Cannabis

1 products shall not be Delivered to a Customer if the electronic age verification device is not
2 functioning.

20 dispensary, including, but not limited to, any change in ownership that affects an ownership
21 interest of less than 20% of the medical cannabis dispensary, must be promptly disclosed, in
22 writing, to the Director.

24 dispensary that results in a person holding an aggregate ownership interest of 20% or more of
25 a medical cannabis dispensary, when that person did not previously hold an aggregate

1 ownership interest of 20% or more in the medical cannabis dispensary, shall require the
2 permittee to promptly obtain a permit amendment. For purposes of this Section 3311, a
3 “person” shall be defined to include any individual, firm, partnership, joint venture, association,
4 corporation, limited liability company, estate, trust, business trust, receiver, syndicate, or any
5 other entity, or other group or combination acting as a unit. The decision to grant or deny a
6 permit amendment shall be entrusted to the Director’s discretion in the same manner, and
7 subject to the same criteria, as the decision to grant or deny a provisional permit as set forth
8 in Section 3307, provided however that the permit amendment shall not be granted unless the
9 permittee has provided, and the Director has approved, an actionable Cannabis Equity
10 Incubator Agreement, as set forth in subsection (b)(3)(B), where such an agreement is
11 required because the permittee seeks to implement a change affecting an ownership interest
12 in a medical cannabis dispensary.

13 (3) A permittee seeking a permit amendment as required under this
14 subsection (b) shall provide to the Director and the Director of the Office of Cannabis for
15 review and approval the following information:

16 (A) Such information, from the categories of information described in
17 Section 3304, as may be required by the Director; and

18 (B) Where a permittee seeks a permit amendment to implement a
19 change affecting an ownership interest in a medical cannabis dispensary, a Cannabis Equity
20 Incubator Agreement in which it identifies no less than one Equity Applicant, as that term is
21 defined in subsection (b) of Section 1604 of the Police Code, and commits to comply with one
22 of the following operating requirements for 18 months from the date that the permit
23 amendment is approved:

24 (i) Submit to the Director and the Director of the Office of
25 Cannabis for review and approval a written, an actionable “Equity Incubator Plan” describing

1 how the permittee will encourage and support the establishment and growth of at least one of
2 the identified Equity Applicants by, among other things, providing business plan guidance,
3 operations consulting, personnel, or technical assistance. The services listed in the Equity
4 Incubator Plan must be enumerated, and include an estimated dollar value of those services.
5 The aggregate dollar value of the services must equal or exceed the sum of 10% of the rent
6 for, or, if the permittee owns the permittee's premises, 10% of the rental market value of, the
7 permittee's premises, and the annual total costs of security services at the permittee's
8 premises; or

9 (ii) Provide at least one of the identified Equity Applicants with
10 rent-free commercial space owned or leased by the permittee, either adjacent to the
11 permittee's premises or off-site, in which the Equity Applicant may prepare to conduct, and
12 upon award of a Cannabis Business permit under Article 16 of the Police Code may in fact
13 conduct, its Cannabis Business. If such rent-free commercial space is provided off-site, the
14 permittee must provide the greater of 800 square feet or the equivalent of at least 10% of the
15 square footage of the permittee's premises. If such rent-free commercial space is provided
16 adjacent to the permittee's premises, the permittee must provide either 800 square feet or the
17 equivalent of at least 10% of the square footage of the permittee's premises.

18 (4) Notwithstanding any other provision of this subsection (b), an aggregate
19 ownership interest of 50% or more in a medical cannabis dispensary may not be transferred
20 to any person or combination of persons who were not owners of the medical cannabis
21 dispensary at the time that a medical cannabis dispensary permit was awarded under this
22 Article 33. In the event that an aggregate ownership interest of 50% or more in a medical
23 cannabis dispensary is transferred to any person or combination of persons who were not
24 owners of the medical cannabis dispensary at the time that a medical cannabis dispensary
25 permit was awarded, the permittee shall promptly surrender the permit to the Director. This

1 obligation is not dependent on the Director's requesting the surrender, but arises by operation
2 of law upon the transfer of an ownership interest of 50% or more in the medical cannabis
3 dispensary. If the permittee fails to surrender the permit to the Director, the Director may, after
4 giving the permittee notice by mail and electronically of the proposed action and an
5 opportunity to respond, revoke the permit.

6 (5) A change in the form or structure of a medical cannabis dispensary shall
7 not be considered a change affecting an ownership interest in a medical cannabis dispensary
8 for purposes of this subsection (b). Notwithstanding any other provision of this subsection (b),
9 a permittee may undertake a change in its form or structure, as long as the change in form or
10 structure does not cause any change affecting an ownership interest, and so long as the
11 change in form is otherwise authorized under this Article 33. The Permittee must promptly
12 disclose its change in form or structure, in writing, to the Director, and such change shall
13 require the permittee to promptly apply for and obtain a permit amendment as set forth in
14 subsection (b)(3).

15 (6) Notwithstanding any other provision of this subsection (b), it shall not be
16 considered a change affecting an ownership interest in a medical cannabis dispensary if an
17 individual transfers an ownership interest in a medical cannabis dispensary to a person that is
18 entirely owned and controlled by that same individual, but any subsequent transfer of an
19 ownership interest in that person shall be considered a change affecting an ownership interest
20 in the medical cannabis dispensary. All transfers described in this subsection (b)(6) must be
21 promptly disclosed, in writing, to the Director.

2 (7) Submits to the Director of the Office of Cannabis a written, actionable and
3 measurable "Equity Plan" describing the concrete steps the medical cannabis dispensary will

6 been disproportionately impacted by the criminalization of cannabis; and otherwise further the

10 _____ shall affect the status of Equity Applicants or Equity Incubators whom the Office of
11 Cannabis has previously verified to be Equity Applicants or Equity Incubators, as reflected in
12 written notification sent to those Equity Applicants or Equity Incubators by the Office of
13 Cannabis. Therefore, the changes, set forth in the ordinance in Board File No. _____, to
14 the Equity Criteria set forth in Section 1604 of the Police Code shall apply only to applicants
15 for Cannabis Business Permits who seek to be verified as Equity Applicants or Equity
16 Incubators after the effective date of the ordinance in Board File No. _____.

18 Section 454. Scope of Ordinance. In enacting this ordinance, the Board of
19 Supervisors intends to amend only those words, phrases, paragraphs, subsections, sections,
20 articles, numbers, punctuation marks, charts, diagrams, or any other constituent parts of the
21 Municipal Code that are explicitly shown in this ordinance as additions, deletions, Board
22 amendment additions, and Board amendment deletions in accordance with the "Note" that
23 appears under the official title of the ordinance.

Ordinance amending the Police Code by making a number of changes in the regulation of commercial cannabis activity, including, among other things: 1) defining ownership interest and revising Equity Criteria, for purposes of the Equity Program; 2) modifying the Cannabis Equity Incubator Program requirements; 3) extending by one year the possible duration of a Temporary Cannabis Business Permit; 4) authorizing the Director of the Office of Cannabis to issue Cannabis Business Permits to Medical Cannabis Dispensaries forced to discontinue operations due to a no-fault lease termination before December 31, 2018; 5) modifying the order in which the Director may review and process Cannabis Business Permit applications; 6) revising requirements associated with a Cannabis Business' change in ownership and structure; 7) revising Cannabis Business Permit application requirements; 8) requiring Cannabis Businesses to comply with all permit conditions whether or not they are currently engaging in the permitted activity; 9) modifying the amount of Cannabis that may be delivered or sold to a customer; and 10) authorizing Cannabis Microbusinesses to conduct either storefront or delivery sales, but not both, and reducing from four to three the categories of Commercial activity required to operate as a Cannabis Microbusiness; and amending the Health Code by revising eligibility requirements for medical cannabis dispensaries seeking authorization to Sell Adult Use Cannabis, and extending by one year to December 31, 2019, the date on which Article 33 (Medical Cannabis Act) expires.


