

1 [Muni Service to the Forgotten Holocaust Exhibit at Treasure Island]  
2 URGING MUNI TO EXTEND ITS REGULAR TRANSIT SERVICE TO TREASURE ISLAND  
3 TO INCLUDE SUNDAYS IN ORDER TO PROVIDE THE PUBLIC WITH TRANSPORTATION  
4 TO "THE FORGOTTEN HOLOCAUST OF WORLD WAR II" EXHIBIT ON TREASURE  
5 ISLAND.

6 WHEREAS, On August 3, 1998, a Board of Supervisors Resolution  
7 was introduced urging the Mayor's Office and the Treasure Island  
8 Authority to authorize a request by The Alliance for Preserving the  
9 Truth of Sino-Japanese War to extend "The Forgotten Holocaust of  
10 World War II" photographic and video exhibit, on display at Treasure  
11 Island since July 5, 1998, through 1999; and

12 WHEREAS, There is currently no public transportation service  
13 from San Francisco to Treasure Island on Sundays; and

14 WHEREAS, Many San Franciscans who wish to see "The Forgotten  
15 Holocaust of World War II" exhibit rely on Muni as their sole means  
16 of transportation; and

17 WHEREAS, The opportunity to view this historically important  
18 exhibit should be made available to everyone, including those who  
19 lack transportation options; and

20 WHEREAS, The exhibit is a valuable educational resource  
21 containing the most comprehensive collection of visual historic  
22 documents of World War II in Asia and should be made available to  
23 anyone who wishes to learn more about "The Forgotten Holocaust"; now,

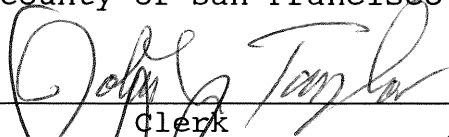
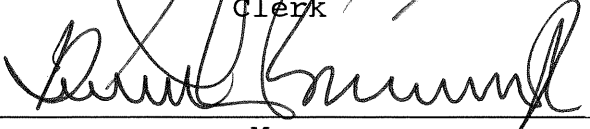
